1 (a) Any fees collected by the Director of the Department of Finance 2 and Administration under this section shall be classified as special revenues 3 and shall be deposited into the State Treasury. 4 (b) Upon receipt of the funds, and if not prohibited by the Unified Carrier Registration Act of 2005, Pub. L. No. 109-59, §§ 4301 et seq., as in 5 6 effect on January 1, 2007, the Treasurer of State shall deduct three percent 7 (3%) of the funds as a charge by the state for its services as specified in 8 this section and shall credit the three percent (3%) to the Constitutional 9 Officers Fund and the State Central Services Fund, as defined in the Revenue Classification Law of Arkansas, § 19-6-101 et seq., or to any successor State 10 11 Treasury fund or funds established by law to replace the Constitutional 12 Officers Fund and the State Central Services Fund. Failure to carry the receipt authorizing travel in the State of Arkansas shall subject the motor carrier to such civil and criminal penalties and fines as are authorized by this subchapter.
- (e) In addition to the terms and provisions of this section, all other terms and provisions of this subchapter shall be applicable to interstate motor carriers insofar as the terms and provisions of this subchapter are not prohibited under the provisions of the Constitution of the United States and acts of Congress.

SECTION 4. EMERGENCY CLAUSE. It is found and determined by the

General Assembly of the State of Arkansas that in August 2005 the United

States Congress enacted the Uniform Carrier Registration Act of 2005; that

the Uniform Carrier Registration Act of 2005 is to replace the single state

registration program on or before January 1, 2007; that the deadline has

passed and Arkansas has not yet had an opportunity to respond to this law due

1	to its biennial legislative sessions; and that there is an immediate need for
2	implementation of the provisions of this act to ensure that Arkansas is in
3	compliance with the Uniform Carrier Registration Act of 2005 to prevent the
4	loss of funding. Therefore, an emergency is declared to exist and this act
5	being immediately necessary for the preservation of the public peace, health,
6	and safety shall become effective on:
7	(1) The date of its approval by the Governor;
8	(2) If the bill is neither approved nor vetoed by the Governor,
9	the expiration of the period of time during which the Governor may veto the
10	<pre>bill; or</pre>
11	(3) If the bill is vetoed by the Governor and the veto is
