20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
21

22 SECTION 1. Arkansas Code § 23-2-101(d), concerning the maximum salary
23 for commissioners which has been superseded by subsequent appropriations acts
24 for the Arkansas Public Service Commission, is repealed.

25 ~~(d) Each commissioner shall receive an annual salary of five thousand~~
26 ~~dollars (\$5,000), payable semimonthly or monthly in conformity with~~
27 ~~prevailing practices of other officers of the state.~~
28

29 SECTION 2. Arkansas Code § 23-3-512(b), concerning appeals to the
30 Supreme Court which has been superseded by the Arkansas Rules of Appellate
31 Procedure and the Arkansas Rules for Inferior Courts, is repealed.

32 ~~(b) The appeal may be taken through the filing of notice of appeal as~~
33 ~~prescribed in §§ 16-67-310 [superseded] and 16-67-312 [superseded], and in~~
34 ~~all respects the procedure in taking, perfecting, and prosecution of the~~
35 ~~appeal, including the preparation and filing with the Arkansas Supreme Court~~
36 ~~of the record, shall be controlled by the then applicable statutes regulating~~



1 ~~appeals to the Arkansas Supreme Court from the circuit court.~~

3 SECTION 3. Arkansas Code § 23-37-208(a), concerning the investigatory
4 powers of the Securities Commissioner as Supervisor of Savings and Loan
5 Associations, is amended to read as follows:

6 (a) For the purpose of any investigation, examination, inquiry, or
7 proceeding under this chapter ~~or the Building and Loan Association Act, § 23-~~
8 ~~38-101 et seq.~~, the Supervisor of Savings and Loan Associations or any
9 officer designated by the supervisor may administer oaths and affirmations,
10 subpoena witnesses or documents, compel their attendance, take evidence, and
11 require the production of any books, papers or correspondence, memoranda,
12 agreements, or other documents which the supervisor deems relevant or
13 material to the inquiry or examination.

14
15 SECTION 4. Arkansas Code Title 23, Chapter 38, which is regulated
16 under Arkansas Code Title 23, Chapter 37, is repealed.

17 ~~23-38-101. Definitions.~~

18 ~~As used in this act, unless the context otherwise requires:~~

19 (1) ~~“Building and loan association” means any association or~~
20 ~~corporation which is chartered under any building and loan law, which is~~
21 ~~principally in the business of assisting its members to buy, improve, or~~
22 ~~build homes or to remove encumbrances therefrom, and which accumulates the~~
23 ~~funds loaned through the issuance or sale of its own shares or certificates;~~

24 (2) ~~“Domestic association” means any association chartered under~~
25 ~~the laws of this state;~~

26 (3) ~~“Foreign association” means any association chartered under~~
27 ~~the laws of any other state or territory of the United States;~~

28 (4)(A) ~~“Guaranty, or permanent stock building and loan~~
29 ~~association” means a financial institution incorporated by the state which~~
30 ~~has for its purposes those outlined in subdivision (1) of this section and~~
31 ~~which issues a class of stock known as “guaranty capital stock”, “permanent~~
32 ~~capital stock”, or “reserve capital stock”, as provided in Acts 1929, No.~~
33 ~~128, § 18 [repealed].~~

34 (B) ~~Par funds derived from the sale of the shares shall be~~
35 ~~set apart and be a fixed and permanent guaranty or reserve to holders of all~~
36 ~~other shares or certificates and to all other customers of the association~~

1 that the association will fulfill its agreement as per terms of contract with
2 them.

3 (C) ~~“Guaranty”, “permanent”, or “reserve capital stock”~~
4 ~~cannot be withdrawn until final liquidation of the association, and no loans~~
5 ~~shall ever be made by the association upon the pledge of the stock as~~
6 ~~security; and~~

7 (5) ~~“Mutual building and loan association” means a mutual,~~
8 ~~cooperative financial institution, incorporated by the state and composed of~~
9 ~~members who associate themselves together for mutual benefit and the purposes~~
10 ~~outlined in subdivision (1) of this section.~~

11
12 ~~23-38-102. Annual reports.~~

13 (a)(1) ~~Within sixty (60) days after December 31 each year, every~~
14 ~~building and loan association operating under the provisions of this act~~
15 ~~shall file with the Securities Commissioner a statement of its financial~~
16 ~~condition at the close of its business on December 31 setting forth such~~
17 ~~details of its financial condition upon such blanks as may be prescribed by~~
18 ~~the commissioner.~~

19 (2)(A) ~~Unless an extension of time is granted in writing by the~~
20 ~~commissioner, failure to file the statement within the time mentioned shall~~
21 ~~be a violation punishable by a fine of one hundred dollars (\$100) for each~~
22 ~~day the statement is delinquent.~~

23 (B) ~~The fine shall be assessed against the secretary of~~
24 ~~the association by any court of competent jurisdiction upon complaint of the~~
25 ~~commissioner.~~

26 (b)(1) ~~The commissioner shall annually file with the Governor a report~~
27 ~~of the name, officers, directors, domicile, and financial statement of each~~
28 ~~building and loan association.~~

29 (2) ~~This report shall be published in book form.~~

31 ~~23-38-201. Shares, stock, or certificates generally.~~

32 (a) ~~The bylaws of each association shall describe the several kinds or~~
33 ~~classes of shares, stock, or certificates which it may issue.~~

34 (b) ~~The board of directors of the associations shall have power and~~
35 ~~authority to limit or suspend the issuing of any or all classes of shares,~~
36 ~~stock, or certificates, to fix a maximum limit for the excess payments, above~~

1 the regular dues, which may be paid in any one (1) month on installment
2 shares. The board may also remove the limit or suspension at any time in its
3 discretion.

4
5 ~~23-38-202. Calling in shares.~~

6 ~~(a) Any building and loan association, in its bylaws, may reserve the~~
7 ~~right and power to require, at any time, any holders of any or all classes of~~
8 ~~shares, stock, or certificates issued by it, except guaranty permanent~~
9 ~~shares, to surrender for cancellation and payment any or all of the shares,~~
10 ~~stock, or certificates held by them, upon notice to do so within a reasonable~~
11 ~~time stated in the notice.~~

12 ~~(b) Upon surrender, the association shall pay to the owner of the~~
13 ~~shares, stock, or certificates the full book value thereof, together with the~~
14 ~~contract or earned interest or dividend thereon, up to the date specified in~~
15 ~~the notice to surrender.~~

16 ~~(c) The shares, stock, or certificates called for surrender,~~
17 ~~cancellation, and payment, and not brought in for that purpose, shall cease~~
18 ~~to draw interest or dividend at the date named for the surrender.~~

19 ~~(d) All shares withdrawn, paid off, or called in and cancelled shall~~
20 ~~revert to the association and may be reissued as new shares.~~

22 ~~23-38-203. Guaranty associations—Stock, dividends, etc.~~

23 ~~(a) Any association with guaranty permanent capital may issue to its~~
24 ~~members, or to nonmembers, other classes of investment certificates, or~~
25 ~~savings certificates or pass books, and shall specify on all of the other~~
26 ~~classes of certificates or pass books the fixed, definite rate of interest~~
27 ~~thereon.~~

28 ~~(b) The associations may contract to mature their loans on a definite~~
29 ~~contract basis without reference to the maturity of shares.~~

30 ~~(c) Associations having guaranty permanent capital, after setting~~
31 ~~aside from the earnings a sum sufficient to pay, credit, or reserve to all~~
32 ~~other classes of investment certificates, savings certificates, and pass-~~
33 ~~books the accrued interest or dividend thereon, and those further sums which~~
34 ~~this act may provide for the contingent reserve fund, and to pay all other~~
35 ~~past due liabilities, may then distribute the balance of any distributable~~
36 ~~surplus profits as a dividend to the guaranty permanent shares.~~

1 ~~(d)(1) The amount of guaranty permanent stock authorized to be issued~~
2 ~~by every guaranty plan association shall be not less than one hundred fifty~~
3 ~~thousand dollars (\$150,000), of which not less than twenty-five thousand~~
4 ~~dollars (\$25,000) shall be paid in cash before the association begins~~
5 ~~operation. The amount of the paid-in guaranty permanent shares shall at all~~
6 ~~times be not less than five percent (5%) of the total liabilities of the~~
7 ~~association until the entire authorized guaranty permanent capital has been~~
8 ~~paid in, and the full amount of one hundred fifty thousand dollars (\$150,000)~~
9 ~~permanent or guaranty capital shall thereafter be maintained.~~

10 ~~(2) However, associations domiciled in towns of not more than~~
11 ~~one thousand five hundred (1,500) population and confining their operations~~
12 ~~to the town and the vicinity within five (5) miles thereof may begin~~

14 ~~than ten thousand dollars (\$10,000).~~

16 ~~23-38-204. Mutual or guaranty permanent stock associations — Dayton or~~
17 ~~optional payment plan.~~

18 ~~(a) The Dayton or optional payment plan of maturing shares or~~
19 ~~certificates may be employed by either mutual or guaranty permanent stock~~
20 ~~associations.~~

21 ~~(b) Members or certificate holders whose shares are on the optional~~
22 ~~payment plan may make payments thereon in any amount at any time, subject to~~
23 ~~those limitations which the board of directors may impose under the bylaws of~~
24 ~~the association.~~

25 ~~(c) The stock may be subject to withdrawal under the bylaws of the~~
26 ~~association, but the entire number of shares represented by the certificate~~
27 ~~must be withdrawn at one (1) time. It shall not be permissible to make~~
28 ~~partial withdrawals under any of the certificates.~~

29
30 ~~23-38-205. Directors — Stock ownership.~~

31 ~~(a) The bylaws of each building and loan association may prescribe~~
32 ~~other qualifications for directors, but no person shall be eligible to~~
33 ~~election as director unless he is a bona fide owner of stock or shares in the~~
34 ~~association to the amount of:~~

35 ~~(1) Two hundred fifty dollars (\$250) fully paid and free from~~
36 ~~all liens if the assets of such association do not exceed one hundred~~

1 thousand dollars (\$100,000); and

2 (2) ~~Five hundred dollars (\$500) if the assets of the association~~
3 ~~do exceed one hundred thousand dollars (\$100,000).~~

4 (b) ~~A director shall not have the right to sell or dispose of his~~
5 ~~stock or to resign or vacate his office as director during the term for which~~
6 ~~he is elected without the consent and approval of the Securities~~
7 ~~Commissioner.~~

8
9 ~~23-38-206. Voting rights, etc., of shareholders and directors.~~

10 ~~The bylaws of each association shall prescribe the voting rights and~~
11 ~~powers of the owners of the several classes of shares of stock and~~
12 ~~certificates and the qualifications of the voting shareholders and of the~~
13 ~~members of the board of directors.~~

14
15 ~~23-38-207. Members or employees may take acknowledgments.~~

16 ~~No notary public or other public officer qualified to take~~
17 ~~acknowledgments or proofs of written instruments shall be disqualified from~~
18 ~~taking the acknowledgment or proof of an instrument in writing in which a~~
19 ~~building and loan association is interested by reason of his membership or~~
20 ~~stockholding in, or employment by, the building and loan association~~
21 ~~interested in the instrument. Any such acknowledgments taken prior to June~~
22 ~~11, 1931, are validated.~~

23
24 ~~23-38-208. Excessive dividends—Suspension of payment.~~

25 ~~(a) If, after examination, the Securities Commissioner shall find that~~
26 ~~any building and loan association of this state is paying, crediting, or~~
27 ~~reserving dividends, or is about to pay, credit, or reserve dividends, or is~~
28 ~~distributing or about to distribute profits, on its stock or certificates in~~
29 ~~excess of the dividends or profits earned; or that the condition of the~~
30 ~~assets of the association does not justify the payment, credit, or~~
31 ~~reservation of dividends or the distribution of profits upon its stock or~~
32 ~~certificates; or that dividends or profits are being or are about to be paid,~~
33 ~~credited, reserved, or distributed so as to result in inequities to the~~
34 ~~stockholders or certificate holder, or any class or portion thereof; or that~~
35 ~~the safety of the investments in the association are, or are about to be,~~
36 ~~jeopardized by the payment, credit, reservation, or distribution of dividends~~

1 or profits, then the commissioner shall order the association, in writing, to
2 cease to pay, credit, or reserve dividends, or distribute profits, on any
3 class of its shares or certificates except as and to the extent as may be
4 specified in the order, notice of which order shall be given to the officers
5 of the association.

6 (b) From and after the issuance of the order, it shall be unlawful for
7 the association to pay, credit, or reserve any dividends, or distribute any
8 profits, on any of its shares or certificates contrary to the order. Willful
9 violation of the terms of the order shall have the effect of rendering the
10 officers and directors of the association participating in the violation
11 jointly and severally liable for the amount of the dividends or distributions
12 unlawfully paid, credited, reserved, or distributed.

13 (c) The order shall remain in full force and effect until the
14 commissioner shall have determined either:

15 (1) That the assets and earnings of the association are in a
16 condition and of a value and amount which permits the association to resume
17 dividends or distributions to such extent as the commissioner may authorize;
18 or

19 (2) That the association should go into voluntary liquidation or
20 receivership.

21
22 ~~23-38-209. Excessive dividends—Liability of directors.~~

23 Any members of the board of directors of a building and loan
24 association who knowingly vote to declare or who, being secretary or manager
25 or auditor or examiner thereof, willfully declare, or advise the board of
26 directors of the association to declare, a greater dividend than has actually
27 been earned or has been previously accumulated as surplus by the association
28 shall personally refund the dividend and be liable to the corporation for the
29 amount in excess of earned dividends or accumulated surplus jointly and
30 severally.

31
32 ~~23-38-210. Loans and investments generally.~~

33 (a)(1) Loans made by a building and loan association operating under
34 this act shall be made to its members or certificate holders, accompanied by
35 a transfer and pledge of shares or units issued by the association or secured
36 by a mortgage or deed of trust on improved real estate which is unencumbered,

1 ~~except for prior liens owned by the association and taxes and assessment~~
 2 ~~liens for improvements not yet due.~~

3 ~~(2) The association shall be empowered to make such other loans~~
 4 ~~as are authorized by the Federal Home Loan Bank or by the Federal Savings and~~
 5 ~~Loan Insurance Corporation [abolished].~~

6 ~~(3) Loans may also be made to members or certificate holders~~
 7 ~~upon pledge, assignment, and delivery to the association, but the loan shall~~
 8 ~~not exceed the withdrawal value of the shares, stock, or certificate so~~
 9 ~~pledged.~~

10 ~~(b)(1) The board of directors of any association may invest funds in~~
 11 ~~the treasury, in excess of the demands of members or certificate holders, in~~

22 ~~(a) No building and loan association shall make a mortgage loan to an~~
 23 ~~officer, director, or employee of the association, either directly or~~
 24 ~~indirectly, unless the loan is first approved unanimously by the members of~~
 25 ~~the board of directors present at the next regular board meeting, the~~
 26 ~~approval to be recorded by aye and nay vote in the minutes of the meeting of~~
 27 ~~the board.~~

28 ~~(b) No building and loan association shall make loans exceeding, in~~
 29 ~~the aggregate:~~

30 ~~(1) Five thousand dollars (\$5,000) to one (1) borrower upon real~~
 31 ~~estate security if the assets of the association do not exceed fifty thousand~~
 32 ~~dollars (\$50,000);~~

33 ~~(2) Ten thousand dollars (\$10,000) to one (1) borrower upon real~~
 34 ~~estate security if the assets of the association do not exceed two hundred~~
 35 ~~thousand dollars (\$200,000);~~

36 ~~(3) Fifteen thousand dollars (\$15,000) to one (1) borrower upon~~

1 ~~real estate security if the assets of the association do not exceed five~~
 2 ~~hundred thousand dollars (\$500,000);~~

 10 ~~23-38-212. Conveyance of mortgaged property as transfer of shares~~
 11 ~~securing loan.~~

12 ~~The conveyance or transfer of property mortgaged to a building and loan~~
 13 ~~association shall, unless otherwise stated in the instrument of conveyance,~~
 14 ~~act as a transfer also of the shares or certificate of the association~~
 15 ~~securing the loan.~~

16
 17 ~~23-38-213. Investment in real estate.~~

18 ~~(a) Any building and loan association operating under the provisions~~
 19 ~~of this act and having assets in excess of five hundred thousand dollars~~
 20 ~~(\$500,000) may permanently invest a portion of its funds in real estate on~~
 21 ~~which there is, or may be, erected a building suitable to be occupied as~~
 22 ~~offices of the association and for revenue to be derived from rentals of that~~
 23 ~~portion of the building which is not required by the association for its own~~
 24 ~~use. The amount so invested shall not exceed the surplus and reserve of the~~
 25 ~~association.~~

26 ~~(b) The association may also acquire real estate in satisfaction of~~
 27 ~~debts owing to it, previously contracted in the course of its business, or~~
 28 ~~purchased under the foreclosure at sheriff's, judicial, or any other sale,~~
 29 ~~public or private, upon which real estate the association may have or hold a~~
 30 ~~mortgage lien or other interest or encumbrance for the purpose of securing~~
 31 ~~any debts due it or for the protection of its interest in the real estate.~~

32
 33 ~~23-38-214. Valuation of real estate owned as an asset.~~

34 ~~(a) In the event any real estate is acquired by any association~~
 35 ~~through foreclosure, by purchase, or otherwise, the value of the real estate~~
 36 ~~shall immediately be determined by the board of directors, which valuation~~

1 shall in no case exceed the actual cost of the real estate to the
2 association, unless the cost is in excess of the amount of the original
3 mortgage, in which case the value shall be limited to that amount. The
4 valuation, in either case, shall not be increased at any time by the addition
5 of carrying charges.

6 (b) If real estate is owned by the association and not occupied in
7 whole or in part by the association as its office within two (2) years after
8 acquisition, there shall be annually charged off, as depreciation, a sum
9 equal to not less than ten percent (10%) of the valuation as prescribed in
10 this section.

11 (c)(1) If, at any time, the Securities Commissioner should have reason
12 to believe that real estate carried on the books of any association is in
13 excess of its reasonable market value, then he [or she] is authorized to have
14 an appraisal made of the real estate, at an expense not to exceed five
15 dollars (\$5.00) for each appraisal, to be paid by the association, and to fix
16 the amount at which the real estate is being carried on the books of the
17 association to conform to the appraised value.

18 (2) If the board of directors of the association considers that
19 the appraised value does not reflect the fair market value of the property,
20 it has the right to submit additional information as to the value of each and
21 every piece of property which, in its opinion, has been undervalued, with
22 request for reconsideration and review. Upon reconsideration and review of
23 all the information at hand, the value as fixed by the commissioner shall
24 become final.

25
26 ~~23-38-215. Authority to borrow money.~~

27 (a) Building and loan associations of this state shall, subject to the
28 prior approval of the Securities Commissioner in each instance as to the
29 amount of the loan, have the power and authority to borrow money for
30 corporate purposes, to issue negotiable notes therefor, to pledge and endorse
31 and, from time to time, substitute their assets as may be required for the
32 security of the repayment of the borrowed money.

33 (b) However, any loan made by any association from the Federal Home
34 Loan Bank, or any successor thereof established under the authority of the
35 United States, may be consummated in full legal effect by the association
36 without obtaining either the prior or subsequent approval of the

1 commissioner.

2
3 ~~23-38-216. Expenses restricted.~~

4 ~~(a) The expenses of any building and loan association operating in~~
5 ~~Arkansas shall not, in any fiscal year, exceed the total receipts from~~
6 ~~membership, withdrawal or cancellation fees, fines, plus two percent (2%) of~~
7 ~~the average amount of loans outstanding during the year on mortgages, shares,~~
8 ~~and other securities and investments in securities authorized by this act.~~

9 ~~(b) However, if any building and loan association operating in the~~
10 ~~State of Arkansas during any fiscal year has reserve funds on hand of more~~
11 ~~than ten percent (10%) of the association's assets, it may take three percent~~
12 ~~(3%) of the average amount of loans outstanding during that fiscal year on~~
13 ~~mortgages, shares, and other securities and investments in securities~~
14 ~~authorized by this act, in addition to the total receipts from membership,~~
15 ~~withdrawal, or cancellation fees, or fines, for expenses of operating.~~

16 ~~(c) The term "expenses", as used in this section, shall not be~~
17 ~~construed to include:~~

18 ~~(1) Taxes, assessments, repairs, or insurance on real estate~~
19 ~~owned by the association, dividends or interest, or the expenses of~~
20 ~~foreclosure or other litigation;~~

21 ~~(2) Expenses of appraisals, attorney's fees for examination of~~
22 ~~title, premiums for title insurance, recording fees, or other expenses which~~
23 ~~are usually incurred in connection with loaning funds of the association; and~~

24 ~~(3) Premiums paid for the insurance of its shares, cost of~~
25 ~~examination and audit, or any other expense required by the Securities~~
26 ~~Commissioner or the Federal Home Loan Bank.~~

27
28 ~~23-38-217. Losses — Reduction of liability to members.~~

29 ~~(a) Whenever the losses of any building and loan association,~~
30 ~~resulting from depreciation in value of its securities or otherwise, exceed~~
31 ~~its contingent reserve fund, undivided profits, and current earnings so that~~
32 ~~the estimated value of its assets is less than the total amount due its~~
33 ~~members, the Securities Commissioner shall order a reduction of its liability~~
34 ~~to its members in a manner which distributes the loss equitably among the~~
35 ~~members.~~

36 ~~(b) If, thereafter, the association shall realize from the assets a~~

1 ~~greater amount than was fixed in the order of reduction, the excess shall be~~
2 ~~divided among members whose credits were so reduced, but to the extent of the~~
3 ~~reduction only.~~

5 ~~23-38-218.—Sale of assets.~~

6 ~~(a) At any regular meeting of the shareholders of any building and~~
7 ~~loan association, or at any special meeting of the shareholders of the~~
8 ~~association, in either case called to consider the action and held in~~
9 ~~accordance with the laws governing the association, the shareholders, by~~
10 ~~affirmative vote of two-thirds (2/3) of the outstanding shares, may authorize~~
11 ~~the sale of all or a portion of the assets of the association to another~~
12 ~~building and loan association or to a federal savings and loan association.~~

13 ~~(b) The sale shall be on terms and under conditions which may be~~
14 ~~adopted in the shareholders' meeting. Upon authority given the directors of~~
15 ~~the association in the meeting, they are authorized to proceed to consummate~~
16 ~~the sale.~~

18 ~~23-38-219.—Subscription for stock in corporation created by an act of~~
19 ~~Congress.~~

20 ~~Any building and loan association organized under the laws of the State~~
21 ~~of Arkansas shall have authority to subscribe for stock in any corporation~~
22 ~~created by an act of Congress when subscription is required by the act of~~
23 ~~Congress as a condition precedent to the securing of a loan to the building~~
24 ~~and loan association from any corporation created by the act of Congress.~~

25
26 ~~23-38-220.—Foreign associations.~~
