<u>SB11</u>	G. Stubblefield	TO CREATE AN EXEMPTION FROM THE SALES AND USE TAX FOR EXPENDABLE SUPPLIES FOR FARM MACHINERY.
<u>SB108</u>	K. Ingram	TO EXTEND THE NET OPERATING LOSS CARRY-FORWARD PERIOD FOR CALCULATING ARKANSAS INCOME TAX; AND TO MAKE TECHNICAL CHANGES.
<u>SB135</u>	Rapert	TO REDUCE THE STATE SALES AND USE TAX ON FOOD AND FOOD INGREDIENTS IF CERTAIN FUND BALANCES EXIST; AND TO DECLARE AN EMERGENCY.
<u>SB212</u>	Files	TO INCLUDE THE ARKANSAS REAL ESTATE COMMISSION WITHIN THE DEFINITION OF "CLAIMANT AGENCY" FOR THE PURPOSE OF OBTAINING A SETOFF AGAINST STATE TAX REFUNDS FOR DEBTS OWED TO THE STATE.
<u>SB245</u>	J. Dismang	TO REQUIRE THAT CERTAIN INFORMATION BE INCLUDED ON INDIVIDUAL INCOME TAX FORMS; AND TO ENABLE THE STATE TO TRACK CERTAIN INFORMATION RELEVANT TO INDIVIDUAL INCOME TAXES.
<u>SB253</u>	Hester	TO REQUIRE THE USE OF APPORTIONMENT FACTORS TO DETERMINE THE AMOUNT OF PARTNERSHIP INCOME TO BE ALLOCATED TO ARKANSAS.
<u>SB254</u>	Hester	TO ALLOW THE DEPARTMENT OF FINANCE AND ADMINISTRATION TO ENTER INTO AN INSTALLMENT AGREEMENT WITH A TAXPAYER WHO HAS INDIVIDUAL INCOME TAX DEBT IF CERTAIN CONDITIONS ARE MET.
<u>SB262</u>	A. Clark	TO FACILITATE AND ENCOURAGE CHARITABLE DONATIONS; AND TO EXEMPT FROM THE SALES AND USE TAX SELLERS' DONATIONS OF TANGIBLE PERSONAL PROPERTY TO CHARITABLE ORGANIZATIONS OR FOR CHARITABLE CAUSES.
