HB1409	Neal	CONCERNING THE EVALUATION PROTOCOL FOR ASSESSING PERSONS WHO POTENTIALLY WILL BE CLASSIFIED AS A SEXUALLY DANGEROUS PERSON; TO MAKE TECHNICAL CHANGES IN THE CHANGE IN TERMINOLOGY THROUGHOUT THE CODE.

SB718	Files	TO CREATE CRIMINAL AND CIVIL PENALTIES FOR CERTAIN ACTIVITIES RELATING TO SOFTWARE AND OTHER DEVICES AND MECHANISMS THAT MODIFY OR FALSIFY ELECTRONIC RECORDS FOR THE PURPOSE OF EVADING TAXES.
HB1417	Harris	TO EXTEND THE CONCEALED HANDGUN LICENSE EXEMPTION TO CURRENT AND FORMER CERTIFIED LAW ENFORCEMENT OFFICERS, AUXILIARY LAW ENFORCEMENT OFFICERS, BAILIFFS, AND RETIRED LAW ENFORCEMENT OFFICERS.
