H. Consideration for Adoption of Interim Study Proposals (ISPs) [**Exhibits H1-H4**]

1. **ISP 2021-024** by Representative Howard Beaty - “An Act to amend the law concerning the confidentiality of tax records under the Arkansas tax procedure act; to amend the requirements concerning the tax information that shall be provided to a city or county by the Department of Finance and Administration; and for other purposes”
2. **ISP 2021-049** by Representative Jack Ladyman - “To require certain individuals and organizations that engage in charitable solicitation to register within a municipality”
3. **ISP 2021-055** by Representative Jack Ladyman - “An act concerning the Arkansas speed trap law; and for other purposes”
