<u>HB1157</u>	Bentley	TO REQUIRE PUBLIC SCHOOL DISTRICTS AND OPEN-ENROLLMENT PUBLIC CHARTER SCHOOLS TO PROVIDE INFORMATION TO PUBLIC SCHOOL STUDENTS REGARDING WATER SAFETY EDUCATION COURSES AND SWIMMING LESSONS.
<u>HB1238</u>	Cozart	TO AMEND VARIOUS PROVISIONS OF THE ARKANSAS CODE CONCERNING ENHANCED TRANSPORTATION FUNDING AMOUNTS; AND TO DECLARE AN EMERGENCY.
<u>SB190</u>	R. Murdock	TO REQUIRE THE DIVISION OF ELEMENTARY AND SECONDARY EDUCATION TO GRANT A PETITION FOR A WAIVER SUBMITTED BY A PUBLIC SCHOOL DISTRICT IF AN OPEN-ENROLLMENT PUBLIC CHARTER SCHOOL IS ELIGIBLE TO RECEIVE THE WAIVER.
