<a href="#">HB1154</a>	Cozart	TO REQUIRE THAT ANY INCREASES IN PROFESSIONAL DEVELOPMENT FUNDING EACH SCHOOL YEAR BE USED FOR PROFESSIONAL DEVELOPMENT COMMUNITIES.

<a href="#">HB1002</a>	McElroy	TO REGULATE EQUIPMENT REQUIRED FOR SCHOOL BUSES; TO REQUIRE THAT CERTAIN SCHOOL BUSES BE EQUIPPED WITH SEAT BELTS; AND TO ENFORCE THE USE OF SEAT BELTS ON SCHOOL BUSES EQUIPPED WITH SEAT BELTS.
<a href="#">HB1017</a>	Cozart	TO ALLOW THE TEACHER FAIR DISMISSAL ACT OF 1983 TO BE WAIVED IF A PUBLIC SCHOOL OR PUBLIC SCHOOL DISTRICT IS UNDER STATE AUTHORITY AFTER BEING CLASSIFIED AS BEING IN DISTRESS.
<a href="#">HB1027</a>	Eubanks	TO PROHIBIT A SCHOOL DISTRICT FROM USING PUBLIC FUNDS TO PAY A TEACHER'S OR CLASSIFIED EMPLOYEE'S MEMBERSHIP DUES IN A PROFESSIONAL ORGANIZATION.
