Mission Statement:

The mission of the ArkansasIDEAS initiative is to improve teacher quality as a means to increase student achievement by providing high quality professional development, online and face-to-face trainings, and instructional resources to teachers licensed in the state of Arkansas 24 hours a day, seven days a week.

Vision Statements:

ArkansasIDEAS provides all Arkansas licensed teachers access to high quality, innovative professional development opportunities 24/7/365 via internet-enabled devices and face-to-face workshops.

Professional development hours offered by ArkansasIDEAS meets the standards for high quality. Administrators and educators in all content and licensure areas will find course offerings in ArkansasIDEAS appropriate for their professional development needs.

Goals and Expectations:

The following goals and expectations are based upon a staffing level of at least 90%, in the event of staff level below 90%, the goals and expectations will need to be adjusted in collaboration with the Arkansas Department of Education.

Goals:

- 1) To maintain active users at the level of at least 50% of the enrolled users
- 2) To increase the number and variety of professional development courses (prioritized by ADE initiatives and needs assessment results) by 10% each calendar year
- 3) To increase professional development credit hours earned (completion of course assessment at 80% or greater) by 10% each calendar year
- 4) To provide high quality (average of 3.5 or above) workshops to all districts and organizations who request ArkansasIDEAS training on how to use the LMS and how to host professional development on specific content using the LMS, measured by workshop evaluations (5-point Likert scale)
- 5) To provide high quality (yearly average of 3.5 or above) professional development to all licensed educators who take ArkansasIDEAS online courses, measured by course survey (5-point Likert scale)

Expectations:

- 1) To compile and monitor unsolicited qualitative data from users
- 2) To offer and monitor Help Desk support via phone and email to ArkansasIDEAS users
- 3) To monitor measurable data quarterly and revise actions accordingly toward meeting program goals
- 4) To annually evaluate the effectiveness of the Arkansas Online Professional Development Initiative and its online professional development courses and programs
- 5) To annually report evaluation findings to stakeholders

Evaluation of Goals

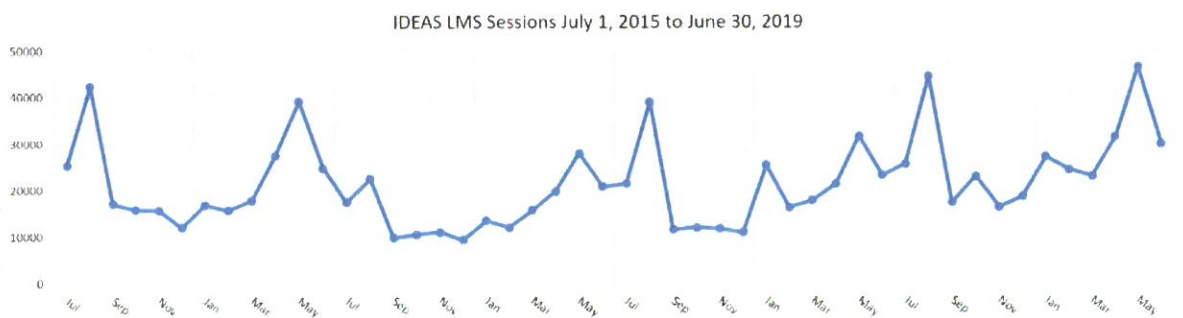
An evaluation of the previously stated goals and expectations is provided annually to stakeholders via the ArkansasIDEAS Year End Report. A summary page of key data points is provided quarterly and included in the appendix of the year-end report. All evaluations are based on data currently available within the learning management system (LMS) and records maintained by the staff. Baseline data is provided to the reader as a point of reference.

New web-based software, which launched June 1, 2015, has had an impact on ArkansasIDEAS users and services and those numbers are becoming evident now that there are four years of data to report. The new LMS implementation has been noted, where applicable, to distinguish the baseline data for the new system.

It should be assumed that all data reported herein is retrieved from within the ArkansasIDEAS LMS and is limited to users who complete courses within the LMS. When applicable, data obtained from other sources will be noted.

Every project pursued by the AETN-ArkansasIDEAS team is in service of one goal—to impact student learning through educator training. Arkansas educators rely on ArkansasIDEAS regularly for their professional development needs, logging into the ArkansasIDEAS LMS by the thousands throughout the year. The number of educators logging into ArkansasIDEAS varies according to the school year, with the highest numbers occurring during annual teacher in-service training days, but even the lowest peaks rarely dip below ten thousand users.

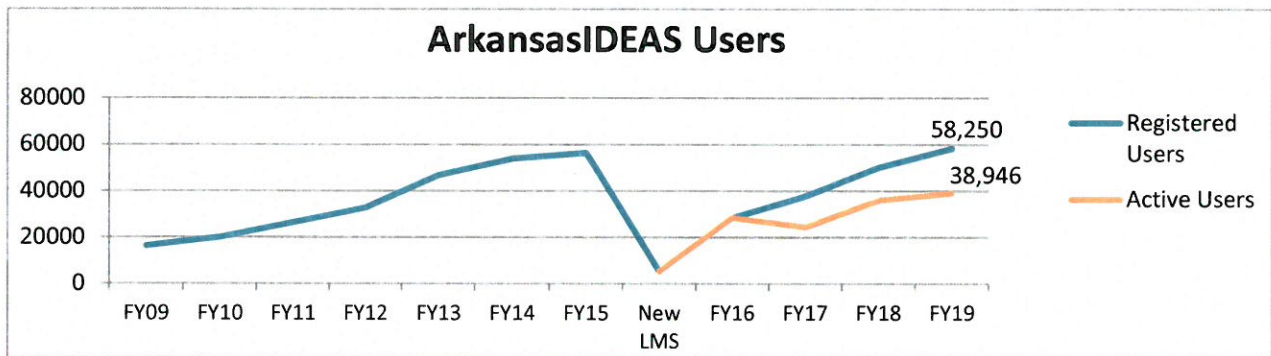
This graph represents the heartbeat of the LMS, the actual teachers who log in and generate the data for this report. Arkansas educators have a direct impact on students and are the focus of our work.



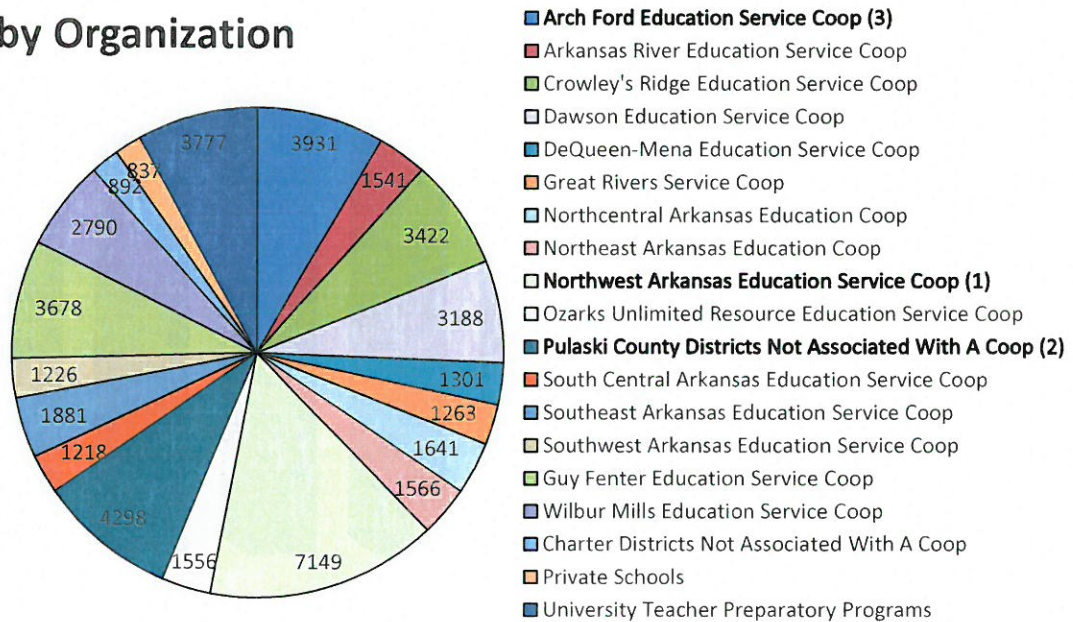
GOAL 1

Maintain active users at the level of at least 50% of enrolled users

ArkansasIDEAS serves thousands of educators throughout the year. Active users are defined as any user that has logged into the learning management system (LMS) within the last twelve months. With the rollout of a new LMS on June 1, 2015, all educators were required to create new accounts. The numbers have quickly rebounded as users have found the new system more user-friendly and easier to navigate. The number of new accounts added each year holds steady and the number of active users remains above the 50% threshold.



Users by Organization



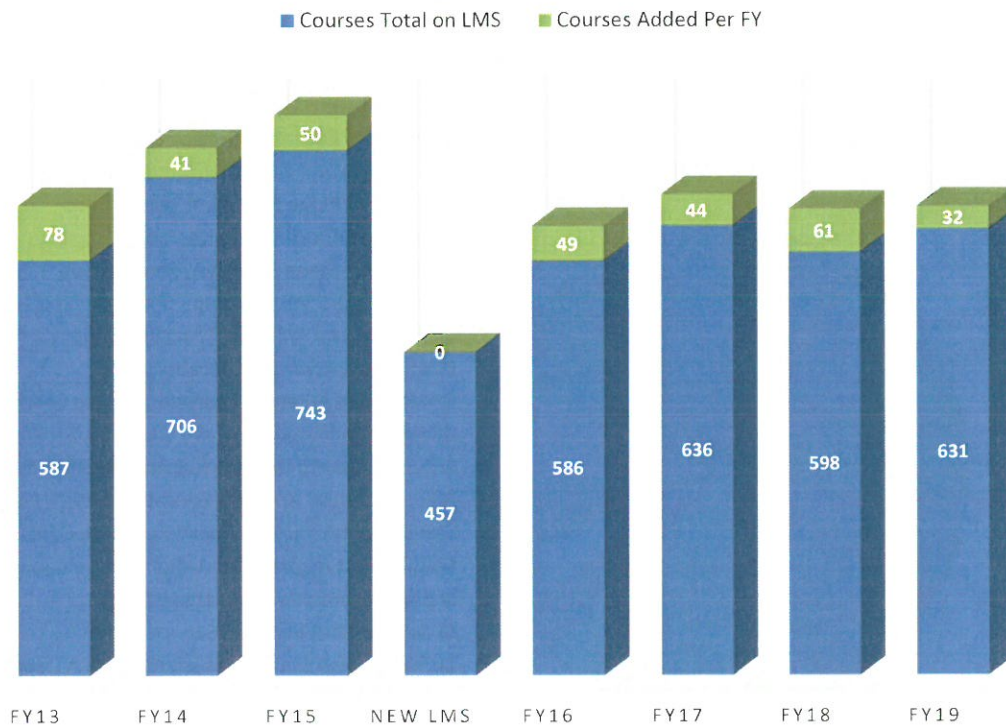
In an effort to monitor and distinguish data, all user accounts are created in a hierarchy starting at the Education Service Cooperative level. From there, users filter down to the school district and even campus level. In the future this will allow administrators to assign PD and facilitate the overall advancement of features in the LMS.

GOAL 2

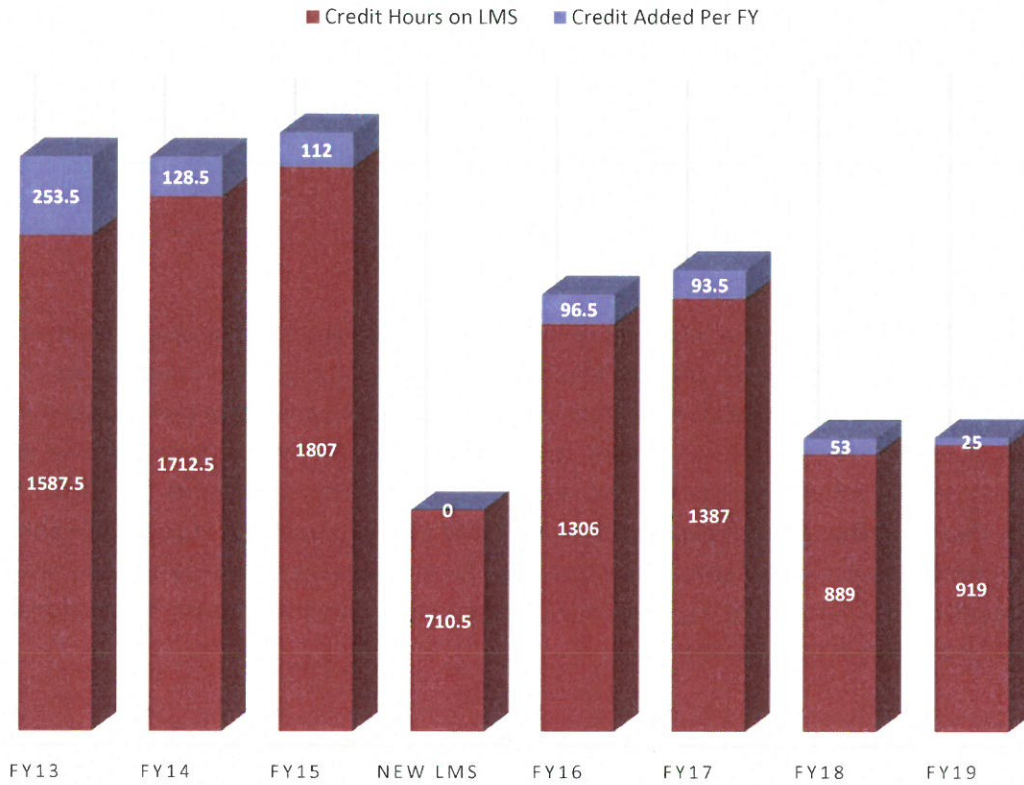
To increase the number and variety of professional development courses (prioritized by ADE initiatives and needs assessment results) by 10% each calendar year

Each year the ArkansasiDEAS team of Producers and Education Specialists work with the Arkansas Department of Education (ADE) as well as other stakeholders to design and create online professional development. The topics and areas of content are driven by state trends and needs as assessed by ADE, requested topics from survey tools used with educators, and laws or regulations that affect licensure. Subject matter experts are sought out to guide the objectives and goals of the course and to ensure that learning is on topic and relevant to current research. Production staff provides the skills and abilities to turn presentations into video productions. The education team serves as instructional designers, developing the course outline and creating assessment tools aligned with online professional development standards in Arkansas.

Note: Baseline data for June 30, 2015 represents new courses added to the new LMS software, opened June 1, 2015, in addition to the manual transfer of courses to the new software.

The decrease in the number of courses and credit hours added this fiscal year is in part due to increasing the level of video quality and instructional design of our courses which requires more planning time during the pre-production phase of our work flow. This decrease in number of courses was also due to additional projects contributed to by the ArkansasIDEAS team by request of the Arkansas Department of Education. Descriptions of the additional non-course projects are available in Appendix A.

Content Available on the LMS

After the implementation of the new system in the fall of 2015, a new online catalog available outside of the LMS was created to reduce the need for printed catalogs. This catalog is a live feed of the PD courses available to certified teachers through their ArkansasIDEAS account. It is filterable by subject area and TESS Domain. A selection of these courses is also available to non-licensed educators and support personnel, and a list of those can be found on the course catalog page on the website. 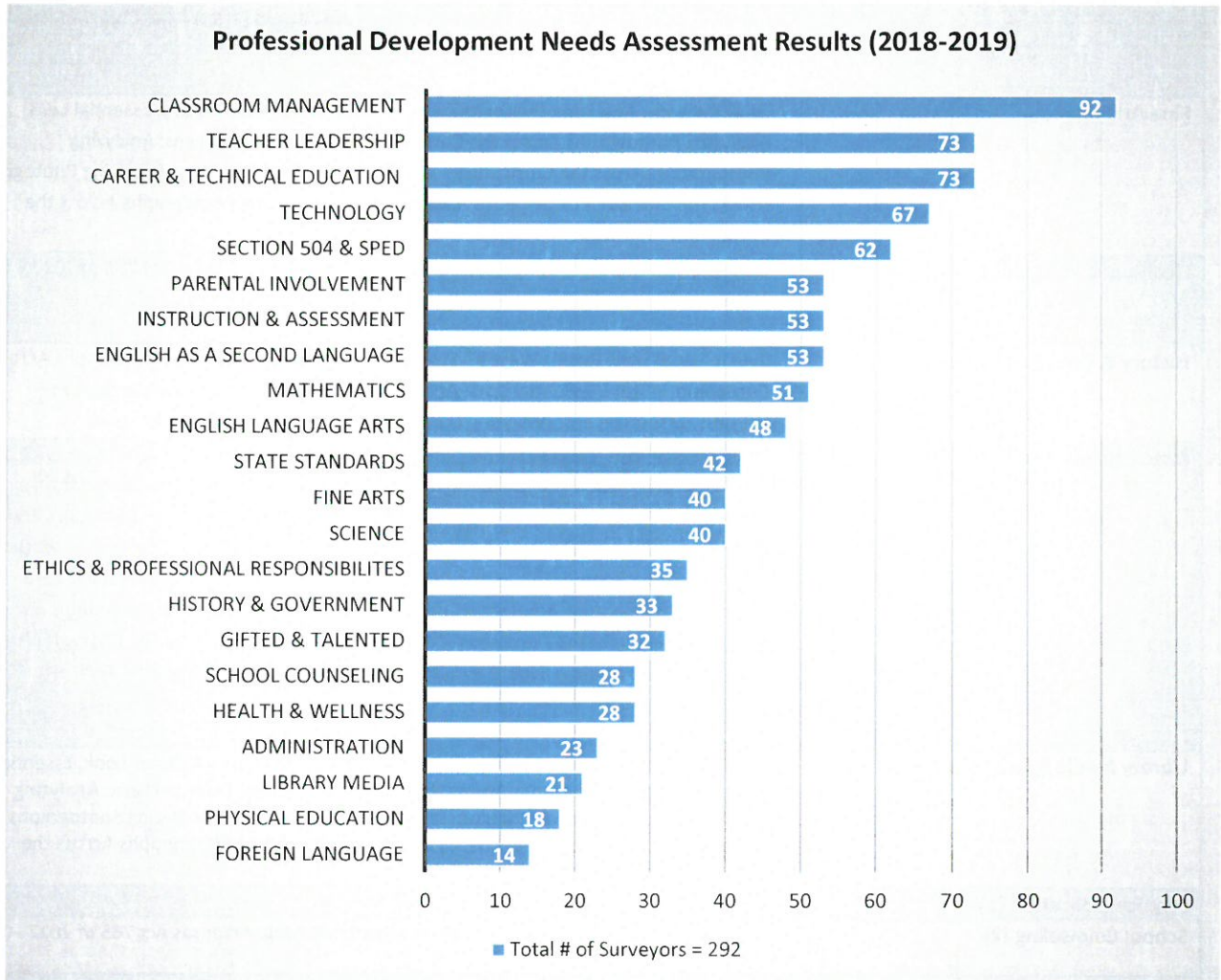
Training Resources for PD Facilitators

ArkansasIDEAS continues to create resources for certified administrators and teacher leaders who facilitate professional development sessions at schools and at education service cooperatives. Professional development facilitators have often used ArkansasIDEAS courses in their face-to-face training sessions but navigation of our courses, which are designed for asynchronous learning, proved difficult. Additionally, attendance was not reported, limiting the ability to fully track the impact of the resources. These training resource pages provide increased ability to track this impact while also making the resource more accessible to facilitators. Altogether, facilitators have reported that they have used the ArkansasIDEAS Facilitated Training Version (FTV) resources to provide professional development to over 21,000 educators in this past year.

User Requests for Content

When afforded the opportunity to meet users, ArkansasIDEAS takes the opportunity to collect their input on the content offered on the LMS. ArkansasIDEAS also made available a Professional Development Needs Assessment Survey in the LMS, giving users the ability to provide us with feedback. The graph below depicts the data collected.

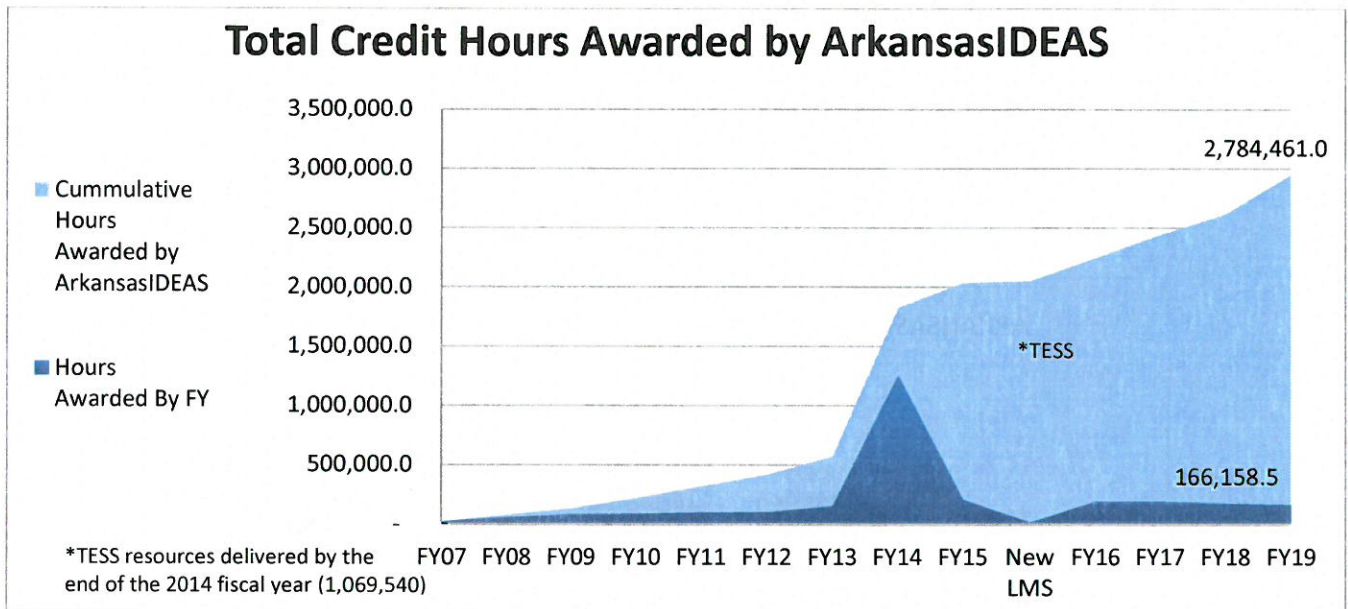

GOAL 3

To increase professional development credit hours earned (completion of course assessment at 80% or greater) by 10% each calendar year

ArkansasIDEAS provides educators with the trainings they need when they need them. Every year, educators continue to earn tens of thousands of credit hours available through ArkansasIDEAS. These hours are documented through the certificates awarded within the LMS either as individual teacher work or Program of Study completion.

In 2011, legislation introducing the Teacher Excellence and Support System (TESS) was passed and this initiative began to receive the focus of professional development hours in Arkansas. Teachers and administrators were searching for information to assist with the implementation of TESS, so ArkansasIDEAS created a dedicated website to provide reliable access to the necessary training. While tracked separately because much of the training was provided by districts, ArkansasIDEAS was able to verify that by the end of the 2014 Fiscal Year, over one million hours of TESS training had been provided through ArkansasIDEAS web resources.

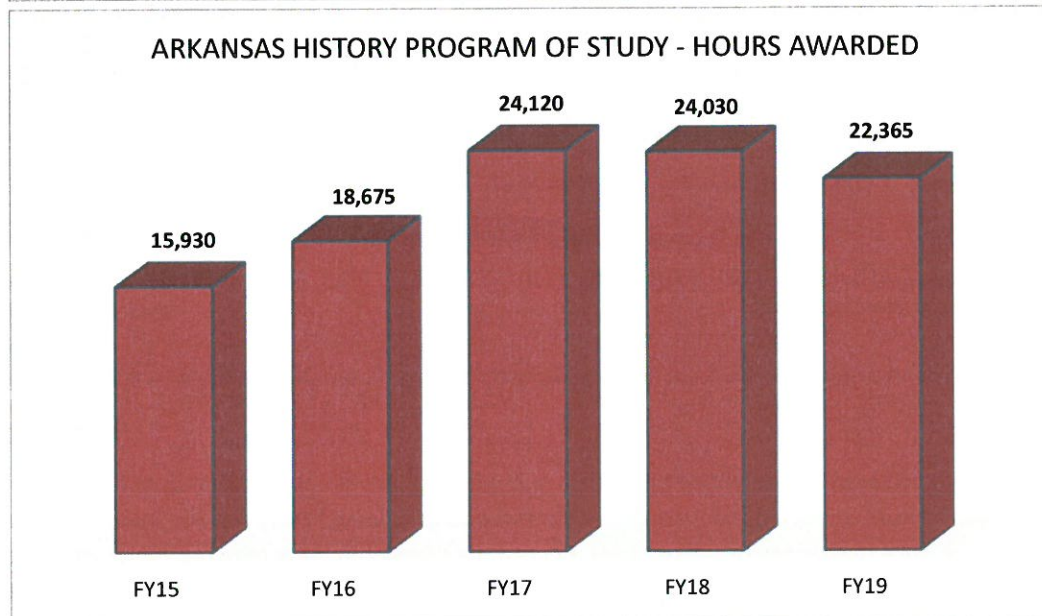
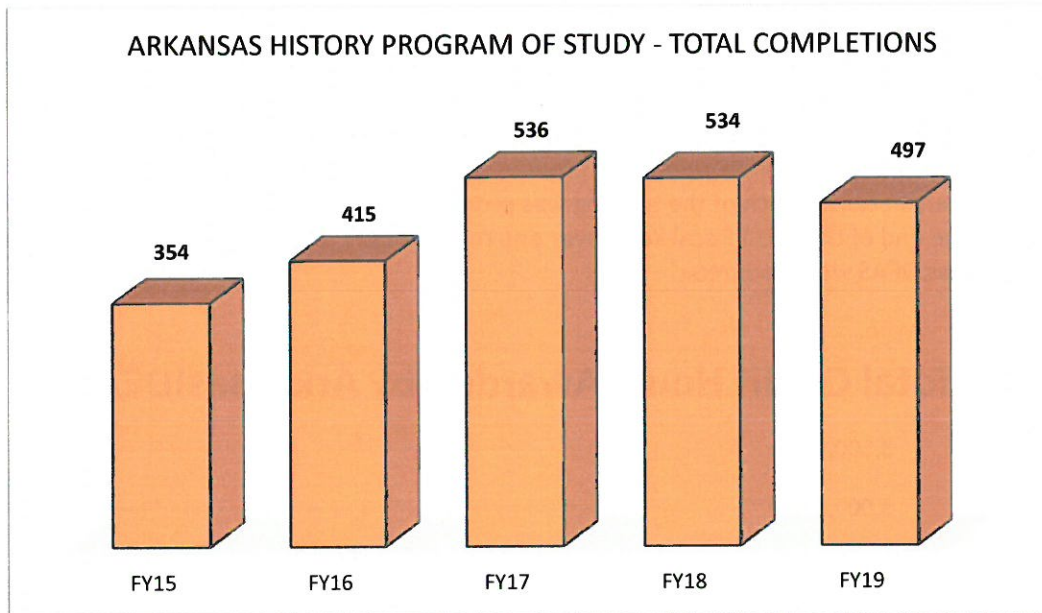


Note: These numbers do not include hours awarded by the school districts for whole-group sessions using ArkansasIDEAS content or resources.

The most popular courses taken, according to the data in Appendix E, are the courses associated with trainings mandated by ADE. These courses include trainings on the science of reading, family and community engagement, human trafficking, child maltreatment, and dyslexia. Beyond the courses on these required topics, many educators tend to seek out courses on instructional strategies and educational technology, as well as classroom management and behavior strategies. Courses about student health issues and special education also remain popular. This aligns well with the most frequently requested trainings listed on the Needs Assessment Survey.

Arkansas History Program of Study

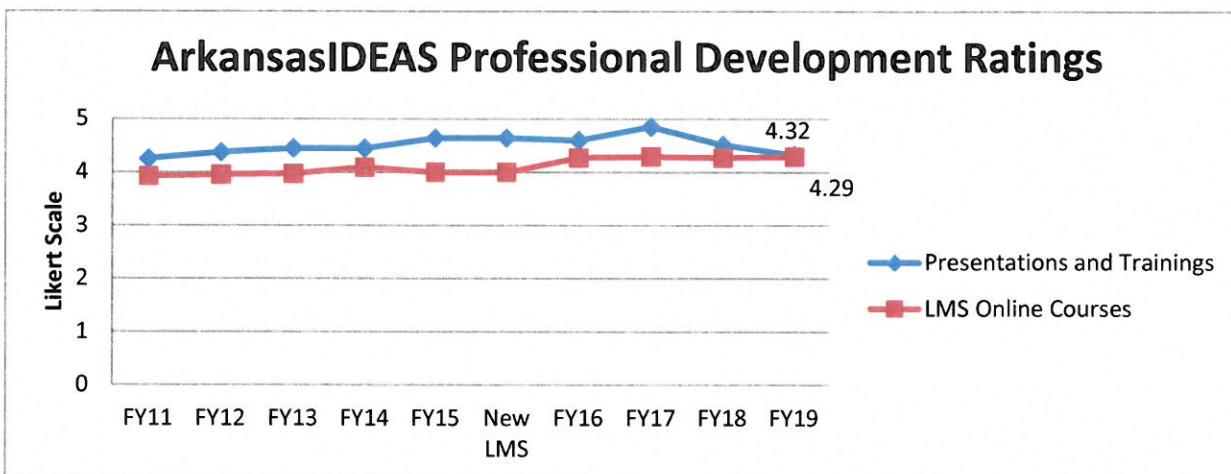
ArkansasIDEAS provides the Arkansas History Program of Study that is vital to educator licensure. Every year hundreds of educators, including educators from other states who wish to become licensed in Arkansas, rely on the program as an affordable way to meet licensure and endorsement requirements that would otherwise require the completion of college-level courses. More and more, universities in Arkansas are choosing to guide their students towards completing the program rather than offering the required college courses. The Arkansas History Program of Study is a composition of 45 hours of ArkansasIDEAS professional development courses selected by the Arkansas Department of Education as an alternative to the college courses required to obtain initial licensure in the state.



GOALS 4 and 5

To provide "high quality" (average of 3.5 or above) workshops to all districts and organizations who request ArkansasIDEAS trainings and presentations on how to use the LMS and how to host professional development on specific content using the LMS, measured by workshop evaluations (5-point Likert scale)

To provide "high quality" (yearly average of 3.5 or above) professional development to all licensed educators who take ArkansasIDEAS online courses, measured by course survey (5-point Likert scale)



The online courses, face-to-face trainings, and presentations provided by ArkansasIDEAS are consistently rated as "high quality" on a five-point Likert scale. The average rating of the online professional development courses has noticeably increased since the rollout of the new LMS. This proves that it was time for a new system and that our users expect updated services from ArkansasIDEAS.

Online Course Data

The design of our online survey allows us to ask users who rate us as below average or poor for additional input so that we can target the areas of concern of our users. Because the following comments come from that solicited section of the survey, they tend to address the issues and problems of the LMS while more of the praise and accolades come from the unsolicited feedback. This information is used by the ArkansasIDEAS team to make decisions concerning course design, layout, and viability. Below is the summary of actions taken based on that feedback.

ARKANSAS HISTORY PROGRAM OF STUDY AUTOMATION Enrollment and coursework verification process took multiple days to complete depending on number of requests	Automating the program now allows for self-enrollment and a cleaner verification process. Lesson activities in the newly automated program are also time restricted, making seat time easily validated.
SURVEY UPDATE Many survey comments mention that the survey is too long or cumbersome to complete, which could inadvertently result in inaccurate survey data.	The ArkansasIDEAS team is in the process of researching best practices regarding course surveys and will be updating our survey methods in the coming fiscal year.
OUT OF DATE CONTENT Courses reported as having outdated content (references to Common Core, aligned to old standards, not updated with new advancements)	Content of the LMS is monitored to remove outdated content. In FY20 and beyond, the education team will be utilizing a maintenance plan to update or archive older courses as necessary.

Presentations and Booths

ArkansasIDEAS is increasing in the number of requests we get for school presentations and conference booths. Over the past decade we have cultivated a partnership with several groups and organizations that represent educators in Arkansas. We try to accommodate most partners who contact us for either a presentation or a booth. Marketing continues to be a need to ensure that new educators have access to ArkansasIDEAS and that existing users are up-to-date with course content, new features, and new resources.

Comments and suggestions given by conference and training attendees are also evaluated by ArkansasIDEAS staff to identify trends and commonalities in requests and to guide future marketing decisions. A selection of comments from the above listed events can be found in Appendix D - User Comments.

Expectations

ArkansasIDEAS is committed to excellence. The learning management software purchased for the ArkansasIDEAS portal of online professional development in 2015 continues to offer new features that can be used to make courses more engaging and enhance the learning experience of Arkansas educators. Researching and utilizing available features of the software and continuing to improve services and course offerings remains an important focus for ArkansasIDEAS.

In addition to researching new features, ArkansasIDEAS responds to user observations and suggestions by following up with solutions. Whether the area for improvement suggested is the age of the content, the length of the courses, the engagement of the speaker, or the quality of the video segments, the ArkansasIDEAS team is continually working on solutions to improve the user learning experience. User feedback has led ArkansasIDEAS on a clear path committed to continuing improvement of the instructional design process.

The following points of data are evaluated annually, and quarterly if needed, to address not only the current operations and procedures but to look for new ways to improve and provide high quality online professional development, face-to-face trainings, and instructional resources to teachers licensed in the state of Arkansas.

1) To compile and monitor unsolicited qualitative data.

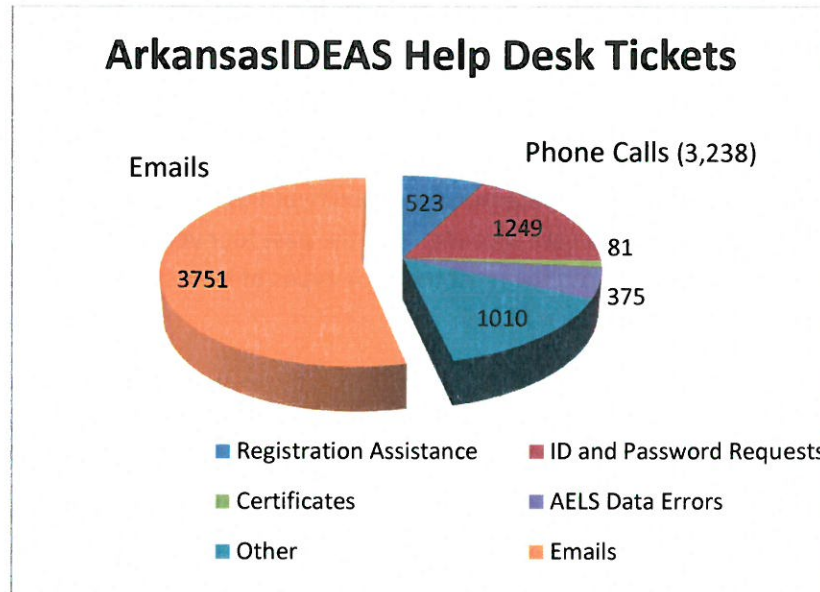
Data is obtained from the LMS via the comment section of the online course survey; from conferences and events; from the Help Desk via phone calls and emails; and from social media. Much of the unsolicited data from the course survey tends to return praise and accolades from users. We appreciate the kind words and encouragement that we receive. Critical comments obtained through unsolicited data tend to follow the same pattern of input as that from the solicited.

UNENROLLMENT DISABLED In an effort to retake courses that users had already completed, many users were choosing to “unenroll” and “reenroll” in a course believing that this would reset their records.	Even with a warning message on the button, users were still choosing to unenroll from courses. Now, the “unenroll” button has been disabled and removed. Users can no longer accidentally reset their coursework.

- 2) To offer Help Desk support, via phone and email, to all ArkansasIDEAS users. The ArkansasIDEAS Help Desk is open 7:00AM - 5:30PM Monday - Friday, not including state holidays.

The ArkansasIDEAS Help Desk team is readily available to assist users with any issues they encounter. The volume of help desk requests has decreased with the rollout of the newer, more streamlined learning management software in 2015 and with the implementation of online user guides, but the help desk still receives thousands of emails and phone calls each year on topics such as ID and password requests, incorrect AELS data, registration assistance, and help with obtaining certificates. No matter the problem, the ArkansasIDEAS Help Desk is here to help.



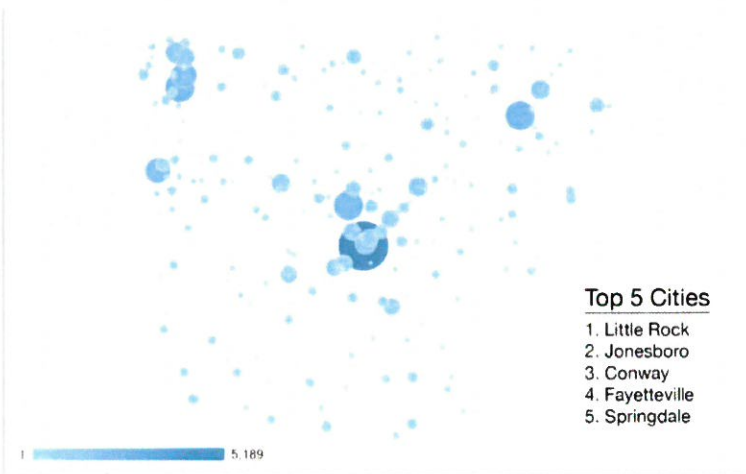
- 3) To monitor measurable data quarterly and revise actions toward meeting program goals.

Each quarter ArkansasIDEAS monitors the number of users, courses, and credit hours obtained. Over the last several years districts have also expressed wanting to look at similar statistics for their organizations users.

REPORTING FEATURES Reporting features in the LMS have been limited.	Zoola Analytics, a reporting tool created by Lambda Solutions, has been purchased and installed. The tool plans to be launched in the fall of 2019.

ArkansasIDEAS provides the online professional development services needed to maintain equity in teacher training across the state. From new laws and educational initiatives to specialized content knowledge and theories on best practices, ArkansasIDEAS is devoted to providing high-quality professional development and committed to remaining the largest, most accessible training resource tailored specifically for Arkansas educators.

Google Analytic Data is monitored annually to identify the activity and trends of users. One piece of data used behind the scenes to evaluate the compatibility of the LMS is the common browser and operating systems used to access user accounts. For the past four years Safari, Internet Explorer, Firefox, and Edge have rounded out the most common types of browsers, with Chrome remaining in the top position each time the data is pulled.



It has also been interesting to track the five cities in the state with the highest number of logins recorded on the ArkansasIDEAS LMS (ideaslms.aetn.org). Consistently the pattern has held for Little Rock, Fayetteville, Springdale, and Jonesboro to be somewhere in the top five with varying order. These are central hubs for their regions, and naturally would garner a higher number of account logins.

- 4) To annually evaluate the effectiveness of the Arkansas Online Professional Development Initiative and its online professional development courses and programs

ArkansasIDEAS offers a wide variety of resources to support educators in the classroom. Through video productions, AETN educational materials, and access to LinkedIn Learning, there is something to benefit every classroom teacher. To make sure that teachers are aware of these resources, webinars are offered by request by the ArkansasIDEAS staff. Regardless of the size of the audience, ArkansasIDEAS is glad to provide assistance to educators looking for resources.

Access to LinkedIn Learning

ArkansasIDEAS offers all users access to a premium account through LinkedIn Learning, formally Lynda.com. This allows users to have unlimited access to a library of high-quality instructional videos on the latest software tools and skills, and with more than 5,000 technology trainings led by industry experts, LinkedIn Learning is designed for all levels of learners and is available whenever you are ready to learn. In FY19, ArkansasIDEAS users logged more than 2,000 hours through LinkedIn Learning with more than 3,500 logins.

PBS LearningMedia

AETN is now a PBS LearningMedia contributing station. For ArkansasIDEAS courses with connected PBS LearningMedia resources, teachers can assign video segments or other connected resources to their students' Google Classroom accounts or to their email addresses with just a few clicks. PBS LearningMedia accounts are free for teachers and include the functionality for creating quizzes, lessons, and other activities that can be assigned to students online.

Appendix A - Additional Projects (FY19)

Chasing the Dragon

The Governor declared October 24th as Opioid Awareness Day in Arkansas. ArkansasIDEAS had the opportunity to contribute to the statewide initiative through the design, burn, and distribution of 400 DVDs of the documentary “Chasing the Dragon.” The film features the true-life stories and experiences of people who have dealt with the opioid epidemic. The goal of the documentary is not only to raise awareness of the epidemic, but also to deter young adults from venturing into drug culture through a better understanding of addiction. ArkansasIDEAS will distribute additional DVDs in FY20 as needed for Opioid Awareness Day.

Books and Breakfast

March is School Breakfast Month in Arkansas. The ArkansasIDEAS production team produced three videos promoting programs across the state who celebrated the importance of school breakfast in keeping children healthy, focused and ready to learn. These videos were released in March 2019 and can be found on AETN’s Facebook page.

Sound It Out/Morphology Minute

As supplements to the R.I.S.E. Arkansas initiative, the ArkansasIDEAS production team began producing the “Sound It Out” and “Morphology Minute” digital series for the Arkansas Department of Education’s YouTube channel. The goal of the series is to help people learn how to correctly pronounce words and study their form. The first episode in each series launched in June 2019. New episodes will launch throughout the next fiscal year.

Maintenance and Transportation Training

Upon the request of the Arkansas Department of Education, the ArkansasIDEAS team added the Division of Public School Academic Facilities and Transportation (DPSAFT) as a new audience in the LMS this fiscal year. Already being one of the biggest online training solutions for school districts, ArkansasIDEAS was the perfect place where maintenance, custodial, food service, transportation and teaching professionals can gain further safety knowledge integral to their profession. The presentations provided cover a variety of topics, including; safety, security, transportation, nutrition services, employment practices, emergency management, health and human resources. A portion of the presentations satisfy annual OSHA training requirements for school district personnel such as Asbestos Awareness, Slips, Trips & Falls, Material Safety Data Sheets, Lockout/Tagout and Bloodborne Pathogen Exposure.

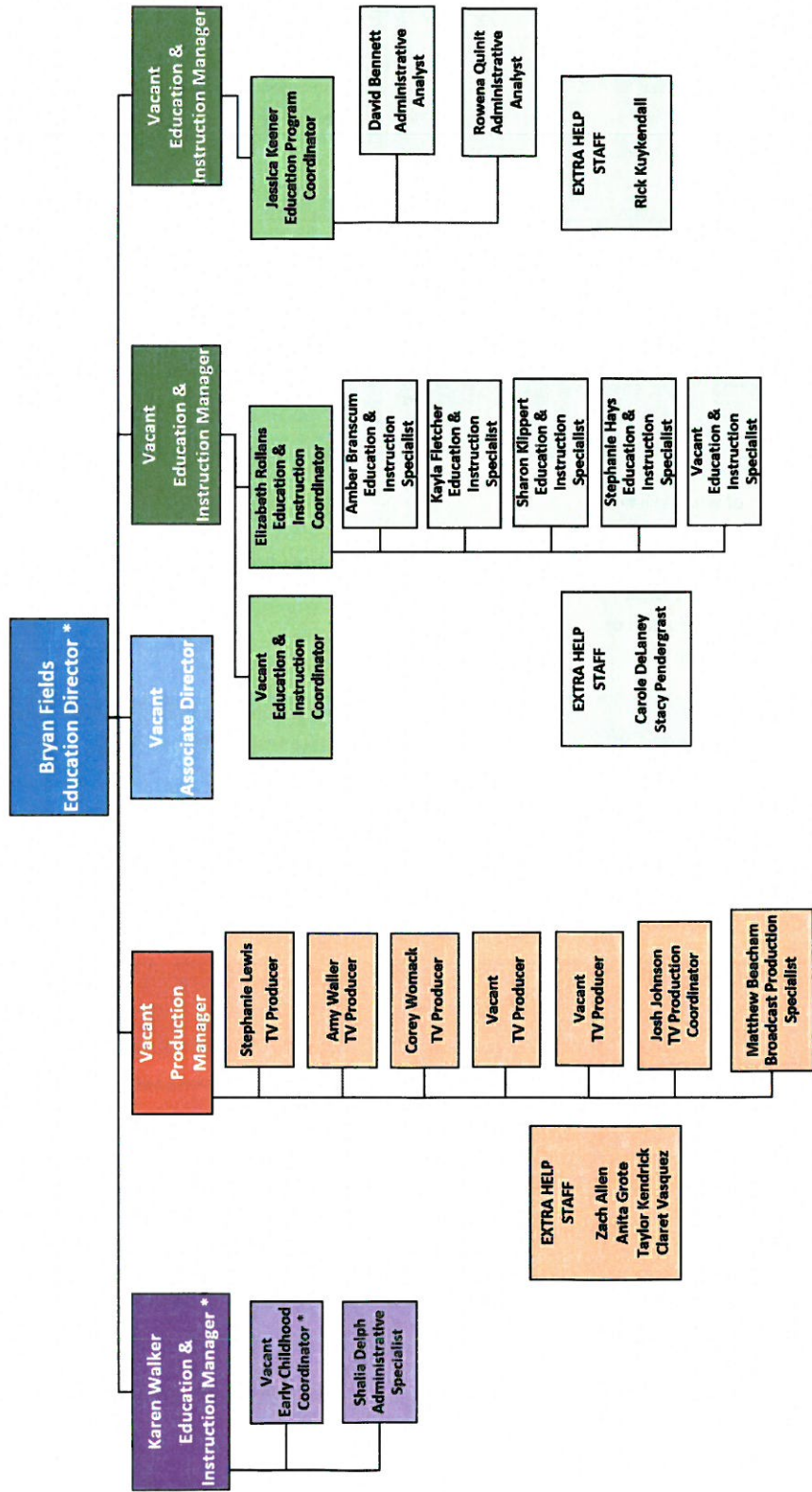


