Dear Senator Bledsoe and Representative Wardlaw:

On May 15, 2020 the Administrative Office of the Courts (AOC) submitted a Request Form for reimbursement through the CARES Act requesting \$127,684.09 in accordance with the Instructions for State Agencies issued by DFA. We assumed that DFA had already worked out the need for restoration of our budget appropriation in order for us to use these reimbursed funds. I confirmed receipt of these funds on June 15, 2020, and now respectfully ask that additional appropriation be granted to AOC to these Cost Centers in the following amounts:

The additional appropriation will allow us to use these federal funds to purchase additional Personal Protective Equipment, such as facemasks and hand sanitizers, for courts around our state. To date, we have distributed approximately 240,000 face masks and over 200 infrared thermometers to courts in each county in Arkansas.
