HIGHLIGHTS OF THE MONTH AND YEAR-TO-DATE COLLECTIONS

Collections of Gross General Revenues year-to-date of approximately \$8,093.6 million have increased \$1,111.0 million, or 15.9%, above the \$6,982.6 million collected last fiscal year-to-date. Net General Revenue Available for distribution this month of \$740.63 million increased \$150.9 million, or 25.6%, from the \$589.7 million available for distribution in June 2020. In accordance with Act 1315 of 1999, the Chief Fiscal Officer of the State transferred \$2,650,012.30 from Corporate Income Tax to the Workforce 2000 Development Fund for a current total of \$31,800,147.60.

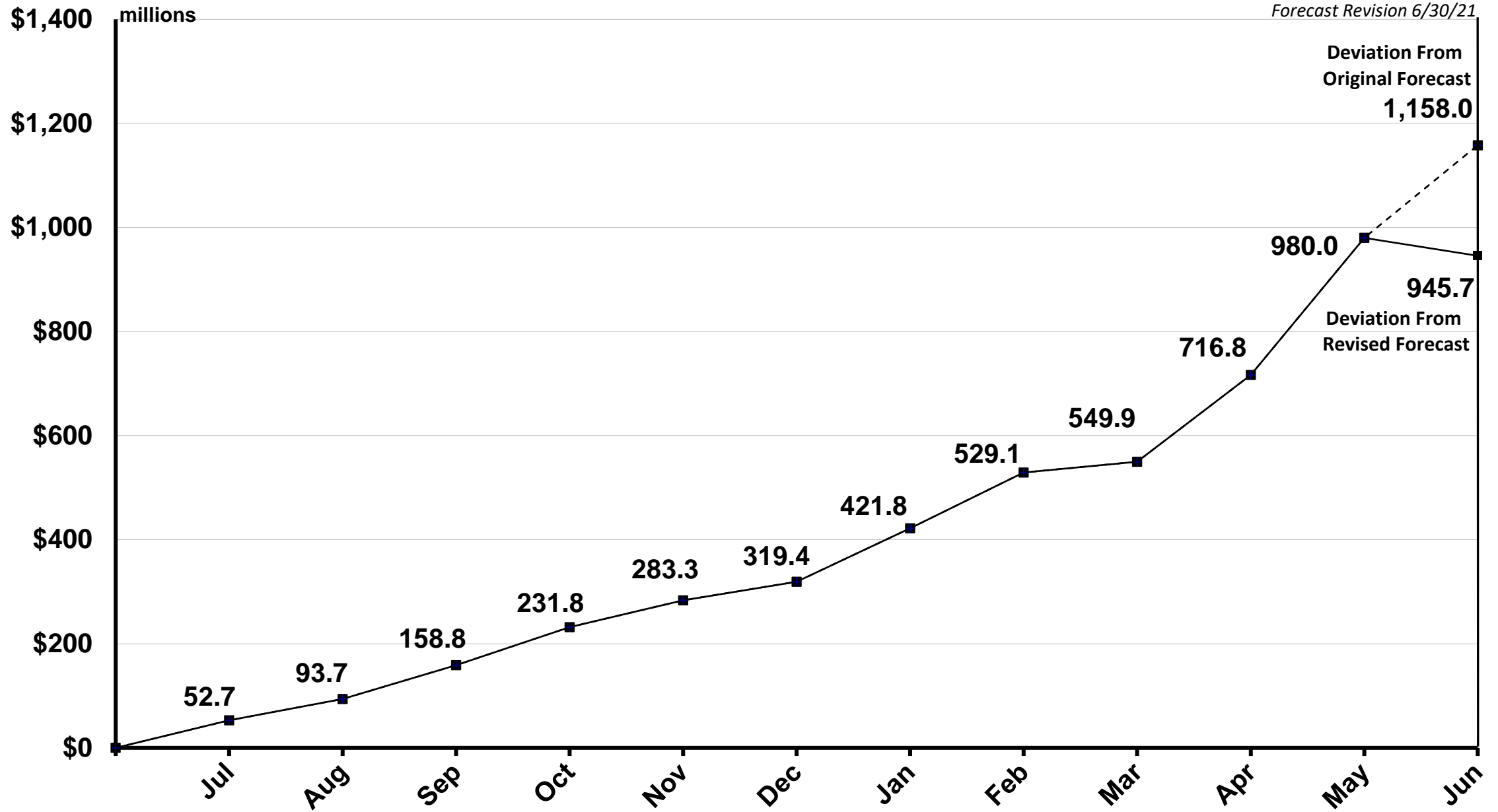
