**SUBJECT: COLLECTION AND DISTRIBUTION OF GENERAL AND SPECIAL REVENUES - 2017-2018**

Attached is the 2017-2018 Annual Revenue Report, which includes various schedules reflecting the collection and distribution of General and Special Revenues for the 2017-2018 fiscal year. In summary, Gross General Revenue collections of approximately \$6,738.3 million increased \$167.9 million or 2.56% above the \$6,570.4 million collected in fiscal year 2016-17. Adjusted Net General Revenues available for distribution of \$5,494.9 million increased \$146.1 million or 2.73% above the \$5,348.8 million available for distribution in fiscal year 2016-17. Gross Special Revenues of \$2,250.3 million increased \$64.4 million or 2.9% more than the \$2,185.9 million collected in fiscal year 2016-17.
