ATTACHMENT 1

SPECIAL LANGUAGE. INSURANCE BUILDING CONSTRUCTION FUNDING PROVISION.

Upon request of the Commissioner, approval of the Chief Fiscal Officer of the State, and prior review by the Arkansas Legislative Council or Joint Budget Committee, the State Insurance Department may retain an amount above that which is set out in A.C.A. 23-61-710(c) for the purposes of providing funding for the construction and renovation of Department facilities, not to exceed eight million dollars (\$8,000,000) in a single biennium. The amount being requested must be submitted to the Chief Fiscal Officer of the State by April 1st of each fiscal year.

The provisions of this section shall be in effect immediately upon passage and approval of this act and shall expire on June 30, 2019.
