Dear Secretary Walther-

I respectfully request consideration of a fund transfer in the amount of \$3,303,215 pursuant to section 10 of Act 457 of 2021 for the purposes of repairing, renovating, equipping, acquiring, and constructing Department of Human Services facilities. The funding for this transfer will be from state general revenue. Under this transfer plan, this source will provide \$3,303,215 to fund various projects for the benefit of the Division of Youth Services, the Division of Aging, Adult, and Behavioral Health Services, and the Division of Developmental Disabilities Services. Funding will be transferred from DYS0000 - Youth Services Fund Account to DHR8000 - Department of Human Services Renovation Fund. The Agency's three divisions with facility settings are holding aging facilities that may need significant work and upgrades that are often unanticipated and delaying those project(s) would cause greater harm to the facilities, clients, or programs of the Department of Human Services.
