HIGHLIGHTS OF THE MONTH AND YEAR-TO-DATE COLLECTIONS

Collections of Gross General Revenues year-to-date of approximately \$5,686.1 million have increased \$253.2 million, or 4.7%, above the \$5,432.9 million collected last fiscal year-to-date. Net General Revenue Available for Distribution this month of \$473.8 million increased \$55.5 million, or 13.3%, from the \$418.3 million available for distribution in June 2010.

In accordance with Act 1315 of 1999, the Chief Fiscal Officer of the State transferred \$2,177,309.67 from Corporate Income Tax to the Workforce 2000 Development Fund for a current total of \$26,062,397.18.

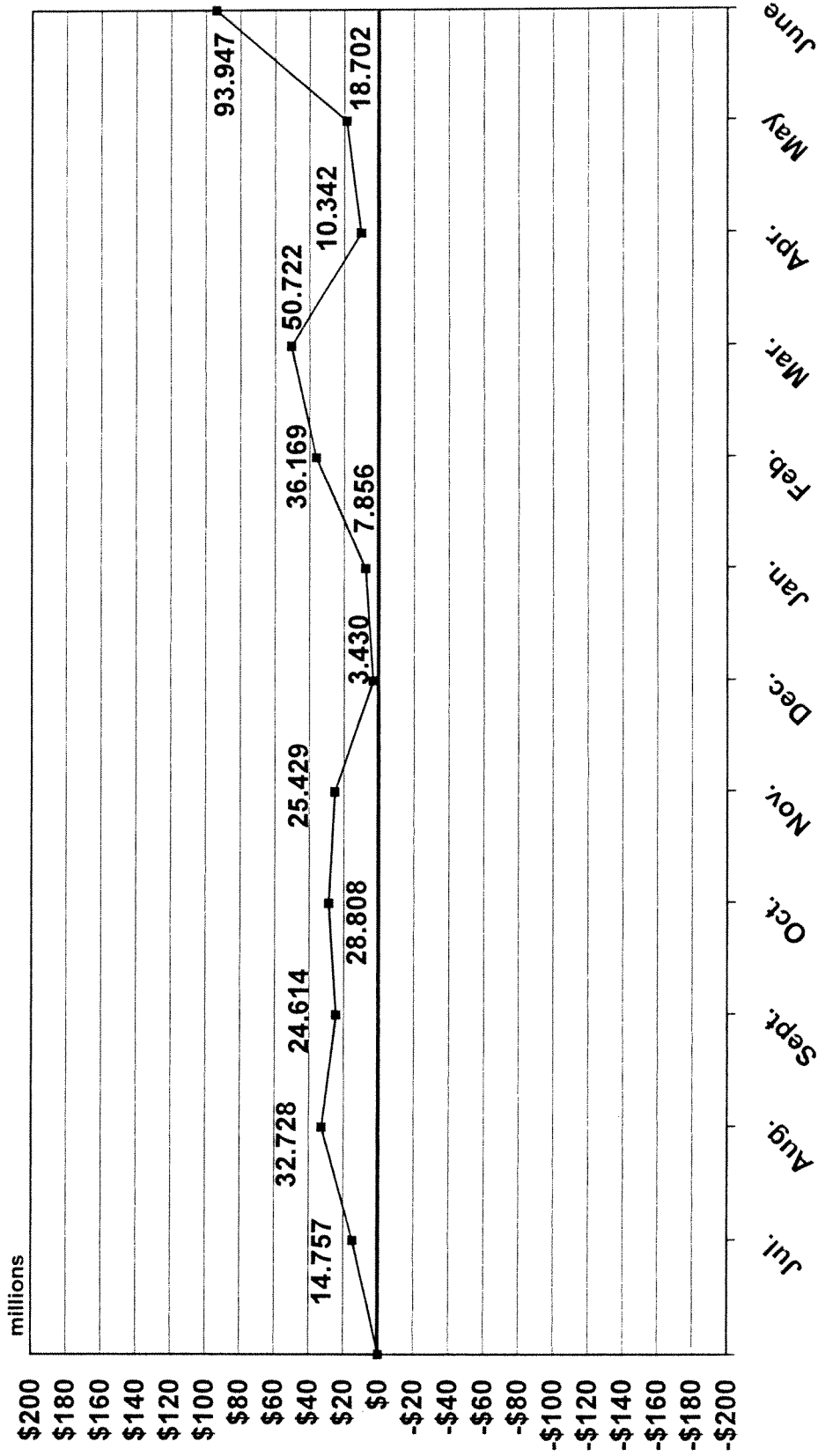
