Amend Senate Bill No. 48 as originally introduced:

Page 5, line 36, insert a new section immediately following Section 8 to read as follows:

" SECTION 9. SPECIAL LANGUAGE - CODE AMENDMENT. Arkansas Code § 12-9-111 is amended to read as follows:

12-9-111. Uniforms.

(a) ~~After seeking prior review by the Legislative Council or Joint Budget Committee and approval by the Chief Fiscal Officer of the State, the~~ The Arkansas Commission on Law Enforcement Standards and Training ~~shall be is~~ exempt from § 19-6-109(c) for the purpose of buying uniforms for students and law enforcement officers employed by the commission.

(b) The amount spent for the purchase of uniforms under subsection (a) of this section in any one (1) year ~~shall be is~~ limited to forty thousand dollars (\$40,000)."

23 SECTION 1. REGULAR SALARIES. There is hereby established for the

SECTION 8. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. CARRY FORWARD. Any unexpended balances of funds authorized for Capital Outlay in the State Operations appropriation of this Act on June 30, ~~2018~~ 2019, shall be carried forward and made available for the same purpose during the fiscal year ending June 30, ~~2019~~ 2020.

Any carry forward of unexpended balance of funding as authorized herein, may be carried forward under the following conditions:

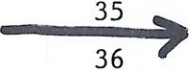
(1) Prior to June 30, ~~2018~~ 2019, the Agency shall by written statement set forth its reason(s) for the need to carry forward said funding to the Department of Finance and Administration Office of Budget;

(2) The Department of Finance and Administration Office of Budget shall report to the Arkansas Legislative Council all amounts carried forward from the first fiscal year of the biennium to the second fiscal year of the biennium by the September Arkansas Legislative Council or Joint Budget Committee meeting in the second fiscal year of the biennial period which report shall include the name of the Agency, Board, Commission or Institution and the amount of funding carried forward from the first fiscal year to the second fiscal year, the program name or line item, the funding source and a copy of the written request set forth in (1) above;

(3) Each Agency, Board, Commission or Institution shall provide a written report to the Arkansas Legislative Council or Joint Budget Committee containing all information set forth in item (2) above, along with a written statement as to the current status of the project, contract, purpose etc. for which the carry forward was originally requested no later than thirty (30) days prior to the time the Agency, Board, Commission or Institution presents its budget request to the Arkansas Legislative Council/Joint Budget Committee; and

(4) Thereupon, the Department of Finance and Administration shall include all information obtained in item (3) above in the budget manuals and/or a statement of non-compliance by the Agency, Board, Commission or Institution.

The provisions of this section shall be in effect only from July 1, ~~2017~~ 2018 through June 30, ~~2018~~ 2019.
