Amendment No. \_\_\_ to House Bill No. 1073

Amend House Bill No. 1073 as originally introduced:

Insert an additional SECTION immediately following SECTION 16 to read as follows:

" SECTION 17. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL OR TEMPORARY LAW. FUNDING TRANSFER. Immediately upon the effective date of this act, the Chief Fiscal Officer of the State shall transfer on his or her books and those of the State Treasurer and the Auditor of the State the sum of twenty-eight million four hundred sixty-three thousand five hundred fifty-eight dollars (\$28,463,558), or all remaining unobligated funds as certified by the Chief Fiscal Officer of the State, from the Economic Development Incentive Quick Action Closing Fund to the Arkansas Highway Transfer Fund to provide funds for the Arkansas Department of Transportation to support a state match for federal funding."

AND

Appropriately renumber the subsequent SECTION numbers of the bill.

20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

21  
22 SECTION 1. REGULAR SALARIES. There is hereby established for the  
23 Arkansas Department of Transportation for the 2018-2019 fiscal year, the  
24 following maximum number of regular employees and the maximum annual salary  
25 for such employees; and no greater salary than that established herein shall  
26 be paid to any employee from appropriations hereinafter made for said  
27 department. The annual salaries to be paid to each employee authorized herein  
28 shall be determined by the Arkansas Highway Commission within the limitations  
29 as set out in this Section and the funds and the appropriations made  
30 available for such purposes. All positions established herein shall be exempt  
31 from the provisions of the Uniform Personnel Classification and Compensation  
32 Act (Arkansas Code §§21-5-201 et seq.), or its successor, but shall not be  
33 exempt from the provisions of the Regular Salaries Procedures and  
34 Restrictions Act. Provided further that the salaries for the pay period  
35 beginning June 2018 and ending July 2018 can be paid from the salaries and  
36 overtime authorized for the fiscal year ending June 30, 2019.



1 SECTION 16. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
 2 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. PERSONAL  
 3 SERVICES MATCHING TRANSFER. Provided that in the event amounts appropriated  
 4 in the Personal Services Matching line item of the Operations appropriation  
 5 section are insufficient in the fiscal year to pay the amounts at the rates  
 6 stipulated by law to be paid for each of these items, an additional amount as  
 7 determined and requested by the Director of the Arkansas Department of  
 8 Transportation, and upon review by the Arkansas Legislative Council or Joint  
 9 Budget Committee, will be transferred by the Director of Finance and  
 10 Administration and the Auditor of State from the Maintenance and General  
 11 Operation line items to the Personal Services Matching line item of the  
 12 Operations appropriation section to enable the Arkansas Department of  
 13 Transportation to pay the required matching funds.

14 The provisions of this section shall be in effect only from July 1, 2017  
 15 2018 through June 30, 2018 2019.

 17 → SECTION 17. COMPLIANCE WITH OTHER LAWS. Disbursement of funds  
 18 authorized by this act shall be limited to the appropriation for such agency  
 19 and funds made available by law for the support of such appropriations; and  
 20 the restrictions of the State Procurement Law, the General Accounting and  
 21 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary  
 22 Procedures and Restrictions Act, or their successors, and other fiscal  
 23 control laws of this State, where applicable, and regulations promulgated by  
 24 the Department of Finance and Administration, as authorized by law, shall be  
 25 strictly complied with in disbursement of said funds.

 27 SECTION 18. LEGISLATIVE INTENT. It is the intent of the General  
 28 Assembly that any funds disbursed under the authority of the appropriations  
 29 contained in this act shall be in compliance with the stated reasons for  
 30 which this act was adopted, as evidenced by the Agency Requests, Executive  
 31 Recommendations and Legislative Recommendations contained in the budget  
 32 manuals prepared by the Department of Finance and Administration, letters, or  
 33 summarized oral testimony in the official minutes of the Arkansas Legislative  
 34 Council or Joint Budget Committee which relate to its passage and adoption.

 36 SECTION 19. EFFECTIVE DATE. This act is effective on and after July 1,
