3 REQUESTING THAT THE ARKANSAS LEGISLATIVE COUNCIL REFER TO THE  
4 HIGHER EDUCATION SUBCOMMITTEE OF THE ARKANSAS LEGISLATIVE COUNCIL  
5 A REQUEST TO CONDUCT A STUDY OF SEXUAL ASSAULT AWARENESS,  
6 PREVENTION, AND RESPONSE ON THE FOUR-YEAR AND TWO-YEAR COLLEGE  
7 AND UNIVERSITY CAMPUSES IN ARKANSAS.

9 WHEREAS, the General Assembly has an obligation to ensure that our  
10 colleges and universities keep our students safe; and  
11

12 WHEREAS, sexual assaults and attempted sexual assaults occur on  
13 campuses large and small, urban and rural, private and public; and  
14

15 WHEREAS, a June 2015 poll by the Washington Post and the Kaiser Family  
16 Foundation found that twenty percent (20%) of college women and five percent  
17 (5%) of college men surveyed reported having been sexually assaulted; and  
18

19 WHEREAS, a February 2015 report by the Journal of Adolescent Health  
20 found that nineteen percent (19%) of college women reported being a victim of  
21 attempted or completed rape, either by force or while they were incapacitated  
22 due to alcohol or drugs, during their freshman year; and  
23

24 WHEREAS, according to the United States Department of Education,  
25 reports of forcible sex offenses on college campuses increased by eighty-four  
26 percent (84%) from 2009 to 2013; and  
27

28 WHEREAS, as of May 2014, fifty-five (55) colleges and universities in  
29 the United States were under investigation by the United States Department of  
30 Education for possible violations of Title IX in their handling of sexual  
31 assault cases; and

33 WHEREAS, the number of colleges and universities in the United States  
34 under investigation by the Department of Education for possible violations of  
35 Title IX in their handling of sexual assault cases stood at one hundred  
36 twenty-four (124) as of July 2015; and

WHEREAS, while the forty-six (46) college and university campuses in Arkansas are not among the college and universities currently under investigation, it is critical that the Arkansas General Assembly ensure that our state's colleges and universities provide safe, secure campuses and properly respond to any sexual assault;

NOW THEREFORE, BE IT PROPOSED BY THE ARKANSAS LEGISLATIVE COUNCIL OF THE NINETIETH GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

THAT the Arkansas Legislative Council refer to the Higher Education Subcommittee of the Arkansas Legislative Council a request to conduct a study of sexual assault awareness, prevention, and response on the four-year and two-year college campuses in Arkansas.

BE IT FURTHER RESOLVED THAT by July 1, 2017, the study be completed and a report presented to the Speaker of the House of Representatives and the President Pro Tempore of the Senate.
