JUSTIFICATION

Agriculture makes this request to address recruitment and retention issues in this classification located at the Baucum Nursey in North Little Rock. The division has experienced a 57.14% turnover rate for this classification during the past fiscal year.

The primary function of this facility is to grow, test, and sell forest tree seedlings. The seedlings are lifted, packed, and transported to various cooler locations for reforestation throughout the state of Arkansas. This certification will allow the department to recruit and retain qualified staff with a CDL, which is essential for testing and transporting seedlings to landowners within the state.

The Arkansas Department of Agriculture is requesting a five percent certification differential pay increase for the following Natural Resources Program Technician positions at our Forestry Division's Baucum Nursery.

- 22088412-Natural Resources Program Technician, B101C, GS04
- 22094666- Natural Resources Program Technician, B101C, GS04
- 22088519- Natural Resources Program Technician, B101C, GS04-currently vacant

Current pay for nursery technicians is \$13.96 per hour. A five percent increase is 70 cents per hour (\$14.66) or an annual increase of \$1,456 per technician for a total of \$4,368 for three positions.

Hiring and keeping technicians at the nursery has been difficult; 11 technicians have been hired to fill the three positions over the past five years. The Department is optimistic that offering a five percent certification differential pay increase for attaining a class A CDL will help with hiring and retention.
