- CCA was founded in 1983 with the belief that Public Private Partnerships in Corrections delivers the best of both worlds: The innovation and cost-effectiveness of business with the accountability and oversight of government.
- As a full-service corrections management provider, we specialize in the design, construction, expansion and management of prisons, jails, detention facilities and residential reentry centers.
- CCA is the fifth largest correctional system in the United States, behind the federal government and three states.
- Government partnerships with 15 states, the District of Columbia, Federal Bureau of Prisons, U.S. Immigration and Customs Enforcement, U.S. Marshals Service, U.S. Virgin Islands, and 12 local municipalities
- Approximately 15,000 CCA employees across the nation provide care and confinement to more than 70,000 inmates housed in more than 60 facilities.

- G.I. Jobs magazine has consistently ranked CCA on its annual list of the "Top 100 Military-Friendly Employers®" making CCA one of the best places to work in America for military servicepersons transitioning from active duty. Evaluation factors include Reserve/Guard policies; percentage of new veterans hired; internal recruitment, training and promotional programs for veterans; and community outreach.

Companies were compared based on corporate responsibility efforts in eight categories – climate change, employee relations, environment, financial, governance, human rights, lobbying, and philanthropy.

# CCA State Partnerships

## HAWAII MODEL

- State looks to partnership prisons to meet bed needs
- CCA provides safe and secure out-of-state beds, with a full compliment of needed services

## CALIFORNIA MODEL

- State needs additional bed space due to capacity constraints within their system
- CCA funds, builds and leases new, state of the art correctional facility in a fraction of the time and at a fraction of the cost

## TENNESSEE MODEL

- State needs significant bed space and programming due to backup of state inmates in county jails
- CCA funds, builds and will manage a 2500-bed facility for the state, with a focus on the rehabilitation of inmates

# CCA State Partnerships

## OHIO MODEL

- State needs money for important capital projects, but also needs additional capacity within correctional system
- CCA purchases state-owned facility, adds capacity and manages inmate population for partner, providing much needed capacity and capital in the process

## DESIGN, BUILD, FINANCE MODEL

- State facility is antiquated, inefficient and expensive to manage
- CCA funds, builds and manages a new state-of-the-art facility, saving time and taxpayer dollars in the process while keeping debt off of governmental balance sheet
