SAFETY / ACCIDENT REPORTING

TO PROTECT THE IDENTITIES OF CHILDREN FROM BEING DISCLOSED TO THE PUBLIC IN MOTOR VEHICLE ACCIDENT AND INVESTIGATION REPORTS

name/address of minor occupant shall be redacted and not available under FOIA unless requestor is a parent/guardian or a representative of an insurance company; effective 1-1-15

SB 359 ACT 488 B. Sample

TO MAKE TECHNICAL CORRECTIONS TO THE ARKANSAS CODE CONCERNING THE SUSPENSION OF DRIVING PRIVILEGES FOR MINOR IN POSSESSION OF ALCOHOL

SB 487 ACT 436 J. Woods

TO ALLOW THE USE OF A BOATER EDUCATION CERTIFICATE IN AN ACCEPTABLE ELECTRONIC FORMAT IN LIEU OF A PAPER CERTIFICATE

electronic copy is sufficient for presentment; does not authorize a search of the electronic device or expand or restrict the authority of law enforcement to conduct a search

HB 1180 ACT 965 Steel

CONCERNING IMPROPER LANE USAGE ON CERTAIN MULTILANE HIGHWAYS

addresses when a person may drive in the left lane of a roadway; authorizes AHTD to prohibit continuous driving in the left lane on certain designated highways or portions of multilane highways

HB 1232 ACT 224 Copenhaver

TO REQUIRE ALL PASSENGER VEHICLES NOT OPERATED FOR HIRE TO COMPLY WITH CHILD SAFETY RESTRAINT LAWS

HB 1307 ACT 293 Copenhaver

TO ALLOW MEDICAL WAIVER WINDOW TINTING TO BE THE SAME AS REGULAR LAW ENFORCEMENT VEHICLES

medically necessary window tinting may exceed state established requirements for light transmission, requires labeling from the installer affirming compliance with statutory requirements, and requires disclosure of medical waiver for window tinting or removal of the tinting on transfer of the vehicle

TO REQUIRE MOTORISTS TO MOVE OVER FOR AN AUTHORIZED VEHICLE DISPLAYING A FLASHING OR WARNING LIGHT AT THE SCENE OF A STOP

drivers required to move to farthest possible lane/position from the authorized vehicle; if unable to change lanes, driver shall reduce speed and use caution through the area where authorized vehicle is stopped

HB 2008 ACT 1003 Copenhaver

TO PROHIBIT COVERING OF REQUIRED MOTOR VEHICLE LIGHTING THAT REDUCES LIGHTING VISIBILITY

covering a headlamp or other required lighting device is prohibited if the cover reduces the visibility of the device

if technology allowing access for individuals who are blind or visually impaired is not reasonably available, individuals shall be provided a reasonable accommodation; applies retroactively to information technology procured on or after 7-30-99 and any upgrades/modifications to or replacement of information technology procured on or after 7-30-99; effective 3-11-13

SB 797 ACT 442 J. Dismang

TO ENSURE CONTINUED BROADBAND EXPANSION IN RURAL AREAS WITHIN THE STATE; TO PROVIDE 911 EMERGENCY SERVICE TO RURAL AREAS WITHIN THE STATE; TO ENHANCE THE 911 EMERGENCY SYSTEM AND ASSIST ITS FUNDING

enacts the Telecommunications Regulatory Reform Act of 2013; regulate the administration and use of the AR High Cost Fund and duties of Fund Administrator; adopt certain regulatory reforms for the deregulation of telecommunications carriers; effective 3-19-13

SB 926 ACT 1168 Teague

TO CREATE A STATE BROADBAND MANAGER TO PROMOTE, DEVELOP, AND COORDINATE BROADBAND EXPANSION AND APPROPRIATE BROADBAND INFRASTRUCTURE FOR ALL AREAS OF THE STATE
designates DIS Director as the State Broadband Manager

TO REGULATE THE USE OF AUTOMATIC LICENSE PLATE READER SYSTEMS
prohibits use of system except by law enforcement/parking enforcement or for entry to secure areas; data captured by the system to be destroyed after 150 days unless preserved for an ongoing investigation

HB 2007 ACT 590 Copenhaver

TO ESTABLISH THE ARKANSAS EMERGENCY CONTACT INFORMATION SYSTEM
AR State Police, in conjunction with other entities, may establish this system to help law enforcement notify next of kin/designated emergency contact of an eligible participant in times of emergency; information may be used only for emergency notification purposes or pursuant to a court order and shall not be used in a criminal investigation or any other purposes; public participation is voluntary; participant is responsible for accuracy of emergency contact information.

extends authority to regulate towing and recovery to counties
