Senator Williams called the meeting to order.

**A motion was made to approve the minutes by Senator Rice and seconded by Representative Eubanks, without objection, the motion carried. [EXHIBIT C]**

**Consideration to Adopt Interim Study Proposals (ISPs) [EXHIBITS D1 – D3]**

**ISP 2017-058 “To amend the repayment provisions regarding loans made to the Department of Correction from the Budget Stabilization Trust Fund.” [EXHIBIT D1]**  
Senator Eddie Joe Williams introduced ISP 2017-058. This study will review amendment of Arkansas Code 19-5-501 (b) (1) (B). A motion to adopt ISP 2017-058 was made by Senator Terry Rice and seconded by Senator Eddie Joe Williams, without objection, the motion carried.

**ISP 2017-086 “Requesting that the Senate Committee on State Agencies and Governmental Affairs study the process for awarding homestead property tax credits, including the mechanisms in place to guarantee that a citizen owning multiple parcels of land receive on one (1) tax credit.” [EXHIBIT D2]** Senator Eddie Joe Williams introduced ISP 2017-086. This study will review methods to ensure that citizens of the state claim only one (1) homestead property tax credit. A motion to adopt ISP 2017-086 was made by Representative Jack Ladyman and seconded by Senator Terry Rice, without objection, the motion carried.

**ISP 2017-087 “Requesting the Senate Committee on State Agencies and Governmental Affairs study a potential requirement that reports police intervention at premises licensed to serve alcohol by the drink be delivered to the appropriate regulatory authorities.” [EXHIBIT D3]** Senator Eddie Joe Williams introduced ISP 2017-087. This study will review a

potential requirement that reports of police intervention at premises licensed to serve alcohol be delivered to the Alcohol Beverage Control Division and the Alcoholic Beverage Control Enforcement Division. A motion to adopt ISP 2017-087 was made by Senator Terry Rice and seconded by Representative Jack Ladyman, without objection, the motion carried.
