<u>SB526</u>	A. Clark (Lowery)	<u>MOTION TO EXPUNGE THE VOTE BY WHICH FAILED</u> TO REQUIRE THE PRESENCE OF A FINANCIAL COUNSELOR UNDER CERTAIN CONDITIONS WHEN A STUDENT OF A STATE-SUPPORTED INSTITUTION OF HIGHER EDUCATION SIGNS A DOCUMENT TO BORROW A STUDENT EDUCATION LOAN.
