15 TO AMEND THE PROCEDURES FOR ANNEXATION.

18 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
19

20 SECTION 1. Arkansas Code § 14-40-302(b), concerning exceptions to
21 annexation proceedings, is amended to read as follows:

22 (b)(1) Contiguous lands shall not be annexed ~~when they~~ if the lands
23 either:

24 (A) Have a fair market value, at the time of the adoption
25 of the ordinance, of lands used only for agricultural or horticultural
26 purposes and the highest and best use of the lands is for agricultural or
27 horticultural purposes; or

28 (B) Are lands upon which a new community is to be
29 constructed with funds guaranteed, in whole or in part, by the federal
30 government under Title IV of the Housing and Urban Development Act of 1968 or
31 under Title VII of the Housing and Urban Development Act of 1970.

32 (2) Any person, firm, corporation, partnership, or joint
33 venturer desiring to come within this exclusion must have received from the
34 Department of Housing and Urban Development a letter of preliminary
35 commitment to fund the new community under one (1) of the federal acts.

1 (3) If any lands are annexed that are being used ~~exclusively~~ for
2 agricultural purposes, the lands shall be protected under § 2-4-101 et seq.,
3 and the lands may continue to be used for such purposes so long as the owner
4 desires and the lands shall be assessed as agricultural lands.

5
6 SECTION 2. Arkansas Code § 14-40-303 is amended to read as follows:

7 14-40-303. Annexation ~~ordinance—Election—Procedures~~ initiated by
8 municipalities.

9 ~~(a) The annexation ordinance shall:~~

10 ~~(1) Contain an accurate description of the lands desired to be~~
11 ~~annexed;~~

12 ~~(2) Include a schedule of the services of the annexing~~
13 ~~municipality that will be extended to the area within three (3) years after~~
14 ~~the date the annexation becomes final; and~~

15 ~~(3) Fix the date for the election provided in this section.~~

16 ~~(b)(1) The annexation ordinance shall not become effective until the~~
17 ~~question of annexation is submitted to the qualified electors of the annexing~~
18 ~~municipality and of the area to be annexed at the next general election or at~~
19 ~~a special election. The special election shall be called by ordinance or~~
20 ~~proclamation of the mayor of the annexing municipality in accordance with §~~
21 ~~7-11-201 et seq.~~

22 ~~(2)(A) If a majority of the qualified electors voting in the~~
23 ~~election vote for the annexation, no later than fifteen (15) days following~~
24 ~~the election, the county clerk shall certify the election results and record~~
25 ~~the same, along with the description and a map of the annexed area, in the~~
26 ~~county records, and file a certified copy thereof with the Secretary of~~
27 ~~State.~~

28 ~~(B) The annexation shall be effective, and the lands~~
29 ~~annexed shall be included within the corporate limits of the annexing~~
30 ~~municipality thirty (30) days following the date of recording and filing of~~
31 ~~the description and map, as provided in this section, or in the event an~~
32 ~~action is filed with the circuit court as provided in § 14-40-304, on the~~
33 ~~date the judgment of the court becomes final.~~

34 ~~(3) If a majority of the qualified electors voting on the issue~~
35 ~~at the election vote against the annexation, the annexation ordinance shall~~
36 ~~be null and void.~~

1 ~~(c)(1)(A) The city clerk shall certify two (2) copies of the~~
2 ~~annexation ordinance and a plat or map of the area to be annexed and convey~~
3 ~~one (1) copy to the county clerk and one (1) copy to the county election~~
4 ~~commission at least sixty (60) days before the election.~~

5 ~~(B)(i) No later than forty five (45) days prior to the~~
6 ~~election, the city shall identify all persons who reside within the area~~
7 ~~proposed to be annexed, and the county clerk shall assist the city in~~
8 ~~determining the names and addresses of all qualified electors residing within~~
9 ~~that area.~~

10 ~~(ii) The failure to identify all persons residing~~
11 ~~within the area proposed to be annexed or the failure to determine the names~~
12 ~~and addresses of all qualified electors residing within that area shall not~~
13 ~~invalidate or otherwise affect the results of the election.~~

14 ~~(C) All of the qualified electors residing within the~~
15 ~~territory to be annexed shall be entitled to vote in the election.~~

16 ~~(D) The city clerk shall give notice of the election by~~
17 ~~publication by at least one (1) insertion in some newspaper having a general~~
18 ~~circulation in the city.~~

19 ~~(2)(A) The county clerk shall give notice of the voter~~
20 ~~registration deadlines at least forty (40) days before the election by~~
21 ~~ordinary mail to those persons whose names and addresses are on the list~~
22 ~~provided by the city clerk.~~

23 ~~(B) The county clerk shall prepare a list by precinct of~~
24 ~~all those qualified electors residing within the area to be annexed who are~~
25 ~~qualified to vote in that precinct and furnish that list to the election~~
26 ~~officials at the time the ballot boxes are delivered.~~

27 ~~(3) If the county clerk or the county election commission shall~~
28 ~~fail to perform any duties required of it, then any interested party may~~
29 ~~apply for a writ of mandamus to require the performance of the duties. The~~
30 ~~failure of the county clerk or the county election commission to perform the~~
31 ~~duties shall not void the annexation election unless a court finds that the~~
32 ~~failure to perform the duties substantially prejudiced an interested party.~~

33 ~~(d) If the annexation is approved and becomes final, the governing~~
34 ~~body of the city shall, by ordinance, as soon as practical after the~~
35 ~~annexation, attach and incorporate such annexed territory to and in one (1)~~
36 ~~or more wards of the city lying adjacent thereto, and the territory so~~

1 ~~assigned and attached to a ward shall thereafter be considered and become a~~
 2 ~~part thereof as fully as any other part of the city.~~

3 ~~(e) From the map or plat provided by city ordinance of the wards~~
 4 ~~assigned, the county clerk shall proceed to ascertain and determine the~~
 5 ~~voters' proper precinct and shall enter the same upon the voter registration~~
 6 ~~records of those inhabitants of the territory so annexed and give notice of~~
 7 ~~that change within thirty (30) days after the adoption of the city ordinance~~
 8 ~~assigning the territory to wards.~~

9 ~~(f)(1) In the event that within thirty (30) days of the date that one~~
 10 ~~(1) city calls for an annexation election, another city calls for an~~
 11 ~~annexation election on all or part of the same land proposed to be annexed by~~
 12 ~~the first city, then both annexation elections shall be held, provided that~~
 13 ~~the second city must call for its annexation election to be held on the next~~
 14 ~~available date in accordance with § 7-11-201 et seq. before or after the~~
 15 ~~holding of the first city's election.~~

16 ~~(2)(A) If the annexation election held first is approved by the~~
 17 ~~voters, the results of it shall be stayed until the second annexation~~
 18 ~~election is held.~~

19 ~~(B)(i) If only one (1) of the annexation elections is~~
 20 ~~approved by the voters, then the city that called that election shall proceed~~
 21 ~~with the annexation of the land.~~

22 ~~(ii)(a) Except as provided in subdivisions~~
 23 ~~(f)(2)(B)(ii)(b) and (c) of this section, if both annexation elections are~~
 24 ~~approved by the voters, then a third election shall be held three (3) weeks~~
 25 ~~after the second annexation election. The provisions of § 7-11-201 et seq.,~~
 26 ~~governing the procedures and dates on which special elections may be held~~
 27 ~~shall not apply to the third annexation election provided in this subsection.~~

28 ~~(b) If the date of the third election falls~~
 29 ~~upon a legal holiday, the election shall be held four (4) weeks after the~~
 30 ~~second annexation election.~~

31 ~~(c) If the date of the election under~~
 32 ~~subdivision (f)(2)(B)(ii)(b) of this section is a legal holiday, the election~~
 33 ~~shall be held five (5) weeks after the second annexation election.~~

34 ~~(iii) Notice of the third election shall be~~
 35 ~~published in a newspaper circulated in the area to be annexed during the~~
 36 ~~period following the second election.~~

1 ~~(iv) Only the residents of the area proposed to be~~
2 ~~annexed by both cities shall vote in the third election.~~

3 ~~(v) The issue on the ballot in the third election~~
4 ~~shall be into which of the two (2) cities the residents of the area want to~~
5 ~~be annexed.~~

6 ~~(vi) The area shall be annexed into the city~~
7 ~~receiving the most votes in the third election.~~

8 ~~(vii) In the event of a tie vote in the third~~
9 ~~election, the area shall be annexed to the city that had the highest~~
10 ~~percentage vote in favor of the annexation in the first or second election.~~

11 ~~(3) If the city that does not get to annex the area voted on by~~
12 ~~both cities included land in its annexation election other than the land~~
13 ~~voted on by both cities, then that land shall be annexed into such city if it~~
14 ~~is still contiguous to such city after the other land is annexed to the other~~
15 ~~city, but such land shall remain part of the county if it is not so~~
16 ~~contiguous.~~

17 (a) It is declared that:

18 (1) Sound urban development is essential to the continued
19 economic development of Arkansas;

20 (2) Municipalities are created to provide the governmental
21 services essential for sound urban development and for the protection of
22 health, safety, and welfare in areas being intensively used for residential,
23 commercial, industrial, institutional, and governmental purposes or in areas
24 undergoing development;

25 (3) Municipal boundaries should be extended using uniform
26 statutory standards that apply throughout the state to include such areas and
27 to provide the high quality of governmental services needed therein for the
28 public health, safety, and welfare;

29 (4) Areas annexed to municipalities using uniform statutory
30 standards should receive the services provided by the annexing municipality;

31 (5) The provision of services to protect the health, safety, and
32 welfare is a public purpose; and

33 (6) It is essential for citizens to have an effective voice in
34 annexations initiated by municipalities.

35 (b) As used in this section:

1 (1)(A) "Contiguous area" means any area that, at the time
2 annexation procedures are initiated, either abuts directly on the municipal
3 boundary or is separated from the municipal boundary by a street or street
4 right-of-way, a creek or river, the right-of-way of a railroad or other
5 public service corporation, lands owned by the municipality or some other
6 political subdivision, or lands owned by the State of Arkansas.

7 (B) A connecting corridor consisting solely of the length
8 of a street or street right-of-way may not be used to establish contiguity;

9 (2) "Eligible property owner" means a property owner who is
10 eligible to be notified of the opportunity to have water lines and sewer
11 lines and connections installed at no cost to the property owner because he
12 or she held a freehold interest in the real property to be annexed as of the
13 date of the combined notice of public informational meeting and public
14 hearing;

15 (3) "Necessary land connection" means an area that does not
16 exceed twenty-five percent (25%) of the total area to be annexed; and

17 (4) "Property owner" means a person having a freehold interest
18 in real property;

19 (5)(A) "Used for residential purposes" means any lot or tract
20 five (5) acres or less in size on which is constructed a habitable dwelling
21 unit.

22 (B) "Used for residential purposes" also means any lot or
23 tract that is used in common for social or recreational purposes by either
24 owners of lots with habitable dwelling units or owners of lots intended for
25 occupation by dwelling units and the lot owners have a real property interest
26 in the commonly used property that attaches to or is appurtenant to the
27 owners' lots.

28 (c) The governing body of a municipality may extend the corporate
29 limits of the municipality under this section.

30 (d) A municipality exercising authority under this section shall make
31 plans for the extension of services to the area proposed to be annexed and
32 before the public hearing under this subchapter shall prepare a report
33 setting forth the plans to provide services to the area proposed to be
34 annexed. The report shall include the following:

35 (1) A map of the municipality and adjacent territory to show the
36 following:

1 (A) The present and proposed boundaries of the
2 municipality;

3 (B) The present major trunk water mains and sewer
4 interceptors and outfalls, and the proposed extensions of such mains,
5 outfalls, and lines as required in this section. The water and sewer map
6 shall bear the seal of a registered professional engineer; and

7 (C) The general land use pattern in the area proposed to
8 be annexed;

9 (2) A statement showing that the area proposed to be annexed
10 meets the requirements of this subchapter;

11 (3) A statement setting forth the plans for extending to the
12 area proposed to be annexed each major municipal service on substantially the
13 same basis and in the same manner as the services are provided within the
14 rest of the municipality before annexation and the method to finance the
15 extension of major municipal services into the area proposed to be annexed as
16 follows:

17 (A)(i) Provision of police protection, fire protection,
18 solid waste collection, and street maintenance services on the effective date
19 of annexation.

20 (ii) A contract with a rural fire department to
21 provide fire protection shall be an acceptable method of providing fire
22 protection.

23 (iii) A contract with a private firm to provide
24 solid waste collection services shall be an acceptable method of providing
25 solid waste collection services; and

26 (B) Extension of water and sewer services to each lot or
27 parcel, if an installation easement is provided by the affected property
28 owner, with a proposed timetable for construction of such mains, outfalls,
29 and lines within three and one-half (3 ½) years of the effective date of
30 annexation, in accordance with this subchapter;

31 (4)(A) A statement of the impact of the annexation on any rural
32 fire department providing service in the area proposed to be annexed and a
33 statement of the impact of the annexation on fire protection and fire
34 insurance rates in the area proposed to be annexed, if the area where service
35 is provided is in a rural fire protection district or a fire service
36 district.

1 (B) The rural fire department shall make available to the
2 municipality not later than thirty (30) days following a written request from
3 the municipality all information in its possession or control, including
4 operational, financial, and budgetary information necessary for preparation
5 of a statement of impact.

6 (C) The municipality shall in a timely fashion supply the
7 rural fire department with information requested by the rural fire department
8 to respond to the written request.

9 (D) The rural fire department forfeits its rights under
10 this subchapter if it fails to make a good faith response within forty-five
11 (45) days following receipt of the written request for information from the
12 municipality, provided that the municipality's written request makes specific
13 reference to this section; and

14 (5)(A) A statement concerning how the proposed annexation will
15 affect the municipality's finances and services, including without limitation
16 municipal revenue change estimates.

17 (B) This statement shall be delivered to the county clerk
18 at least thirty (30) days before the date of the public informational meeting
19 on any annexation under this section.

20 (e) The governing body of a municipality may extend the municipal
21 corporate limits to include any area that meets all of the following
22 criteria:

23 (1) It shall be adjacent or contiguous to the municipality's
24 boundaries at the time the annexation proceeding begins, except if the entire
25 territory of a county water and sewer district is being annexed, the
26 annexation shall include any noncontiguous pieces of the district as long as
27 the part of the district with the greatest land area is adjacent or
28 contiguous to the municipality's boundaries at the time the annexation
29 proceeding begins;

30 (2) At least one-eighth (1/8) of the aggregate external
31 boundaries of the area shall coincide with the municipal boundary;

32 (3) No part of the area shall be included within the boundary of
33 another incorporated municipality; and

34 (4) The total area to be annexed shall meet the requirements of
35 the following:

1 (A) Part or all of the area to be annexed must be an area
2 developed for urban purposes at the time of approval of the report provided
3 for in this subchapter. The area of streets and street rights-of-way shall
4 not be used to determine total acreage under this subdivision. "Area
5 developed for urban purposes" means any area which meets any one (1) of the
6 following standards:

7 (i) Has a total resident population equal to at
8 least two and three-tenths (2 3/10) persons for each acre of land included
9 within its boundaries;

10 (ii) Has a total resident population equal to at
11 least one (1) person for each acre of land included within its boundaries and
12 is subdivided into lots and tracts such that at least sixty percent (60%) of
13 the total acreage consists of lots and tracts three (3) acres or less in size
14 and such that at least sixty-five percent (65%) of the total number of lots
15 and tracts are one (1) acre or less in size;

16 (iii) Is so developed that at least sixty percent
17 (60%) of the total number of lots and tracts in the area at the time of
18 annexation are used for residential, commercial, industrial, institutional,
19 or governmental purposes, and is subdivided into lots and tracts so that at
20 least sixty percent (60%) of the total acreage, not counting the acreage used
21 at the time of annexation for commercial, industrial, governmental, or
22 institutional purposes, consists of lots and tracts three (3) acres or less
23 in size;

24 (iv) Is the entire area of any county water and
25 sewer district, if all of the following apply:

26 (a) The municipality has provided in a
27 contract with that district that the area is developed for urban purposes;

28 (b) The contract provides for the municipality
29 to operate the sewer system of that county water and sewer district; and

30 (c) The municipality is annexing in one (1)
31 ordinance the entire territory of the district not already within the
32 corporate limits of a municipality; and

33 (v) Is so developed that, at the time of the
34 approval of the annexation report, all tracts in the area to be annexed are
35 used for commercial, industrial, governmental, or institutional purposes; or

1 (B) Part or all of the area to be annexed meets at least
2 one (1) of the following:

3 (i) Lies between the municipal boundary and an area
4 developed for urban purposes so that the area developed for urban purposes is
5 either not adjacent to the municipal boundary or cannot be served by the
6 municipality without extending major municipal services, including water or
7 sewer lines, through such sparsely developed area;

8 (ii) Is adjacent, on at least sixty percent (60%) of
9 its external boundary, to any combination of the municipal boundary and the
10 boundary of an area or areas developed for urban purposes as defined in this
11 section. The purpose is to permit the governing body of a municipality to
12 extend corporate limits to include all nearby areas developed for urban
13 purposes and where necessary to include areas which at the time of annexation
14 are not yet developed for urban purposes but which constitute necessary land
15 connections between the municipality and areas developed for urban purposes
16 or between two (2) or more areas developed for urban purposes; or

17 (iii) The total area to be annexed is completely
18 surrounded by the municipality's primary corporate limits.

19 (f) In fixing new municipal boundaries and determining whether land is
20 an area developed for urban purposes, the governing body of a municipality
21 shall:

22 (1) Use recorded property lines and streets as boundaries. Some
23 or all of the boundaries of a county water and sewer district may also be
24 used when the entire district is not already within the corporate limits of
25 the municipality;

26 (2) Use whole parcels of property. If any portion of that
27 parcel is included, the entire parcel of real property as recorded in the
28 deed transferring title shall be included;

29 (3) Not use a connecting corridor consisting solely of the
30 length of a street or street right-of-way to establish contiguity;

31 (4) Not consider property in use for a commercial, industrial,
32 institutional, or governmental purpose if the lot or tract is used only
33 temporarily, occasionally, or on an incidental or insubstantial basis in
34 relation to the size and character of the lot or tract;

35 (5) Include acreage actually occupied by buildings or other man-
36 made structures together with all areas that are reasonably necessary and

1 appurtenant to such facilities for purposes of parking, storage, ingress and
2 egress, utilities, buffering, and other ancillary services and facilities
3 when determining acreage in use for commercial, industrial, institutional, or
4 governmental purposes; and

5 (6) Consider the area of an abolished water and sewer district
6 to be a water and sewer district for the purpose of this section following
7 its abolition.

8
9 SECTION 3. Arkansas Code § 14-40-304 is repealed.

10 ~~14-40-304. Judicial review.~~

11 ~~(a) If it is alleged that the area proposed to be annexed does not~~
12 ~~conform to the requirements and standards prescribed in § 14-40-302, a legal~~
13 ~~action may be filed in the circuit court of the county where the lands lie,~~
14 ~~within thirty (30) days after the election, to nullify the election and to~~
15 ~~prohibit further proceedings pursuant to the election.~~

16 ~~(b) In any such action filed in the circuit court of the county where~~
17 ~~the lands lie, the court shall have jurisdiction and the authority to~~
18 ~~determine whether the procedures outlined in this subchapter have been~~
19 ~~complied with and whether the municipality has used the proper standards~~
20 ~~outlined in § 14-40-302 in determining the lands to be annexed.~~

21
22 SECTION 4. Arkansas Code Title 14, Chapter 40, Subchapter 3, is
23 amended to add additional sections to read as follows:

24 14-40-305. Procedure for annexation.

25 (a)(1) The governing body of a municipality desiring to annex
26 territory under this section first shall pass a resolution of consideration
27 identifying the area under consideration for annexation by either a metes and
28 bounds description or a map. The resolution of consideration shall remain
29 effective for two (2) years after adoption and be filed with the municipal
30 clerk.

31 (2) A new resolution of consideration adopted before expiration
32 of the two-year period for a previously adopted resolution covering the same
33 area shall relate back to the date of the previous resolution.

34 (3) Adoption of a resolution of consideration under this section
35 does not confer prior jurisdiction over the area as to any other
36 municipality.

1 (b)(1) A notice of the adoption of the resolution of consideration
2 shall be published one (1) time a week for two (2) successive weeks, with
3 each publication being on the same day of the week, in a newspaper having
4 general circulation in the municipality.

5 (2) The second notice shall be published no more than thirty
6 (30) days after adoption of the resolution of consideration.

7 (3) The resolution of consideration shall contain a map or
8 description of the area under consideration and a summary of the annexation
9 process and time lines.

10 (4) A copy of the resolution of consideration shall be mailed
11 within thirty (30) days after the adoption of the resolution of consideration
12 by first class mail to the owners of real property located within the area
13 under consideration for annexation as shown by the tax records of the county.

14 (5) If a proposed annexation extends across a county border into
15 a county other than the county where the majority of the area of the existing
16 municipality is located, a copy of the resolution of consideration shall be
17 mailed within thirty (30) days after the adoption of the resolution of
18 consideration by first class mail to the county clerk of that county.

19 (c)(1) At least one (1) year after adoption of the resolution of
20 consideration, the governing body of a municipality may adopt a resolution of
21 intent to proceed with the annexation of some or all of the area described in
22 the resolution of consideration.

23 (2) The resolution of intent shall:

24 (A) Describe the boundaries of the area proposed for
25 annexation;

26 (B) Fix a date for a public informational meeting;

27 (C) Fix a date for a public hearing on the question of
28 annexation; and

29 (D) Fix a date for the referendum on annexation.

30 (3) The date for the public informational meeting shall be not
31 less than forty-five (45) days and not more than fifty-five (55) days
32 following passage of the resolution of intent.

33 (4) The date for the public hearing shall be not less than one
34 hundred thirty (130) days and not more than one hundred fifty (150) days
35 following passage of the resolution of intent.

36 (5) The date of the referendum on annexation shall be set for

1 the next municipal general election that is more than forty-five (45) days
2 from the date of the resolution of intent.

3 (d) A combined notice of public informational meeting and public
4 hearing shall be issued under this section as follows:

5 (1) The notice shall be a combined notice that includes a
6 minimum of:

7 (A) The date, hour, and place of the public informational
8 meeting;

9 (B) The date, hour, and place of the public hearing;

10 (C) A clear description of the boundaries of the area
11 under consideration, including a legible map of the area;

12 (D) A statement that the report required by this
13 subchapter will be available at the office of the municipal clerk;

14 (E) An explanation of property owner's rights under this
15 section;

16 (F) A summary of the annexation process with time lines;

17 (G) A summary of the opportunity to vote in the
18 referendum, available statutory remedies appealing the annexation, and the
19 failure to provide services;

20 (H) Information on how to request water and sewer service,
21 all forms to request that service, and the consequences of opting in or
22 opting out, as provided in this subchapter; and

23 (I) A clear description of the distinction between the
24 public informational meeting and the public hearing.

25 (2)(A) The combined notice shall be given by publication of the
26 information required by this section and a statement regarding the
27 availability of the information required by this section in a newspaper
28 having general circulation in the municipality one (1) time a week for at
29 least two (2) successive weeks before the date of the public informational
30 meeting, with each publication being on the same day of the week.

31 (B)(i) The date of the last publication shall be not more
32 than ten (10) days preceding the date of the public informational meeting.

33 (ii) In addition, if the area proposed to be annexed
34 lies in a county containing less than fifty percent (50%) of the land area of
35 the municipality, the same publication shall be given in a newspaper having
36 general circulation in the area of proposed annexation.

1 (iii) If there is no such newspaper, the
2 municipality shall post the notice in at least five (5) public places within
3 the municipality and at least five (5) public places in the area to be
4 annexed for thirty (30) days before the date of public informational meeting.

5 (3)(A) The combined notice, together with the information about
6 requesting water and sewer service, shall be mailed within five (5) business
7 days of the passage of the resolution of intent by first class mail to the
8 owners of real property located within the area to be annexed as shown by the
9 tax records of the county.

10 (B) The person or persons mailing the notices shall
11 certify to the governing body of the municipality that fact, and the
12 certificate shall become a part of the public record of the annexation
13 proceeding and is conclusive in the absence of fraud.

14 (C) If a notice is returned to the municipality by the
15 postal service by the tenth day before the informational meeting, a copy of
16 the notice shall be sent by certified mail, return receipt requested, at
17 least seven (7) days before the informational meeting.

18 (D) Failure to comply with the mailing requirement of this
19 section does not invalidate the annexation unless it is shown that the
20 requirements were not substantially complied with by the municipality.

21 (4)(A) If the governing body of a municipality by resolution
22 finds that the tax records are not adequate to identify the property owners
23 within the area to be annexed after exercising reasonable efforts to locate
24 the property owners, in lieu of the mail procedure required by this section,
25 it may post the notice at least (thirty) 30 days before the date of the
26 public informational meeting on all buildings, on such parcels, and in at
27 least five (5) other places within the area to be annexed as to those parcels
28 where the property owner could not be identified.

29 (B) In any case where notices are placed on property, the
30 person placing the notice shall certify that fact to the governing body of a
31 municipality.

32 (e) At least thirty (30) days before the date of the public
33 informational meeting, the governing body of a municipality shall:

34 (1) Approve the report provided for in this subchapter;

35 (2) Prepare a summary of the approved report for public
36 distribution;

1 (3) Post in the office of the county clerk:

2 (A) The approved report provided for in this subchapter;

3 (B) The summary of the approved report;

4 (C) A legible map of the area to be annexed;

5 (D) The list of the property owners and associated mailing
6 addresses in the area to be annexed that the municipality has identified and
7 mailed notice; and

8 (E) Information for property owners on how to request
9 water service or sewer service and all forms to request that service;

10 (4) If the municipality has a website, post on that website all
11 of the information under this section together with any forms to apply for
12 water and sewer service; and

13 (5) Prepare a summary of the opportunity to vote in the
14 referendum and available statutory remedies for appealing the annexation for
15 public distribution.

16 (f)(1) At the public informational meeting, a representative of the
17 municipality shall make an explanation of the report required in this
18 subchapter and an explanation of the provision of major municipal services.

19 (2) The explanation of the services shall include how to request
20 water service or sewer service to individual lots, the average cost of a
21 residential connection to the water and sewer system, and the opportunity for
22 installation of a residential connection under this subchapter.

23 (3) The following shall be distributed at the public
24 informational meeting:

25 (A) A summary of the annexation process with time lines;

26 (B) A summary of opportunity to vote in the referendum;

27 (C) A summary of available statutory remedies for
28 appealing the annexation;

29 (D) An explanation of the provision of services; and

30 (E) Information for requesting water service or sewer
31 service to individual lots and any forms to so request.

32 (4) After the distribution of information under subdivision
33 (f)(3) of this section, all property owners and residents of the area
34 proposed to be annexed as described in the notice of public informational
35 meeting and hearing and all residents of the municipality shall be given the
36 opportunity to ask questions and receive answers regarding the proposed

1 annexation.

2 (g)(1) At the public hearing, a representative of the municipality
3 shall first make an explanation of the report required in this subchapter.

4 (2) After the explanation, all property owners and residents of
5 the area proposed to be annexed as described in the notice of public
6 informational meeting and hearing and all residents of the municipality shall
7 be given an opportunity to be heard.

8 (h)(1) The governing body of the municipality shall take into
9 consideration facts presented at the public hearing and shall have authority
10 to amend the report required by this subchapter to make changes in the plans
11 for serving the area proposed to be annexed so long as such changes meet the
12 requirements of this subchapter.

13 (2) At any regular or special meeting held no sooner than ten
14 (10) days after the certification of the election held under this subchapter,
15 the governing body of a municipality may adopt an ordinance, subject to this
16 section, extending the corporate limits of the municipality to include all or
17 part of the area described in the notice of public hearing which the
18 governing body of a municipality has concluded should be annexed. The
19 annexation ordinance shall:

20 (A) Contain specific findings showing that the area to be
21 annexed meets the requirements of this subchapter;

22 (B) Describe the external boundaries of the area to be
23 annexed by metes and bounds;

24 (C) Include a statement of the intent of the municipality
25 to provide services to the area being annexed as set forth in the report
26 required by this subchapter and a time line for the provision of those
27 services; and

28 (D)(i) Contain a specific finding that on the effective
29 date of annexation, the municipality will have funds appropriated in
30 sufficient amount to finance construction of any water and sewer lines stated
31 in the report required by this subchapter to extend the water and sewer
32 services into the area to be annexed, or that on the effective date of
33 annexation the municipality will have authority to issue bonds in an amount
34 sufficient to finance such construction.

35 (ii) If authority to issue the bonds is secured from
36 the electorate of the municipality prior to the effective date of annexation,

1 the effective date of annexation shall be no earlier than the day following
2 the statement of the successful result of the bond election.

3 (3) The governing body of a municipality shall set the effective
4 date for annexation as June 30 next following the adoption of the ordinance
5 or the second June 30 following adoption of the ordinance, but not before the
6 completion of the water and sewer request appeal periods are complete.

7 (4) The list of the property owners of parcels within the area
8 described in the annexation ordinance to which a notice was mailed under this
9 section shall be delivered within five (5) business days to the tax assessor
10 and the board of elections of the county in which a majority of the
11 municipality lies.

12 (5) If a public body has a website, conspicuously post notice of
13 the referendum until after the certification of the election.

14 (i) The procedures in this subchapter shall apply to any annexation
15 under this section. The municipality shall reimburse the county board of
16 election commissioners the costs of the referendum required under this
17 subchapter.

18 (j) From and after the effective date of the annexation ordinance, the
19 citizens and property in the annexed area shall be subject to all debts,
20 laws, ordinances, and regulations in force in the municipality and shall be
21 entitled to the same privileges and benefits as other parts of the
22 municipality.

23 (k) If a municipality is considering the annexation of two (2) or more
24 areas which are all adjacent to the municipal boundary but are not adjacent
25 to one another, it may undertake simultaneous proceedings under authority of
26 this section for the annexation of the areas.

27 (1)(1) If not earlier than thirty (30) days after the effective date
28 of annexation and not later than fifteen (15) months from the effective date
29 of annexation any property owner in the annexed territory contends that the
30 municipality has not followed through providing services under this
31 subchapter and this section, the property owner may apply for a writ of
32 mandamus.

33 (2) Relief may be granted by the judge of the circuit court if
34 the municipality has not provided the services under this subchapter on
35 substantially the same basis and in the same manner as the services were
36 provided within the rest of the municipality before the effective date of

1 annexation and those services are still being provided on substantially the
2 same basis and in the same manner within the original corporate limits of the
3 municipality.

4 (3) If a writ is issued, costs, including reasonable attorneys'
5 fees for the aggrieved property owner, shall be charged to the municipality.

6 (o) The municipality shall report to the circuit court of the county:

7 (1)(A) If police protection, fire protection, solid waste
8 services, and street maintenance services were provided under this
9 subchapter, within (thirty) 30 days after the effective date of the
10 annexation.

11 (B) The report shall be filed no more than thirty (30)
12 days following the expiration of the thirty-day period.

13 (C) If the circuit court determines that the municipality
14 failed to deliver police protection, fire protection, solid waste services,
15 or street maintenance services under this subchapter within thirty (30) days
16 after the effective date of the annexation, the circuit court shall notify
17 the municipality that the municipality may not count any of the residents as
18 part of the population of the municipality for the purpose of receiving any
19 state, federal, or county dollars distributed based on population until all
20 of the services are provided; and

21 (2)(A) If the extension of water and sewer lines was completed
22 under this subchapter, within six (6) months after the effective date of the
23 annexation ordinance and again within three and one-half (3 1/2) years of the
24 effective date of the annexation ordinance or upon the completion of the
25 installation, whichever occurs first.

26 (B) If the municipality failed to deliver either water or
27 sewer services, or both, under this subchapter within three and one-half (3
28 1/2) years after the effective date of the annexation, the municipality shall
29 stop any other annexations in progress and may not begin any other annexation
30 until the water and sewer services are provided.

31 (C) The municipality shall adopt a resolution of
32 consideration to begin again any annexation that is stopped under this
33 section.

34
35 14-40-306. Provision of water and sewer service.

36 (a)(1) The municipality shall provide water and sewer service to the

1 annexed area as required by plans for extension under this subchapter within
2 three and one-half (3 1/2) years of the effective date of the annexation
3 ordinance except as provided in this section if:

4 (A) The residents in the existing city boundaries are
5 served by a public water or sewer system or by a combination of a public
6 water or sewer system and one (1) or more nonprofit entities providing
7 service by contract with the public system;

8 (B) The annexing municipality does not provide that
9 service within the existing city boundaries;

10 (C) The area to be annexed is in an area served by the
11 public water or sewer system; and

12 (D) The municipality has no responsibility through an
13 agreement with the public water or sewer system to pay for the extension of
14 lines to areas annexed to the city, the city shall have no financial
15 responsibility for the extension of water and sewer lines under this section;

16 (2) As used in this section, "public water or sewer system"
17 means:

18 (A) A water or sewer authority;

19 (B) A water or sewerage district;

20 (C) A county water or sewer district;

21 (D) A sanitary district;

22 (E) A county-owned water or sewer system;

23 (F) A municipally owned water or sewer system;

24 (G) A water or sewer utility created by an act of the
25 General Assembly; or

26 (H) A joint agency providing a water or sewer system by
27 interlocal agreement.

28 (b) Prior to the adoption of the annexation ordinance, the
29 municipality shall offer to each eligible owner of real property located
30 within the area proposed to be annexed an opportunity to obtain water or
31 sewer service, or both, at no cost other than periodic user fees based upon
32 usage as follows:

33 (1)(A) After passage of the resolution of intent, the owner of
34 real property located within the area proposed to be annexed shall be
35 notified in writing under this subchapter within five (5) business days of
36 the passage of the resolution of intent of the opportunity to have water and

1 sewer lines and connections installed at no cost to the property owner.

2 (B) The notice shall state that a request for extending
3 water and sewer lines does not waive the right to contest the annexation.

4 (C) The owners of real property located within the area
5 proposed to be annexed shall be allowed sixty-five (65) days from the date of
6 the passage of the resolution of intent to respond yes or no to the
7 opportunity.

8 (D) Any property owner of a parcel that is an existing
9 customer of the municipality's water or sewer, whether provided by the
10 municipality or by a third party under contract with the municipality, shall
11 be deemed to respond yes to the opportunity, whether or not the property
12 owner returns the notification;

13 (2)(A) At the close of the sixty-five-day period, the
14 municipality shall determine if the eligible property owners of a majority of
15 the parcels to be annexed have responded favorably.

16 (B) A majority of the owners of a single parcel of real
17 property must respond favorably before the municipality may count that parcel
18 of real property as responding favorably;

19 (3) If the property owners of a majority of the parcels located
20 within the area proposed to be annexed respond favorably, the municipality
21 shall:

22 (A)(i) Provide water and sewer lines, service lines, and
23 connections at no cost other than periodic user fees to all real property
24 that an owner responded favorably if the annexation ordinance is adopted.

25 (ii) The right to receive water and sewer lines
26 shall run with the land; and

27 (B) Notify within five (5) days of the close of the sixty-
28 five-day period under this subsection those owners of real property located
29 within the area proposed to be annexed who failed to respond or responded
30 negatively that the property owners of a majority of the parcels located
31 within the area proposed to be annexed responded favorably and offer a second
32 opportunity for that property owner to respond favorably within thirty (30)
33 days; and

34 (4)(A) If the property owners of a majority of the parcels
35 located within the area proposed to be annexed fail to respond favorably to
36 the offer to obtain water and sewer services made under this section, the

1 municipality may nevertheless proceed with the annexation.

2 (B) If the municipality proceeds with the annexation when
3 the property owners of a majority of the parcels located within the area
4 proposed to be annexed fail to respond favorably to the offer to obtain water
5 and sewer services, the municipality is not required to provide water and
6 sewer services to any property owners in the area that is annexed.

7 (C) If the municipality does provide water and sewer
8 services, and if a property owner requests those services, the municipality
9 may charge the property owner for the connection to a residential lot under
10 this section during the first five (5) years following the effective date of
11 the annexation.

12 (D) After five (5) years, and only if connection is
13 requested by a property owner under this section, the municipality may charge
14 for the connection according to the municipality's policy.

15 (c)(1) The process required by this section shall be completed by the
16 municipality at least thirty (30) days prior to the public hearing.

17 (2) The report required by this subchapter shall include the
18 results of the process required by this section.

19 (d)(1) Any owner of real property located within the area described in
20 the annexation ordinance may apply to participate in the water and sewer
21 system after the completion of the process required by this section.

22 (2) The following costs of installation of water and sewer for a
23 residential lot may be charged to an owner of real property located within
24 the area described in the annexation ordinance who applies:

25 (A) Within the first year, an amount not to exceed fifty
26 percent (50%) of average cost of installation;

27 (B) Within the second year, an amount not to exceed sixty
28 percent (60%) of average cost of installation;

29 (C) Within the third year, an amount not to exceed seventy
30 percent (70%) of average cost of installation;

31 (D) Within the fourth year, an amount not to exceed eighty
32 percent (80%) of average cost of installation; and

33 (E) Within the fifth year, an amount not to exceed ninety
34 percent (90%) of average cost of installation;

35 (3) Charges under this section shall be made when the water and
36 sewer connection is operable.

1 (e)(1) The municipality may not charge for any reason any property
2 owner within the area described in the annexation ordinance for the
3 installation or use of the water or sewer system unless that property owner
4 is or has requested to become a customer of the water or sewer system.

5 (2)(A) The initial installation of water or sewer connection
6 lines to property shall be completed without charge to the property owner.

7 (B) Title to water or sewer connection lines shall vest in
8 the property owner following completion of the initial installation.

9 (C) The property owner shall be responsible for
10 maintenance and repair of water and sewer connection lines on the owner's
11 property following the initial installation.

12 (3) If the municipality is unable to provide water or sewer
13 service within three and one-half (3 1/2) years, as required by this section,
14 due to permitting delays that are caused through no fault of the
15 municipality, the municipality may petition the circuit court for a
16 reasonable time extension.

17 (f) As used in this section:

18 (1)(A) "At no cost other than periodic user fees" means the
19 municipality may not charge the property owner who responded favorably under
20 this section for any costs associated with the installation of the water or
21 sewer system.

22 (B) The municipality may not charge a property owner who
23 applies to participate in the water and sewer system under this section
24 before the first periodic user fee charge, and on that bill the owner may be
25 charged no more then as provided in this section; and

26 (2) "Average installation of a connection for a residential lot"
27 means the average of the cost for residential installations from curb to
28 residence, including connection and tap fees, in the area described in the
29 annexation ordinance.

30
31 14-40-307. Contract with rural fire department.

32 (a) If the area to be annexed described in a resolution of intent
33 passed under this subchapter includes an area in a rural fire protection
34 district or a fire service district, and a rural fire department was on the
35 date of adoption of the resolution of intent providing fire protection in the
36 area to be annexed, the municipality is required to make a good faith effort

1 to negotiate a five-year contract with the rural fire department to provide
2 fire protection in the area to be annexed, if the rural fire department makes
3 a written request for a good faith offer, and the request is signed by the
4 chief officer of the fire department and delivered to the city clerk no later
5 than fifteen (15) days before the public hearing.

6 (b) If the area is a rural fire protection district or a fire service
7 district, an offer to pay annually for the term of the contract the amount of
8 money that the tax rate in the district in effect on the date of adoption of
9 the resolution of intent would generate based on property values on January 1
10 of each year in the area to be annexed which is in such a district is deemed
11 to be a good faith offer of consideration for the contract.

12 (c) Any offer by a municipality to a rural fire department that would
13 compensate the rural fire department for revenue loss directly attributable
14 to the annexation by paying the amount annually for five (5) years is a good
15 faith offer of consideration for the contract.

16 (d) Under this section, if the good faith offer is for first responder
17 service, an offer of one-half (1/2) the calculated amount under this section
18 is deemed to be a good faith offer.

19 (e) This section does not obligate a municipality or rural fire
20 department to enter into any contract.

21 (f)(1) If it feels that no good faith offer has been made, the rural
22 fire department may appeal to the circuit court within thirty (30) days
23 following the passage of an annexation ordinance.

24 (2) The rural fire department may apply to the circuit court for
25 an order staying the operation of the annexation ordinance pending the
26 outcome of the review.

27 (3) The circuit court may grant or deny the stay in its
28 discretion upon such terms as it deems proper, and it may permit annexation
29 of any part of the area described in the ordinance concerning which no
30 question for review has been raised, provided that no other appeal under this
31 subchapter is pending.

32 (g) The circuit court may affirm the ordinance, or if the circuit
33 court finds that no good faith offer has been made, it shall remand the
34 ordinance to the governing body of the municipality for further proceedings,
35 and the ordinance shall then not become effective unless the circuit court
36 finds that a good faith offer has been made.

14-40-308. Assumption of debt.

(a) If the municipality has annexed any area which is served by a rural fire department, a rural fire protection district, or a fire service district, upon the effective date of annexation if the municipality has not contracted with the rural fire department for fire protection, or when the rural fire department ceases to provide fire protection under contract, the municipality shall pay annually a proportionate share of any payments due on any debt, including principal and interest, relating to facilities or equipment of the rural fire department if the debt was existing at the time of adoption of the resolution of intent, with the payments in the same proportion that the assessed valuation of the area of the district annexed bears to the assessed valuation of the entire district on the date the annexation ordinance becomes effective or another date for valuation mutually agreed upon by the municipality and the fire department.

(b) The municipality and rural fire department shall jointly present a payment schedule to the circuit court for approval and no payment may be made until the schedule is approved.

14-40-309. Contract with private solid waste collection firms.

(a) If the area to be annexed described in a resolution of intent passed under this subchapter includes an area that a private solid waste collection firm services and:

- (1) It meets the requirements of this section;
- (2) On the ninetieth day preceding the date of adoption of the resolution of intent or resolution of consideration was providing solid waste collection services in the area to be annexed;
- (3) On the date of adoption of the resolution of intent is still providing the services; and

(4) By reason of the annexation the firm's franchise with a county or arrangements with third parties for solid waste collection will be terminated, the municipality shall:

(A) Contract with the firm for a period of two (2) years after the effective date of the annexation ordinance to allow the firm to provide collection services to the municipality in the area to be annexed for sums determined under this section;

1 (B)(i) Pay the firm for the firm's economic loss, with
2 one-third (1/3) of the economic loss to be paid within thirty (30) days of
3 the termination and the balance paid in twelve (12) equal monthly
4 installments during the next succeeding twelve (12) months.

5 (ii) Any remaining economic loss payment is
6 forfeited if the firm terminates service to customers in the annexation area
7 prior to the effective date of the annexation; or

8 (C) Make other arrangements satisfactory to the parties.

9 (b) To qualify for the options set forth in this section, a firm shall
10 have:

11 (1) After receiving notice of the annexation under this section,
12 filed with the city clerk at least ten (10) days before the public hearing a
13 written request to contract with the municipality to provide solid waste
14 collection services containing a certification, signed by an officer or owner
15 of the firm, that the firm serves at least fifty (50) customers within the
16 county at that time; or

17 (2)(A) Contacted the city clerk under the public notice
18 published by the municipality under this subchapter at least ten (10) days
19 before the hearing and provided to the city clerk a written request to
20 contract with the municipality to provide solid waste collection services.

21 (B) The request shall contain a certification signed by an
22 officer or owner of the firm that the firm serves at least fifty (50)
23 customers within the county at that time.

24 (c) Firms shall file notice of provision of solid waste collection
25 service with the city clerk of the municipality of each municipality located
26 in the firm's collection area or within five (5) miles of the collection
27 area.

28 (d)(1) At least four (4) weeks before the date of the informational
29 meeting under subsection (c) of this section, the municipality shall provide
30 written notice of the resolution of intent to all firms serving the area to
31 be annexed.

32 (2) The notice shall be sent to all firms that filed notice
33 under this section by certified mail, return receipt requested, to the
34 address provided by the firm.

35 (e) The municipality may require that the contract contain:

36 (1) A requirement that the private solid waste collection firm

1 post a performance bond and maintain public liability insurance coverage;

2 (2) A requirement that the private solid waste collection firm
3 agree to service customers in the annexed area that were not served by that
4 firm on the effective date of annexation;

5 (3) A provision that divides the annexed area into service areas
6 if more than one (1) private solid waste collection firm is being contracted
7 within the area, such that the entire area is served by the firms, or by the
8 municipality to customers not served by the firms;

9 (4) A provision that the municipality may serve customers not
10 served by the firm on the effective date of annexation;

11 (5) A provision that the contract can be cancelled in writing,
12 delivered by certified mail to the firm in question with thirty (30) days to
13 cure substantial violations of the contract, but no contract may be cancelled
14 on these grounds unless the circuit court finds that substantial violations
15 have occurred, except that the municipality may suspend the contract for up
16 to thirty (30) days if it finds substantial violations of health laws;

17 (6) Performance standards not exceeding municipal standards
18 existing at the time of notice published under this subchapter with a
19 provision that the contract may be cancelled for substantial violations of
20 those standards, but no contract may be cancelled on those grounds unless the
21 circuit court finds that substantial violations have occurred; and

22 (7) A provision for monetary damages if there are violations of
23 the contract or of performance standards.

24 (f)(1) If the services to be provided to the municipality by reason of
25 the annexation are substantially the same as rendered under the franchise
26 with the county or arrangements with the parties, the amount paid by the
27 municipality shall be at least ninety percent (90%) of the amount paid or
28 required under the existing franchise or arrangements.

29 (2) If the services are required to be adjusted to conform to
30 municipal standards or as a result of changes in the number of customers and
31 as a result there are changes in disposal costs, including mileage and
32 landfill charges, requirements for storage capacity like dumpsters or
33 residential carts, or frequency of collection, the amount paid by the
34 municipality for the service shall be increased or decreased to reflect the
35 value of such adjusted services as if computed under the existing franchise
36 or arrangements.

1 (3) If agreement cannot be reached between the municipality and
2 the firm under this subsection, the matters shall be determined by the
3 circuit court.

4 (g)(1) If it contends that no contract has been offered, the firm may
5 appeal to the circuit court within thirty (30) days following passage of an
6 annexation ordinance.

7 (2) The firm may appeal to the circuit court for an order
8 staying the operation of the annexation ordinance pending the outcome of the
9 review.

10 (3) The circuit court may grant or deny the stay upon such terms
11 as it deems proper.

12 (4) If the circuit court finds that the municipality has not
13 made an offer that complies with this section, it shall remand the ordinance
14 to the governing body of the municipality for further proceedings, and the
15 ordinance shall not become effective until the circuit court finds that such
16 an offer has been made.

17 (h)(1) A firm that has given notice under this section that it desires
18 to contract, and any firm that the municipality believes is eligible to give
19 the notice, shall make available to the municipality not later than thirty
20 (30) days following a written request of the municipality, sent by certified
21 mail return receipt requested, all information in its possession or control,
22 including without limitation operational, financial, and budgetary
23 information, necessary for the municipality to determine if the firm
24 qualifies for the benefits of this section and to determine the nature and
25 scope of the potential contract or economic loss.

26 (2) The firm forfeits its rights under this section if it fails
27 to make a good faith response within thirty (30) days following receipt of
28 the written request for information from the municipality, provided that the
29 municipality's written request makes specific reference to this section.

30 (i) As used in this section:

31 (1) "Economic loss" means a sum equal to fifteen (15) times the
32 average gross monthly revenue for the three (3) months prior to the passage
33 of the resolution of intent or resolution of consideration, as applicable
34 under this section, collected or due the firm for residential, commercial,
35 and industrial collection service in the area annexed or to be annexed,
36 provided that revenues shall be included in calculations under this

1 subdivision only if policies of the city will provide solid waste collection
2 to those customers such that arrangements between the firm and the customers
3 will be terminated; and

4 (2) "Firm" means a private solid waste collection firm.

5
6 14-40-310. Appeal to circuit court.

7 (a) Within sixty (60) days following the adoption of the annexation
8 ordinance, any owner of real property located within the area described in
9 the annexation ordinance who believes that the property owner will suffer
10 material injury by reason of the failure of the governing body of the
11 municipality to comply with the procedure or to meet the requirements set
12 forth in this section as it applies to the annexation may file a petition in
13 the circuit court of the county in which the municipality is located seeking
14 review of the action of the governing body of the municipality.

15 (b)(1) The petition shall explicitly state what exceptions are taken
16 to the action of the governing body of the municipality and what relief the
17 petitioner seeks.

18 (2) Within ten (10) days after the petition is filed with the
19 court, the person seeking review shall serve copies of the petition by
20 registered mail, return receipt requested, upon the municipality.

21 (c) Within fifteen (15) days after receipt of the copy of the petition
22 for review or within such additional time as the court may allow, the

12 the area with an effective date no later than twenty-four (24) months after
13 the adoption of the ordinance.

14 (C) If the estimated annual debt service payment is
15 greater than or equal to five percent (5%) of the municipality's annual water
16 and sewer systems revenue for the most recent fiscal year, then the governing
17 body of the municipality may adopt a resolution declining to annex the area.

18 (D) If a resolution is adopted, the governing body of the
19 municipality shall immediately submit a request to the circuit court of the
20 county to certify that its estimate of the annual debt service payment is
21 reasonable based on established governmental accounting principles.

22 (2)(A) If the circuit court of the county certifies the
23 estimate, the municipality is not required to annex the area and no petition
24 to annex the area may be submitted under this section for thirty-six (36)
25 months following the certification.

26 (B) During the thirty-six month period, the municipality
27 shall make ongoing annual good faith efforts to secure Community Development
28 Block Grants or other grant funding for extending water and sewer service to
29 all parcels in the areas covered by the petition.

30 (C) If sufficient funding is secured so that the estimated
31 capital cost to the municipality for extending water and sewer service, less
32 the funds secured, would result in an annual debt service payment cost to the
33 municipality of less than five percent (5%) of the municipality's annual
34 water and sewer systems revenue for the most recent fiscal year, the
35 governing body of the municipality shall within thirty (30) days adopt an
36 annexation ordinance for the area with an effective date no later than

1 twenty-four (24) months after the adoption of the ordinance.

2 (3) If the circuit court of the county notifies the governing
3 body of the municipality that the estimates are not reasonable based on
4 established governmental accounting principles and that a reasonable estimate
5 of the annual debt service payment is less than five percent (5%) of the
6 municipality's annual water and sewer systems revenue for the most recent
7 fiscal year, the governing body of the municipality within thirty (30) days
8 of the notification shall adopt an annexation ordinance for the area with an
9 effective date no later than twenty-four (24) months after the adoption of
10 the ordinance.

11 (i) Municipal services shall be provided to an area annexed under this
12 section in accordance with this subchapter.

13 (j)(1) From and after the effective date of the annexation ordinance,
14 the annexed area and its citizens and property shall be subject to all debts,
15 laws, ordinances, and regulations in force in the municipality and shall be
16 entitled to the same privileges and benefits as other parts of the
17 municipality.

18 (2) Real and personal property in the newly annexed territory on
19 the January 1 immediately preceding the beginning of the fiscal year in which
20 the annexation becomes effective is subject to municipal taxes as provided in
21 this subchapter.

22 (3) If the effective date of annexation falls between June 1 and
23 June 30, and the effective date of the privilege license tax ordinance of the
24 annexing municipality is June 1, businesses in the area to be annexed shall
25 be liable for taxes imposed in the ordinance from and after the effective
26 date of annexation.

27 (k)(1) As used in this section, an area is "contiguous" if at the time
28 the petition is submitted the area either abuts directly on the municipal
29 boundary or is separated from the municipal boundary by the width of a street
30 or street right-of-way, a creek or river, or the right-of-way of a railroad
31 or other public service corporation, lands owned by the municipality or some
32 other political subdivision, or lands owned by the State of Arkansas.

33 (2) A connecting corridor consisting solely of a street or
34 street right-of-way may not be used to establish contiguity.

35 (3) In describing the area to be annexed in the annexation
36 ordinance, the governing body of the municipality may include within the

1 description any territory described in this section that separates the
2 municipal boundary from the area petitioning for annexation.

3 (1)(1) The governing body of the municipality may initiate annexation
4 of contiguous property owned by the municipality by adopting a resolution
5 stating its intent to annex the property in lieu of filing a petition.

6 (2) The resolution shall contain an adequate description of the
7 property, state that the property is contiguous to the municipal boundaries,
8 and fix a date for a public hearing on the question of annexation.

9 (3) Notice of the public hearing shall be published under this
10 section.

11 (4) The governing body of the municipality may hold the public
12 hearing and adopt the annexation ordinance under this section.

13 (m)(1) A governing body of a municipality that receives a petition for
14 annexation under this section may by ordinance require that the petitioners
15 file a signed statement declaring whether or not vested rights with respect
16 to the properties subject to the petition have been established under this
17 subchapter.

18 (2) If the statement declares that the rights have been
19 established, the municipality may require petitioners to provide proof of the
20 rights.

21 (3) A statement that declares no vested rights have been
22 established under this subchapter are binding on the landowner and any vested
23 right is terminated.

24 (n)(1) A municipality has no authority to adopt a resolution or
25 petition itself under this section for annexation of property it does not own
26 or have any legal interest in.

27 (2) For the purpose of this section, a municipality has no legal
28 interest in a state-maintained street unless it owns the underlying fee and
29 not just an easement.

30 (o)(1) Using the procedures under this section, the governing body of
31 a municipality may annex by ordinance any distressed area contiguous to its
32 boundaries upon presentation to the governing body of a municipality of a
33 petition signed by at least one (1) adult resident of at least two-thirds
34 (2/3) of the resident households located within such area.

35 (2) As used in this section, a "distressed area" is an area in
36 which at least fifty-one percent (51%) of the households in the area

1 petitioning to be annexed have incomes that are two hundred percent (200%) or
2 less than the most recently published United States Census Bureau poverty
3 thresholds.

4 (3) The municipality may require reasonable proof that the
5 petitioner in fact resides at the address indicated.

6 (p) The petition under this section shall be prepared in substantially
7 the following form:

11 1. We the undersigned residents of real property believe that the area
12 described in paragraph 2 below meets the requirements of law and respectfully
13 request that the area described in paragraph 2 below be annexed to the (City
14 or Town) of _____.

15 2. The area to be annexed is contiguous to the (City or Town) of
16 _____, and the boundaries of the territory are as follows:

17 (q)(1) For purposes of determining whether the percentage of
18 households in the area petitioning for annexation meets the poverty
19 thresholds under this section, the petitioners shall submit to the governing
20 body of the municipality any reasonable evidence that demonstrates the area
21 in fact meets the income requirements of this section.

22 (2) The evidence presented may include data from the most recent
23 federal decennial census, other official census documents, signed affidavits
24 by at least one (1) adult resident of the household attesting to the
25 household size and income level, or any other documentation verifying the
26 incomes for a majority of the households within the petitioning area.

27 (3) Petitioners may select to submit name, address, and social
28 security number to the city clerk, who shall in turn submit the information
29 to the Department of Finance and Administration.

30 (4) The information shall be kept confidential and is not a
31 public record under the Freedom of Information Act of 1967, § 25-19-101 et
32 seq.

33 (5) The department shall provide the municipality with a summary
34 report of income for households in the petitioning area.

35 (6) Information for the report shall be gathered from income tax
36 returns, but the report submitted to the municipality shall not identify

1 individuals or households.
