10 AN ACT TO AUTHORIZE THE ARKANSAS MEDICAID PROGRAM TO
11 RECOGNIZE AN ADVANCED PRACTICE REGISTERED NURSE AS A
12 PRIMARY CARE PROVIDER; AND FOR OTHER PURPOSES.

22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

24 SECTION 1. Arkansas Code Title 20, Chapter 77, Subchapter 1, is
25 amended to add an additional section to read as follows:

26 20-77-135. Primary care provider for Arkansas Medicaid Program –
27 Advanced practice registered nurse.

28 (a)(1) The Arkansas Medicaid Program shall recognize an advanced
29 practice registered nurse licensed by the Arkansas State Board of Nursing for
30 all purposes as a primary care provider authorized to carry out the duties of
31 a primary care physician and a primary care case manager.

32 (2) Purposes under subdivision (a)(1) of this section include
33 without limitation:

34 (A) Being recognized as the initial healthcare provider in
35 the federal Comprehensive Primary Care Initiative payment model;

36 (B) Performing initial diagnosis;

- 1 (C) Acting as the team leader of family practice
2 professionals and the patient-centered medical home;
- 3 (D) Maintaining the medical records of a patient;
- 4 (E) Ordering laboratory tests and records management as
5 needed for patient care;
- 6 (F) Providing preventive and periodic examinations within
7 primary care;
- 8 (G) Referring a patient to a physician, a specialist, or a
9 hospital when necessary; and
- 10 (H) Treating a patient within the scope of practice and
11 licensure of an advanced practice registered nurse.
- 12 (b) The program shall reimburse an advanced practice registered nurse:
13 (1) Not less than the current reimbursement rate for services
14 performed within the scope of practice and licensure of the advanced practice
15 registered nurse;
16 (2) One hundred percent (100%) of the physician reimbursement
17 rate for all out-of-pocket costs incurred by the advanced practice registered
18 nurse such as the costs of laboratory tests, x-rays, and any additional tests
19 ordered or conducted by the advanced practice registered nurse; and
20 (3)(A) For any other costs and services performed within the
21 scope of practice and licensure of the advanced practice registered nurse.
22 (B) The scope of practice and licensure of the advanced
23 practice registered nurse shall be determined by the board.
- 24 (c) A healthcare insurance policy in which the premiums are paid
25 directly or indirectly by the program also shall recognize and reimburse an
26 advanced practice registered nurse under subsections (a) and (b) of this
27 section.
- 28 (d) This section does not increase the scope of practice or licensure
29 of an advanced practice registered nurse.
