21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

23 SECTION 1. Arkansas Code 7-9-105(a) is amended to read as follows:

24 (a) The petition and order of referendum shall be ~~substantially in the~~  
25 ~~following form~~ on forms provided by the Secretary of State and shall read as
