22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

24 SECTION 1. Arkansas Code § 14-48-109(a)(2)(B)(i), concerning the date  
25 of primary elections, is amended to read as follows:

26 (B)(i) The primary elections, other than the initial  
27 primary, for those nominations for offices to be filled at the municipal  
28 general election shall be held on the ~~fourth~~ second Tuesday of August  
29 preceding the municipal general election.  
30

31 SECTION 2. Arkansas Code § 14-48-109(a)(3) and (4), concerning the  
32 statement of candidacy, is amended to read as follows:

33 (3) Any person desiring to become a candidate for mayor or  
34 director shall file with the city clerk ~~not less than sixty (60) days not~~  
35 less than forty (40) days nor more than sixty (60) days prior to the primary



1 election by twelve o'clock noon a statement of his candidacy in substantially

before the election by twelve o'clock noon;
