21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
22

23 SECTION 1. Arkansas Code § 10-3-2302 is amended to read as follows:
24 10-3-2302. Creation.

25 (a) There is created the Arkansas Legislative Task Force on Abused and
26 Neglected Children.

27 (b) The task force shall consist of the following members:

28 (1) The Governor or the Governor's designee;

29 (2) The Chair of the House Interim Committee on Public Health,
30 Welfare, and Labor or the chair's designee;

31 (3) The Chair of the Senate Interim Committee on Public Health,
32 Welfare, and Labor or the chair's designee;

33 (4) The Chair of the Senate Interim Committee on Children and
34 Youth or the chair's designee;

35 (5) The Chair of the House Committee on Aging, Children and



1 Youth, Legislative and Military Affairs or the chair's designee;

2 (6) The Director of the Division of Children and Family Services
3 of the Department of Health and Human Services or the director's designee;

4 (7) The Director of the Division of Mental Health Services of
5 the Department of Health and Human Services or the director's designee;

6 (8) The Director of the Division of Youth Services of the
7 Department of Health and Human Services or the director's designee;

8 (9) The Director of the Division of Child Care and Early
9 Childhood Education of the Department of Health and Human Services or the
10 director's designee;

11 (10) The Director of the Administrative Office of the Courts or
12 the director's designee;

13 (11) The Chair of the Arkansas Coalition for Juvenile Justice or
14 the chair's designee;

15 (12) A sheriff to be appointed by the President of the Arkansas
16 Sheriffs' Association;

17 (13) The Director of the Department of Arkansas State Police or
18 the director's designee;

19 (14) The Chair of the State Child Abuse and Neglect Prevention
20 Board or the chair's designee;

21 (15) One (1) member of the Arkansas Child Abuse/Rape/Domestic
22 Violence Commission to be appointed by the Chancellor of the University of
23 Arkansas for Medical Sciences;

24 (16) A public defender who regularly appears in the juvenile
25 division of a circuit court in the State of Arkansas to be appointed by the
26 Director of the Arkansas Public Defender Commission;

27 (17) A prosecutor who regularly appears in the juvenile division
28 of a circuit court in the State of Arkansas to be appointed by the Prosecutor
29 Coordinator;

30 (18) An attorney ad litem to be appointed by the Director of the
31 Administrative Office of the Courts;

32 (19) A physician with special knowledge and experience in the
33 treatment of children who have been abused or neglected;

34 (20) The Chief of Staff of Arkansas Children's Hospital or his
35 or her designee;

36 (21) Two (2) members to be appointed by the President Pro

1 Tempore of the Senate with specialized knowledge, skills, or experience in
2 the area of child welfare or the prevention of child abuse and neglect;

3 (22) Two (2) members to be appointed by the Speaker of the House
4 of Representatives with specialized knowledge, skills, or experience in the
5 area of child welfare or the prevention of child abuse and neglect;

6 ~~(23) The Code Revisor of the Bureau of Legislative Research or~~
7 ~~the revisor's designee; and~~

8 ~~(24) The Director of the Bureau of Legislative Research or the~~
9 ~~director's designee.~~

10 (23) Four (4) members to be appointed by the Governor;

11 (24) Chief Counsel of the Department of Health and Human
12 Services or his or her designee; and

13 (25) A representative or employee of a child advocacy center in
14 the state.

15 (c)(1) The Chair of the Senate Interim Committee on Children and Youth
16 or the chair's designee shall call the first meeting within ~~thirty (30)~~
17 ninety (90) days of August 12, 2005 the adjournment of the regular session of
18 the General Assembly and shall serve as chair at the first meeting.

19 (2) At the first meeting, the members of the task force shall
20 elect from its membership a chair and other officers as needed for the
21 transaction of its business.

22 (3)(A) The task force shall conduct its meetings in Pulaski
23 *County at the State Capitol.*

24 (B) Meetings shall be held at least one (1) time every
25 three (3) months, but may occur more often at the call of the chair.

26 (d) If any vacancy occurs on the task force, the vacancy shall be
27 filled by the same process as the original appointment.

28 (e) The task force shall establish rules and procedures for conducting
29 its business.

30 (f)(1) ~~Members~~ Nonlegislator members of the task force shall serve
31 ~~without compensation, but may receive expense reimbursement according to §~~
32 ~~25-16-902.~~

33 (2) Legislator members shall be entitled to reimbursement for
34 per diem and mileage at the same rate and from the same source as provided by
35 law for members of the General Assembly attending meetings of interim
36 committees.
