13 AN ACT TO AMEND THE ARKANSAS REVENUE
14 STABILIZATION LAW OF ARKANSAS.

17 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
18

19 SECTION 1. Arkansas Code § 19-5-303 concerning the creation of
20 Institutions of higher education funds, is amended to add the following
21 subsections:

22 (gg)(1) Ozarka College Fund. There is established on the books of the
23 Treasurer of State, the Auditor of State, and the Chief Fiscal Officer of the
24 State a fund to be known as the "Ozarka College Fund".

25 (2) The Ozarka College Fund shall be used for the maintenance,
26 operation, and improvement of Ozarka College.

27 (3) The Ozarka College Fund shall consist of:

28 (A) Those general revenues as may be provided by law; and

29 (B) Any other funds made available for the support of Ozarka
30 College which are required to be deposited into the State Treasury by law.

31 (hh)(1) Southeast Arkansas College Fund. There is established on the
32 books of the Treasurer of State, the Auditor of State, and the Chief Fiscal
33 Officer of the State a fund to be known as the "Southeast Arkansas College
34 Fund".

35 (2) The Southeast Arkansas College Fund shall be used for the
36 maintenance, operation, and improvement of the Southeast Arkansas College.



1 (3) The Southeast Arkansas College Fund shall consist of:

2 (A) Those general revenues as may be provided by law; and

3 (B) Any other funds made available for the support of the
 4 Southeast Arkansas College which are required to be deposited into the State
 5 Treasury by law.

6 (ii)(1) College of The Ouachitas Fund. There is established on the
 7 books of the Treasurer of State, the Auditor of State, and the Chief Fiscal
 8 Officer of the State a fund to be known as the "College of The Ouachitas
 9 Fund".

10 (2) The College of The Ouachitas Fund shall be used for the
 11 maintenance, operation, and improvement of the College of The Ouachitas.

12 (3) The College of The Ouachitas Fund shall consist of:

13 (A) Those general revenues as may be provided by law; and

14 (B) Any other funds made available for the support of the
 15 College of The Ouachitas which are required to be deposited into the State
 16 Treasury by law.

17
 18 SECTION 2. Arkansas Code § 19-5-311 concerning the creation of
 19 Technical college funds, is amended to read as follows:
 20 19-5-311. Technical college funds created.

21 (a)(1) There is established on the books of the Treasurer of State, the
 22 Auditor of State, and the Chief Fiscal Officer of the State a fund to be
 23 known as the "Black River Technical College Fund", there to be used for the
 24 maintenance, operation, and improvement of the Black River Technical College.

25 (2) The Black River Technical College Fund shall consist of:

26 (A) Those general revenues as may be provided by law; and

27 (B) Any other funds made available for the support of the Black
 28 River Technical College which are required to be deposited into the State
 29 Treasury by law.

30 ~~(b)(1) There is established on the books of the Treasurer of State, the~~
 31 ~~Auditor of State, and the Chief Fiscal Officer of the State a fund to be~~
 32 ~~known as the "Ozarka College Fund", there to be used for the maintenance,~~

 23 ~~known as the “Ouachita Technical College Fund”, there to be used for the~~

 31 SECTION 3. Arkansas Code § 19-5-1103(b) concerning the Property Tax
 32 Relief Trust Fund, is amended to read as follows:

33 (b) The fund shall consist of such revenues as generated by §§ 26-52-
 34 302(c), 26-52-317(c)(1)(B), 26-52-319(a)(3)(B), 26-53-107(c), 26-53-
 35 145(c)(1)(B), 26-53-148(a)(3)(B), 26-56-201(g)(1)(C) and 26-56-224(c)(2), and
 36 shall be used for such purposes as set out in § 26-26-310.

SECTION 4. Arkansas Code § 19-5-1227(b)(3) concerning the Educational Adequacy Fund, is amended to read as follows:

(3) The revenues generated by §§ 26-52-302(d), 26-52-316, 26-52-317(c)(1)(C), 26-52-319(a)(3)(C), 26-53-107(d), 26-53-145(c)(1)(C), 26-53-148(a)(3)(C), 26-56-201(g)(1)(B), 26-56-224(c)(3), and 26-57-1002(d)(1)(A)(ii); and

SECTION 5. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. Any funds appropriated by the Eighty-Eighth General Assembly from the Ouachita Technical College Fund shall be deemed payable from the College of The Ouachitas Fund.

SECTION 6. Arkansas Code 19-5-401 is amended to read as follows:

19-5-401. Allocations for fiscal year 2012-2013 and thereafter. Commencing with the fiscal year beginning July 1, 2012, and each fiscal year thereafter, the Treasurer of State shall transfer all remaining general revenues available for distribution on the last day of business in July 2012, and on the last day of business in each calendar month thereafter during the fiscal year to the various funds and fund accounts participating in general revenues in the proportions of the maximum allocation as the individual allocation to the fund or fund account bears to the total of the maximum allocation as provided in § 19-5-402 (a).

SECTION 7. Arkansas Code 19-5-402 is amended to read as follows:

19-5-402. Maximum allocations of revenues for fiscal year 2012-2013 and thereafter.

(a) The Treasurer of State shall first make monthly allocations in the proportions set out in this subsection to the funds and fund accounts listed below until there has been transferred a total of four billion seven hundred twenty-seven million five hundred thousand dollars (\$4,727,500,000) or so much thereof as may become available; provided, that the Treasurer of State shall make such monthly allocations in accordance with each fund or fund account's proportionate part of the total of all such allocations set forth in this subsection:

16 SECTION 8. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED
 17 SEPARATELY AS SPECIAL, LOCAL OR TEMPORARY LAW. FUND TRANSFER. Immediately
 18 upon the effective date of this Act, and notwithstanding the provisions of
 19 A.C.A. 18-28-213 (c)(2) regarding the transfer of funds from the Unclaimed
 20 Property Proceeds Trust Fund to the general revenues of the state, the
 21 Auditor of State shall transfer on his or her books and those of the State
 22 Treasurer and the Chief Fiscal Officer of State the sum of one million five
 23 hundred thousand dollars (\$1,500,000) from the Unclaimed Property Proceeds
 24 Trust Fund to the Mid-South Community College Fund to be expensed from the
 25 Arkansas Delta Training and Education Consortium, the Arkansas Delta Training
 26 and Education Consortium Partners, and the University Center Partners
 27 appropriations.

28

29 SECTION 9. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED
 30 SEPARATELY AS SPECIAL, LOCAL OR TEMPORARY LAW. FUND TRANSFER. Immediately
 31 upon the effective date of this Act, and notwithstanding the provisions of
 32 A.C.A. 18-28-213 (c)(2) regarding the transfer of funds from the Unclaimed
 33 Property Proceeds Trust Fund to the general revenues of the state, the
 34 Auditor of State shall transfer on his or her books and those of the State
 35 Treasurer and the Chief Fiscal Officer of State the sum of one million
 36 dollars (\$1,000,000) from the Unclaimed Property Proceeds Trust Fund to the

1 Higher Education Grants Fund Account to provide additional funding for
2 scholarships.

3

4 SECTION 10. EFFECTIVE DATE. This act is effective on and after July 1,
5 2012.
