18 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

20 *SECTION 1. Arkansas Code § 20-22-803 is amended to read as follows:*

21 *20-22-803. Arkansas Fire Protection Services Board – Creation,*

22 *~~membership, etc.~~ -- Membership.*

23 *(a)(1) There is created the Arkansas Fire Protection Services Board.*

24 *(2) The board shall be composed of fifteen (15) members to be*
25 *appointed by the Governor as follows:*

26 *(A)(i) ~~Two (2)~~ Four (4) members shall be fire chiefs*

27 *recommended by the Arkansas Association of Fire Chiefs.*

28 *(ii) Two (2) of the fire chiefs under this*

29 *subdivision (A) shall be full paid fire chiefs, one (1) shall be a volunteer*

30 *fire chief, and one (1) shall be a retired fire chief or a volunteer fire*

31 *chief;*

32 *(B) ~~Four (4)~~ Two (2) members shall be recommended by the*

33 *Arkansas Rural and Volunteer Firefighters Association;*

34 *(C) Four (4) members recommended by the Arkansas State*

35 *Firefighters Association, ~~two (2) of which~~ all of whom of which shall be*

36 *volunteer firefighters ~~and two (2) of which shall be career firefighters;~~*



1 (D) ~~Two (2)~~ Four (4) members shall be recommended by the
2 Arkansas Professional ~~Firefighters~~ Fire Fighters Association; and

3 (E) ~~One (1) member shall be in a retired status and shall~~
4 ~~be recommended by the board;~~

5 ~~(F) The Director of the Arkansas Department of Emergency~~
6 ~~Management Forestry Commission or his or her designee; and~~

7 ~~(G) The Director of the Arkansas Fire Training Academy.~~

8 (3) ~~A representative~~ The Director of the Arkansas ~~Forestry~~
9 ~~Commission~~ Fire Training Academy, the Director of the Arkansas Department of
10 Emergency Management or his or her designee, and the State Fire Marshal or
11 his or her designee shall be an ex officio member members.

12 ~~(4)(A) The initial members appointed under subdivision (a)(2) of~~
13 ~~this section shall determine their terms of office by drawing lots which~~
14 ~~result in four (4) members serving one-year terms, four (4) members serving~~
15 ~~two-year terms, and five (5) members serving three-year terms.~~

16 ~~(B) Successor appointed members~~ Members shall serve three-
17 year terms.

18 (5) Each member shall hold office until his or her successor is
19 appointed and qualified.

20 (6) Each recommending organization shall submit a minimum of
21 three (3) names for consideration for appointment by the Governor for each
22 position vacancy on the board.

23 (b)(1) The board shall elect annually a chair, vice chair, and
24 secretary.

25 (2) The board shall meet at the call of the chair or a majority
26 of the members.

27 (3) A majority of the members ~~shall constitute~~ constitutes a
28 quorum.

29 (c) The Governor shall fill vacancies occurring on the board with
30 appointments for the duration of the unexpired terms.

31 (d) The members shall serve without pay but may receive expense
32 reimbursement in accordance with § 25-16-901 et seq.

33
34 SECTION 2. DO NOT CODIFY. Members whose positions are eliminated
35 under this act shall be determined at the discretion of the Arkansas Fire
36 Protection Services Board.
