## Subtitle

15 TO AMEND VARIOUS PROVISIONS OF THE  
16 ARKANSAS CODE CONCERNING PUBLIC SCHOOL  
17 FUNDING AMOUNTS; AND TO DECLARE AN  
18 EMERGENCY.

21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
22

23 SECTION 1. Arkansas Code § 6-20-2305(a)(2), concerning per-student  
24 foundation funding amounts, is amended to read as follows:

25 (2)(A) For the ~~2015-2016~~ 2017-2018 school year, the foundation  
26 funding amount is equal to ~~six thousand five hundred eighty-four dollars~~  
27 ~~(\$6,584)~~ six thousand seven hundred thirteen dollars (\$6,713) multiplied by  
28 the school district's average daily membership for the previous school year.

29 (B) For the ~~2016-2017~~ 2018-2019 school year and each  
30 school year thereafter, the foundation funding amount is equal to ~~six~~  
31 ~~thousand six hundred forty-six dollars (\$6,646)~~ six thousand seven hundred  
32 eighty-one dollars (\$6,781) multiplied by the school district's average daily  
33 membership for the previous school year.

35 SECTION 2. Arkansas Code § 6-20-2305(b)(2)(A)(i) and (ii), concerning  
36 per-student categorical funding amounts for alternative learning



1 environments, are amended to read as follows:

2 (2)(A)~~(i)~~ For the ~~2015-2016~~ each school year, alternative  
 3 learning environment funding shall be ~~four thousand four hundred seventy-one~~  
 4 ~~dollars (\$4,471)~~ four thousand six hundred forty dollars (\$4,640) multiplied  
 5 by the number of identified alternative learning environment students  
 6 enrolled during the previous school year.

7 ~~(ii) For the 2016-2017 school year and each school~~  
 8 ~~year thereafter, alternative learning environment funding shall be four~~  
 9 ~~thousand five hundred sixty dollars (\$4,560) multiplied by the number of~~  
 10 ~~identified alternative learning environment students enrolled during the~~

 13 SECTION 3. Arkansas Code § 6-20-2305(b)(3)(A) and (B), concerning per-  
 14 student state categorical funding amounts for English-language learners, are  
 15 amended to read as follows:

16 (3)~~(A)~~ For the ~~2015-2016~~ each school year, funding for students  
 17 who are identified as English-language learners shall be ~~three hundred~~  
 18 ~~twenty-four dollars (\$324)~~ three hundred thirty-eight dollars (\$338) for each  
 19 identified English-language learner.

20 ~~(B) For the 2016-2017 school year and each school year~~  
 21 ~~thereafter, funding for students who are identified as English language~~  
 22 ~~learners shall be three hundred thirty-one dollars (\$331) for each identified~~  
 23 ~~English language learner.~~

 25 SECTION 4. Arkansas Code § 6-20-2305(b)(4)(A)(i)-(iii), concerning  
 26 per-student state categorical funding amounts for national school lunch  
 27 students, are amended to read as follows:

28 (4)(A) National school lunch state categorical funding for each  
 29 identified national school lunch student shall be as follows:

30 (i) For a school district in which ninety percent  
 31 (90%) or greater of the previous school year's enrolled students are national  
 32 school lunch students, the amount of per-student national school lunch state  
 33 categorical funding is+

36 ~~(b) For the 2016-2017~~ for each school year,

8 ~~(b) For the 2016-2017 for each~~ school year,  
 9 one thousand fifty-one dollars (\$1,051); and

10 (iii) For a school districts district in which less  
 11 than seventy percent (70%) of the previous school year's enrolled students  
 12 are national school lunch students, the amount of per-student national school  
 13 lunch state categorical funding is+

14 ~~(a) For the 2015-2016 school year, five~~  
 15 ~~hundred twenty two dollars (\$522); and~~

16 ~~(b) For the 2016-2017 for each~~ school year,  
 17 five hundred twenty-six dollars (\$526).

 19 SECTION 5. Arkansas Code § 6-20-2305(b)(5)(A), concerning per-student  
 20 state categorical funding amounts for professional development is amended to  
 21 read as follows:

22 (5)(A) For ~~the 2015-2016 and 2016-2017~~ each school ~~years~~ year,  
 23 professional development funding shall be equal to an amount of up to thirty-  
 24 two dollars and forty cents (\$32.40) multiplied by the school district's  
 25 previous school year average daily membership.

26  
 27 SECTION 6. Arkansas Code Title 6, Chapter 20, Subchapter 23, is  
 28 amended to add an additional section to read as follows:

29 6-20-2309. Enhanced transportation funding.

30 For the 2017-2018 school year and the 2018-2019 school year, in  
 31 addition to the foundation funding provided to a school district under § 6-  
 32 20-2305(a)(2), the Department of Education shall distribute enhanced  
 33 transportation funding to school districts each school year in the following  
 34 amounts:

2           SECTION 7. EMERGENCY CLAUSE. It is found and determined by the  
3 General Assembly of the State of Arkansas that funding for public schools is  
4 the obligation of the state; that ensuring that adequate funding is provided  
5 is the duty of the General Assembly; and that this act is immediately  
6 necessary to ensure that funding is provided for the 2017-2018 and 2018-2019  
7 school years so that school districts can budget accordingly. Therefore, an  
8 emergency is declared to exist, and this act being immediately necessary for  
9 the preservation of the public peace, health, and safety shall become  
10 effective on:

- 11           (1) The date of its approval by the Governor;  
12           (2) If the bill is neither approved nor vetoed by the Governor,

1 the expiration of the period of time during which the Governor may veto the  
2 bill; or

3 (3) If the bill is vetoed by the Governor and the veto is  
4 overridden, the date the last house overrides the veto.
