## For An Act To Be Entitled

9 AN ACT TO AMEND THE DEFINITION OF "REBATES" AS USED  
10 IN THE BUSINESS OF INSURANCE; TO MODIFY THE MINIMUM  
11 THRESHOLD VALUE OF TOKEN GIFTS IN THE BUSINESS OF  
12 INSURANCE; AND FOR OTHER PURPOSES.

## Subtitle

15 TO AMEND THE DEFINITION OF "REBATES" AS  
16 USED IN THE BUSINESS OF INSURANCE; AND TO  
17 MODIFY THE MINIMUM THRESHOLD VALUE OF  
18 TOKEN GIFTS IN THE BUSINESS OF INSURANCE.

22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
23

24 SECTION 1. Arkansas Code § 23-66-206(9), concerning the definition of  
25 "rebates" used in the business of insurance, is amended to add an additional  
26 subdivision to read as follows:

27 (C) Token gifts of one hundred dollars (\$100) or less in  
28 wholesale value that are used for advertisement purposes are not prohibited  
29 under this subdivision (9), including without limitation pens, calendars,  
30 notebooks, and other items;

32 SECTION 2. Arkansas Code § 23-66-308(c), concerning the applicability  
33 of the prohibition on rebates, discounts, or abatelements, is amended to read  
34 as follows:

35 (c) This section shall not be construed as prohibiting:

36 (1) The payment of commissions or other compensation to licensed



1 agents, brokers, or solicitors;

2 (2) An insurer from allowing or returning to its participating  
3 policyholders, members, or subscribers any dividends, savings, or unabsorbed  
4 premium deposits; ~~or~~

5 (3) A licensed insurance consultant who is also a licensed  
6 producer from adjusting or refunding to his or her clients any part of a  
7 consulting fee under a prior written agreement with a client paying total  
8 annual premiums, for all lines of business, of one hundred thousand dollars  
9 (\$100,000) or more based on commissions received by the consultant from  
10 insurers; or

11 (4) Token gifts of one hundred dollars (\$100) or less in  
12 wholesale value that are used for advertisement purposes, including without  
13 limitation pens, calendars, notebooks, and other items.
