

SENATE AMENDMENT 1 TO HB1038.

by adding the following new Section on line 22 of page 45

"SECTION 254. Arkansas Code 25-16-903 is amended to read as follows:

'25-16-903. Stipend - Authorization for \$50.

Each of the following state boards may, by a majority vote of the total membership of the board cast during its first regularly scheduled meeting of each calendar year, authorize payment to its members of a stipend not to exceed fifty dollars (\$50.00) per meeting attended, and the board members shall receive no other compensation, expense reimbursement, or in-lieu-of payments except as provided in § 25-16-902:
