

HOUSE AMENDMENT 2 TO HB1349.

deleting lines 24 through 28 on page 5 and substituting the following:

"(b) (1) Upon agreement between the county assessor and county collector, either the assessor or collector shall issue an annual personal property tax certificate for each vehicle subject to registration. If the county assessor and county collector do not reach an agreement as to which official shall be responsible for issuing the annual personal property tax certificates, then the Quorum Court shall designate either the county assessor or county collector as responsible for such issuance."

AND

by deleting "Assessment Coordination" on line 11 of page 6 and substituting "Tax"

AND

by deleting line 13 on page 6 and substituting the following:

"Registration Plan, nor shall the provisions of this Section apply to vehicles owned by public schools or political subdivisions of this state which are not subject to assessment and payment of personal property taxes."

AND

by deleting lines 24 through 36 on page 6, and lines 1 through 5 on page 7 and substituting the following:

"(5) Annual personal property tax certificates shall be designed by the Director and provided free of charge to the county tax assessors or collectors for issuance. The annual personal property tax certificate shall be in the form of a decal which can be displayed on the vehicle, as specified herein.

(6) The county assessors and collectors shall maintain such records as they deem appropriate to identify the taxpayer to which a certificate was issued.

(7) The annual personal property tax certificate shall be displayed on the vehicle as required by regulations adopted by the Director. A copy of the annual personal property tax assessment showing the vehicle listed thereon, with certification from the county collector that no delinquent personal property taxes are owed, shall be maintained in the vehicle operation."

AND

by deleting "mandatory" on line 23 of page 7,

AND

by deleting "mandatory" on line 30 of page 7,

AND

by deleting lines 6 through 20 on page 9 and substituting the following:

"(a) (1) Upon request from any county assessor or collector, the Director of the Department of Finance and Administration shall annually prepare and file with each deliver to such county assessor or collector a list containing the names and addresses of all persons or business institutions vehicle owners securing automobile, truck, trailer, motorcycle, and other motor vehicle licenses in the county assessor's or collector's county for the time period specified in the request. in their respective counties. The list shall include the make, the style, the vehicle identification number, the and year model of the automobile or truck and the license number assigned.

(2) Upon notification from any county assessor or collector to the Director that a vehicle owner has secured a vehicle license for a vehicle that has not been assessed, or for which delinquent personal property taxes are owed, the Director shall notify the vehicle owner that the vehicle license has been suspended and will remain suspended until the vehicle owner presents satisfactory evidence to the Director that the vehicle has been assessed and any delinquent personal property taxes have been paid."

AND

by deleting line 30 on page 18 and substituting the following:

"(a) No person shall drive or move any vehicle subject to registration on any"

AND

by adding two new subsections to Section 10 at line 4 on page 19 to read as follows:

"(b) The director, uniformed officers, troopers, and other employees of the Department of Arkansas State Police, and any other peace officer as the director may designate may, upon reasonable cause to believe that a motor nd submit the vehicle to an

inspection and such test as may be appropriate.

(c) In the event the use of a vehicle would endanger the public, the officer shall either require the vehicle to be parked at the owner's expense and not operated until it is made safe, or impound the vehicle if the officer determines that impoundment is necessary to protect the public. The owner shall pay any storage and impoundment fees before the vehicle will be released."

AND

by deleting line 12 on page 19 and substituting the following:

"(a) Notwithstanding any provisions of this Act to the contrary, commercial motor vehicles and vehicles transporting passengers, which vehicles are required by federal law or regulation or state law or regulation to be inspected, shall be inspected in accordance with such laws or regulations.

(b) The owner of a vehicle not required to be inspected under any provision set forth in paragraph (a) of this section which requires a commercial driver license"

AND

by deleting "(b)" at the beginning of line 25 on page 19 and substituting "(c)"

AND

by deleting "(c)" at the beginning of line 30 on page 19 and substituting "(d)"

AND

by deleting "(d)" at the beginning of line 35 on page 19 and substituting "(e)"

AND

by deleting "(e)" at the beginning of line 4 on page 20 and substituting "(f)"

AND

by deleting line 2 on page 22 and substituting the following:

"of a vehicle registration, except a vehicle registration issued or renewed under the provisions of §27-14-601(a) (3) (B) through §27-14-601(a) (3) (H) or the provisions of §27-14-601(a) (3) (I) (i) (a) (2) through §27-14-601(a) (3) (I) (i) (a) (4). The Director may allow the

payment of these fees"

AND

by deleting lines 10 through 14 on page 22 and substituting the following:

"the full sum specified in §27-14-1015(f) (1) to the Arkansas Development Finance Authority, and shall also pay the full sum specified in §27-14-1015(f) (2) to the county general fund of the county in which each vehicle is registered. The balance of the net proceeds received, or receivable, from credit card companies shall be prorated to the various funds for which they were collected and deposited into the State Treasury for transfer on the last business day of each month, in the same manner and to be used for the same purposes as all other fees and taxes collected upon the issuance or renewal of vehicle registrations."
