deleting "Petroleum" from line 23 on page 1, and substituting "Unknown petroleum"

AND

by deleting "all of" from line 23 on page 1

AND

by deleting "except for (c) (2)" from line 24 on page 1, and substituting "(1) and (4)"

AND

by inserting "unknown" on line 26 on page 1 between "the" and "petroleum"

AND

by deleting from line 26 on page 1 "for which fees have not been paid"

AND

by deleting from line 27 on page 1 "as required by (c) (2)"

AND

by deleting from line 28 on page 1 "for which fees have been paid" and substituting  
"meeting the requirements of § 8-7-907(c)"

AND

by deleting from line 30 on page 1 "for which fees have been paid" and substituting  
"meeting the requirements of § 8-7-907(c)"

AND

by deleting line 32 on page 1 and substituting:  
"(2) the unknown petroleum storage tank"

AND

by deleting from line 33 on page 1 "as required by (c) (2)"

AND

by inserting "unknown" on line 36 on page 1 between "of" and "petroleum"

AND

by deleting "that" from line 36 on page 1

AND

by deleting lines 1 through 3 on page 2 and substituting the following:

"will be conditioned on the payment of three hundred and seventy-five dollars (\$375.00) to the department."

AND

by deleting "Petroleum" from line 7 on page 2 and substituting "Unknown petroleum"

AND

by deleting "all of" from line 7 on page 2

AND

by deleting "except for (c) (2)" from line 8 on page 2 and substituting "(3)"

AND

by deleting line 10 on page 2 and substituting the following:

"(1) the unknown petroleum storage tank"

AND

by deleting "as required by (c) (2)" from line 11 on page 2

AND

by deleting "for which fees have been paid" from line 12 on page 2 and substituting  
"meeting the requirements of § 8-7-908(c)"

AND

by deleting "for which fees have been paid" from line 14 on page 2 and substituting  
"meeting the requirements of § 8-7-908(c)"

AND

by deleting line 16 on page 2 and substituting the following:

"(2) the unknown petroleum storage tank"

AND

by deleting "as required by (c)(2)" from line 17 on page 2

AND

by deleting lines 20 through 23 on page 2 and substituting the following:

"(3) Eligibility for reimbursement of unknown petroleum storage tanks will be conditioned on the payment of three hundred and seventy-five dollars (\$375.00) to the department."

AND

by inserting an additional section immediately following Section 3 as follows:

"SECTION 4. Arkansas Code 8-7-902 is amended by inserting an additional subsection at the end to read as follows:

"(20) Unknown petroleum storage tank means a petroleum storage tank as defined by this subchapter whose existence on a property or facility at the time of the discovery of a release was not known or should not have reasonably been known by the owner or operator.  
An owner or operator is deemed to have known of the existence of an unknown petroleum storage tank if there was surficial evidence of such tank in the form of visible vent pipes, fill caps, or lines protruding from such tank."
