There is hereby appropriated, to the Department of Finance and Administration - Disbursing Officer, to be payable from the Indigents Patient's Fund, for assistance in defraying the costs for unreimbursed expenses of the University of Arkansas for Medical Sciences for the care and treatment of Arkansas indigent patients, for the biennial period ending June 30, 2003, the following:

Delete Section 22 entitled "SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. DFA/GRANTS-INDIGENT PATIENTS DISTRIBUTION." And substitute therefor:

" SECTION 22. SPECIAL LANGUAGE. Arkansas Code 23-111-505(b) and (c) are amended to read as follows:

(b) All revenue derived from the pari-mutuel tax at the fifteen (15) additional days of racing authorized by subsection (a) of this section <u>after</u> <u>monies have been remitted by the franchise holder to Mid-South Community</u> <u>College as may be provided by law</u>, shall be deposited with the Treasurer of State as special revenue for credit to the Indigent Patients <u>Hospitalization</u> Fund, to be used: (1) <u>To to</u> defray the cost of hospitalization and medical services of indigent Arkansas patients <u>under contract with the City Hospital</u> <u>of the City of Memphis</u>, <u>Tennessee</u> <u>of the University of Arkansas for Medical</u> <u>Sciences</u>;

(2) To provide not more than twenty thousand dollars (\$20,000) per year to a private nonprofit hospital for crippled children located in Memphis, Tennessee, for providing hospitalization and medical services to indigent Arkansas children;

(3) To provide not more than two hundred thousand dollars (\$200,000) in any fiscal year, for the support of the Crittenden County Emergency Medical Services Program benefiting medical indigents in Eastern Arkansas; and

(4) To provide not more than one hundred thousand dollars (\$100,000) in any fiscal year, for the support of the Emergency Medical Services Programs of Mississippi County, Poinsett County, Cross County, St. Francis County, and Lee County.

(c) In the event the General Assembly shall appropriate moneys payable from the General Services Fund to make payments to the City Hospital of the City of Memphis, Tennessee, for hospitalization and medical services provided indigent citizens of this state, the Treasurer of State shall, upon certification of the amount paid from the State General Services Fund by the Director of the Department of Finance and Administration, transfer that amount from the Indigent Patients Hospitalization Fund to the State General Services Fund.

Delete Section 42 in its entirety and substitute:

"SECTION 42. APPROPRIATION - COSSATOT TECHNICAL COLLEGE GRANT. There is hereby appropriated, to the Department of Finance and Administration -Disbursing Officer, to be payable from the General Improvement Fund or its successor fund or fund accounts, for a grant to Cossatot Technical College for construction, renovations, improvements and various associated costs for a building located in Little River County, the sum of

SECTION 43. APPROPRIATION - DEPARTMENT OF FINANCE AND ADMINISTRATION -MANAGEMENT SERVICES. There is hereby appropriated, to the Department of Finance and Administration - Management Services, to be payable from paying accounts as determined by the Chief Fiscal Officer of the State, for personal services of the various state agencies, for each fiscal year, the sum of\$2, 100, 000, 000.

SECTION 44. APPROPRIATION - ICE STORM DAMAGE CLEANUP IN SEVIER AND HOWARD COUNTIES. There is hereby appropriated, to the Department of Finance and Administration - Disbursing Officer, to be payable from the General Improvement Fund or its successor fund or fund accounts, the following:

(A) For state support to Sevier and Howard Counties for ice storm cleanup efforts, the sum of\$50,000.

SECTION 45. APPROPRIATION - BEN LOMAND VOLUNTEER FIRE DEPARTMENT. There is hereby appropriated, to the Department of Finance and Administration - Disbursing Officer, to be payable from the General Improvement Fund or its successor fund or fund accounts, the following:

SECTION 46. APPROPRIATION - AMERICAN LEGION HUT. There is hereby appropriated to the Department of Finance and Administration - Disbursing Officer, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the American Legion Hut for the purpose of making general improvements and for remodeling of the building, the sum of\$20,000.

SECTION 48. APPROPRIATION - ANTOINE VOLUNTEER FIRE DEPARTMENT. There is hereby appropriated to the Department of Finance and Administration -Disbursing Officer, to be payable from the General Improvement Fund or its successor fund or fund accounts, to the Antoine Volunteer Fire Department in Pike County, the sum of......\$10,000.

SECTION 49. APPROPRIATION - CITY OF AUGUSTA. There is hereby appropriated to the Department of Finance and Administration - Disbursing

Officer, to be payable from the General Improvement Fund or its successor fund or fund accounts, for a grant to the City of Augusta for the following:

(B) For the Main Street Park, the sum of......\$10,000.

SECTION 51. APPROPRIATION - CITY OF LITTLE ROCK. There is hereby appropriated to the Department of Finance and Administration - Disbursing officer, to be payable from the General Improvement Fund or its successor fund or fund accounts, for a grant to the City of Little Rock for the following:

(A) For the purpose of making upgrades and repairs for drainage improvements at the Southside Park, the sum of\$100,000.

SECTION 53. Act 937 of 1999 to read as follows:

SECTION 1. APPROPRIATIONS - CLAY COUNTY PARK IMPROVEMENTS AT CHALK BLUFF. There is hereby appropriated, to the Department of Finance and Administration - Disbursing Officer, to be payable from the General Improvement Fund or its successor fund or fund accounts, the following:

SECTION 54. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. <u>FUNDING</u> <u>TRANSFER PROVISION</u>. Immediately upon the effective date of this Act the <u>Chief Fiscal Officer of the State shall transfer on his books and those of</u> the Treasurer of the State and Auditor of the State the sum of five hundred thousand dollars (\$500,000) from the Economic Development of Arkansas Fund to the State General Services Fund Account to provide funding for the appropriations authorized in Section 1 of this Act for the Arkansas State Fair and Livestock Show Association."

And appropriately renumber the subsequent sections of the bill.

Page 19, line 8, insert "<u>Provided however, that the Section which amends Act</u> 937 of 1999 shall be effective on the date of its passage and approval."
