The Arkansas Department of Higher Education shall report by May 30 to the House and Senate Interim Committees on Education the budgeted allocation for each financial aid program funded through the Higher Education Grants Fund Account for the upcoming fiscal year and projections for the following year.

SECTION 34. APPROPRIATION — ARKANSAS TEACHING FELLOWS PROGRAM. There is hereby appropriated, to the Department of Higher Education, to be payable from the Higher Education Grants Fund Account, for providing 100 scholarships in fiscal year 2001-02 and 200 scholarships in fiscal year 2002-03 for the Arkansas Teaching Fellows Program by the Department of Higher Education — Arkansas Teaching Fellows Program for the biennial period ending June 30, 2003, the following:
