Subtitle of Senate Bill No. 393

Amendment No. 1 to Senate Bill No. 393.

Amend Senate Bill No. 393 as originally introduced:

Delete Section 1 and substitute the new section:

" SECTION 1. REGULAR SALARIES. There is hereby established for the Arkansas Code Revision Commission for the 2001-2003 biennium, the following maximum number of regular employees, the grades to be assigned to the respective positions, and the maximum annual salaries for each such position. The maximum annual salary for the position assigned to grades shall be determined in accordance with, but shall not exceed the maximum annual amount for the grade assigned herein, as established in Arkansas Code 21-5-209. Except for the purpose of determining the maximum annual salary grade is assigned hereinafter, in accordance with the provisions of Arkansas Code 21-5-209, all positions set forth herein shall be exempt from other provisions of the Uniform Classification and Compensation Act, or its successor, but shall not be exempt from the provisions of the Regular Salaries Procedures and Restrictions Act, or its successor.

" SECTION 3. APPROPRIATION - OPERATIONS. There is hereby appropriated, to the Arkansas Code Revision Commission, to be payable from the State Central Services Fund, for personal services and operating expenses of the Arkansas Code Revision Commission for the biennial period ending June 30, 2003, the following:

SECTION 5. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. <u>TRANSFER</u> <u>AUTHORITY</u>. The Arkansas Code Revision Commission may transfer appropriation and funds as needed from the Budget Savings Appropriation in Section 4 to any line item in the Operations Appropriation in Section 3 of this Act.

SECTION 6. SPECIAL LANGUAGE. <u>Arkansas Code 1-2-305 is repealed.</u> 1-2-305. Arkansas Code Revision Fund.

There is established on the books of the Treasurer of State, the Auditor of State, and the Chief Fiscal Officer of the state a fund to be known as the "Arkansas Code Revision Fund" which shall consist of those moneys as provided by law. The Arkansas Code Revision Fund shall be used for the maintenance, operation, support, and improvement required by the Arkansas Code Revision Commission in carrying out the powers, functions, and duties imposed upon it as set out by this subchapter.

SECTION 7. SPECIAL LANGUAGE. <u>Arkansas Code 19-5-1079 is repealed.</u> 19-5-1079. Arkansas Code Revision Fund.

(a) There is hereby established on the books of the Treasurer of State, Auditor of State, and Chief Fiscal Officer of the State a fund to be known as the Arkansas Code Revision Fund.

(b) This fund shall consist of those moneys transferred or deposited from the State Administration of Justice Fund, there to be used for the maintenance, operation, support, and improvement required by the Arkansas Code Revision Commission in carrying out the powers, functions, and duties imposed upon them as set out in § 1-2-303. SECTION 8. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. <u>TRANSFER</u> <u>PROVISION.</u> On July 1, 2001 any remaining fund balance in the Arkansas Code <u>Revision Fund shall be transferred to the State Central Service Fund as</u> <u>direct revenue for the Arkansas Code Revision Commission.</u>

SECTION 9. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. <u>TRANSFER OF</u> <u>ALLOCATION.</u> Funds allocated for the Arkansas Code Revision Commission from the State Administration of Justice Fund shall be transferred or deposited into the State Central Services Fund as direct revenue for the Arkansas Code Revision Commission, in lieu of transfer or deposit for the Arkansas Code Revision Fund.

SECTION 10. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. <u>BUDGET</u> <u>SAVINGS TRANSFER.</u> (a) Due to savings from receiving free sets of the <u>Arkansas Code of 1987 Annotated, each Agency or Officer shall transfer or</u> <u>deposit the following funds and appropriations each fiscal year of the 2001-</u> <u>2003 biennium to the Arkansas Code Revision Commission:</u>

SECTION 11. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. <u>GENERAL</u> <u>REVENUE TRANSFER</u>. The Chief Fiscal Officer of the State and State Treasurer shall transfer the sum of three hundred sixty thousand nine hundred and twenty seven dollars (\$360,927) for the fiscal year ending June 30, 2002, and three hundred seventy five thousand four hundred and sixty four dollars (\$375,464) for the fiscal year ending June 30, 2003, from the State General Services Fund Account to the State Central Services Fund as a direct revenue for the Arkansas Code Revision Commission there to be used for such purposes as appropriated in Section 3 herein."
