## Amendment No. 3 to Senate Bill No. 478.

Amend Senate Bill No. 478 as engrossed, S2/28/01:

Page 2, line 24, delete "<u>two (2) inches square.</u>" and substitute "<u>two by four</u> inches (2" X 4") or four by two inches (4" X 2")."

AND

Page 2, delete lines 34 and 35, and substitute the following: "<u>member whose name and mailing address is provided by the superintendent of</u> <u>an affected school district upon the request of the petitioner.</u>"

AND

Page 4, line 36, delete "in" and substitute "in"

AND

Page 5, line 1, delete "existence on July 30, 1999," and substitute "existence on July 30, 1999,"

AND

Page 5, delete lines 3 through 5 and substitute the following: "(2) No <u>open-enrollment charter school shall be located in a</u> school district with an enrollment of less than five hundred (500) students <del>in existence on</del> July 30, 1999, shall be eligible for open-enrollment charter school status <u>at</u> the time that the State Board of Education initially approves the charter."

Page 6, line 36, delete "<u>compensation programs</u>," and substitute "<u>compensation</u> programs designed to enhance student and teacher performance and improve employee salaries, opportunities, and incentives,"

AND

Page 7, line 10, delete "(2)" and substitute "(2)(A)"

AND

Page 7, delete line 12 and substitute the following: "<u>at the school district;</u> (B) No limited charter school may be allowed an exemption that would allow: (i) A certified teacher with a bachelor's degree to be paid less that the base salary of a teacher with no experience and a bachelor's degree set in § 6-17-1001; or (ii) A certified teacher with a master's degree to be paid less that the base salary of a teacher with no experience and a master's degree set in § 6-17-1001;

AND

Page 7, delete line 19 and substitute the following: "(5) The petition shall be reviewed as a regular agenda item and approved after sufficient public comment by the local"

AND

Page 7, line 13, delete "(3)" and substitute "(3)(A)"

AND

Page 7, delete line 14 and substitute the following:

"<u>school will improve student learning and meet the state education goals;</u> (B) Describe how the certified employees at the charter <u>school will be involved developing and implementing the school improvement</u> <u>plan set forth in subdivision (b)(3)(A) of this section and in identifying</u> <u>performance criteria.</u>"
