Subtitle of Senate Bill No. 574

"THE DISTRIBUTION OF THE EIGHTY-THIRD SESSION PROJECTS ACCOUNT OF THE
GENERAL IMPROVEMENT FUND."

Amendment No. 1 to Senate Bill No. 574.

Amend Senate Bill No. 574 as originally introduced:

Page 2, line 4 immediately following "Fund" insert "on June 30, 2001 "

And

Page 2, line 36 delete the period and substitute "prior to any other transfer authorized from the Economic Development of Arkansas Fund on July 1, 2001;

(e) monies credited to the General Improvement Fund for the period beginning July 1, 2001 and ending December 31, 2001 from the Estate tax under the provisions of Arkansas Code 26-59-122(a);

(f) the balance of the Economic Development of Arkansas Fund on December 31, 2001;

(g) six million dollars (\$6,000,000) which the Director of the Department of Finance and Administration shall deposit into the General Improvement Fund from the fund balances of the State Employees Benefit Trust Fund of the State and Public School Employees Insurance Fund;

(h) funds which shall be deposited by the various elected constitutional officers from accounts held outside the State Treasury that are not fiduciary and are not restricted in their use by law or court order as follows:

(1) From accounts of the Commissioner of State Lands, the sum of \$2,000,000;

(2) From accounts of the Office of Attorney General, Secretary of State and Auditor of State the amount of funds as are available which conform to the criteria of this subsection on July 1, 2001 and as determined by the Division of Legislative Audit of the Legislative Joint Audit Committee."

And

Page 3, line 5 insert the following:

" (a) The Treasurer of State shall first make monthly allocations on the

basis of 50% of the total available funds to the Executive Discretionary Division as set out in subsection (c) and 50% of the total available funds to the Legislative Division listed in subsection (b) until all projects enumerated in subsection (b) have been fully funded. The Legislative Division funds shall be used to provide funds to each project enumerated in this section in proportion that each project's allocation bears to the total of the allocations of all projects enumerated in subsection (b). Additional funds that may be received by the General Improvement Fund after the projects in subsection (b) have been fully funded shall remain in the General Improvement Fund for such purpose as may be enacted by law, but shall not be a part of the 83rd Session Projects Account. Funds made available to the Executive Discretionary Division may be used for any project or portion thereof enumerated within the Executive Discretionary Division but not to exceed the amount set out in subsection (c) for the project. The Chief Fiscal Officer of the State shall notify the Legislative Council of the Governor's released funds for projects at the same time that the Department of Finance and Administration is notified.

(b) LEGISLATIVE DIVISION. The Legislative Division shall consist of the following projects and with maximum allocations as set out herein:

" SECTION 7. CONTINGENCY TRANSFER. Five million eight hundred eighty five thousand one hundred forty seven dollars (\$5,885,147) shall be transferred from the Industry and Aerospace Development Fund to the General Improvement Fund to be used as determined by the General Assembly in the event that the commitment approved by the Industry and Aerospace Commission on March 29, 2001 is declined by the prospective corporation.

SECTION 8. APPROPRIATION. There is hereby appropriated, to the Department of Higher Education, to be payable from the General Improvement Fund, for providing student scholarships through the Governor's Scholars Program by the Department of Higher Education for the biennial period ending June 30, 2003, the sum of \$2,200,000.

SECTION 9. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. ADDITIONAL TRANSFER AUTHORITY. Any transfer restrictions contained in appropriation acts for the Department of Higher Education relating to appropriation transfers from Governor's Scholars Program and Academic Challenge Scholarships shall not be applicable to transfers between Governor's Scholars and Academic Challenge Scholarship appropriations."
