Page 4, line 33, delete "<u>teachers or bus drivers</u>" and substitute "<u>teachers,</u> bus drivers, or other substitute classified employees"

Page 5, line 14, delete "<u>two thousand dollars (\$2,000)</u>" and substitute "<u>five</u> thousand dollars (\$5,000)"

Page 5, line 17, insert an additional sentence immediately following the period to read as follows:

Page 5, line 21, insert two additional sentences immediately following the period to read as follows:

"If additional data is needed for a proper determination, the director shall approve or disapprove the contract within ten (10) days of receipt of the additional requested data. If the director does not respond to the public educational entity within the ten-day period, or request additional time or data for a proper review of the contract, the contract shall be deemed to be approved by the director."

Page 5, line 31, delete "<u>Education</u>." and substitute "<u>Education or the director fails to respond to the public educational entity within the time periods specified in this section."</u>

AND

Page 7, delete lines 9 through 12 and substitute the following:

"(4) Upon review of the submitted data, the Director of the Department of Education shall, within ten (10) days of receipt of the resolution and other relevant data, approve or disapprove in writing the board's request. The director may request additional information or testimony before ruling on a request. If additional data is needed for a proper determination, the director shall approve or disapprove the contract within ten (10) days of receipt of the additional requested data. If the director does not respond to the public educational entity within the ten-day period, or request additional time or data for a proper review of the contract, the contract shall be deemed to be approved by the director."

Page 7, line 23, delete "<u>Education.</u>" and substitute "<u>Education or the director fails to respond to the public educational entity within the time periods specified in this section.</u>"
