Amendment No. 2 to Senate Bill No. 916.

Amend Senate Bill No. 916 as engrossed, S3/28/01:

Page 2, delete line 2 and substitute the following:

"at least fourteen (14) years of age. This age restriction does not apply to a person who is at least sixteen (16) years of age and:

	(A) Marri ed;
	<u>(B)</u> Possesses a high school diploma;
	(C) Has successfully completed a General Education Development
test; or	
	(C) Is in enlisted in the United States military."

AND

Page 2, delete line 8 and substitute the following;: "suspension; $\theta\tau$ "

AND

Page 2, delete line 11 and substitute the following: "license was revoked;

(C) License to operate a motor vehicle has, by court order		
or administratively, been withdrawn; or who has been found guilty of a		
serious at fault accident or serious infraction or including:		
(i) Any alcohol related moving traffic violation;		
(ii) Any seat belt violation;		
(iii) Any commercial motor vehicle violation;		
(iv) Driving fifteen (15) or more miles per hour		
over the speed limit;		
<u>(v) Reckless driving;</u>		
(vi) Negligent homicide;		
(vii) Using a vehicle to commit a felony;		
(viii) Failure to carry liability insurance;		

(ix) Leaving the scene of an accident; (x) Evading arrest; (xi) Fleeing by use of an automobile; (xii) Unsafe_driving; (xiii) Hazardous driving; (xiv) Prohibited passing; (xv) Passing stopped school bus; (xvi) Careless or negligent driving; (xvii) Failure to obey a traffic signal or device; (xviii) Failure to obey a railroad crossing barrier; (xix) Racing on a highway; (xx)Driving with a suspended, revoked or cancelled

license; or

(xxi) Driving the wrong way down a one way street."

Page 5, delete lines 3 through 7 and substitute the following: "wear seat belts at all times."

AND

Page 12, delete lines 28 through 34 and substitute the following: "shall operate the motor vehicle on the public streets and highways only when all passengers in the vehicle are wearing their seat belts."
