## Amendment No. 2 to House Bill No. 1710.

Amend House Bill No. 1710 as originally introduced:

Add Representative Flowers as a cosponsor

AND

Page 2, line 1, delete "shall" and substitute "should"

AND

Page 2, delete lines 12 through 13 and substitute: "(iv) Parents, guardians, or any person appointed by

the court."

AND

Page 2, line 21, delete "most"

AND


Page 2, line 34, delete "and"

AND

Page 2, delete lines 35 through 36 and substitute: "(B) It does not conflict with any other provision of current law, excluding the residency requirement pursuant to § 6-18-202; and (C) To the extent reasonable and practical, the school district is encouraged to work out a plan for transportation for the child to remain in the child's current school."

AND

Page 3, delete lines 10 through 11 and substitute:



"(D) Parents, guardians, or any person appointed by the

court."

AND

Page 3, line 24, delete "<u>five (5) business</u>" and substitute "<u>ten (10) school</u>"

AND

Page 3, delete lines 25 through 33 and substitute: "the child's previous school, the child's education record as defined by the Department of Education's regulation."

AND

Page 3, line 36, delete "five (5) business" and substitute "ten (10) school"

AND

Page 4, delete lines 24 through 25 and substitute:
 "(3) The child's attendance at court-ordered counseling or
treatment."

AND

Page 4, delete lines 26 through 35 and substitute:
 "(g) Each school district shall accept credit coursework when the
 student demonstrates that he or she has satisfactorily completed the
 appropriate education placement assessment."

AND

Page 5, line 1, delete "<u>detained</u>," and substitute "<u>detained in a juvenile</u> <u>detention facility or committed to the Division of Youth Services of the</u> <u>Department of Human Services</u>,"

AND

Page 5, line 2, delete "detention" and substitute "detention or commitment"

AND

Page 5, delete lines 3 through 5

AND

Page 5, line 6, delete "(j)" and substitute "(i)"

AND

Page 5, delete line 8 entirely, and substitute the following: "seq., and regulations promulgated thereunder.

(j) Notwithstanding any of the provisions of this section, if it is in the best interest of the child, a foster child may be placed in a nonpublic school, including a private, parochial, or home school as long as no state or federal funding is used for such placement."

AND

If appropriate, renumber the remaining sections of the bill
