Amendment No. 1 to House Bill No. 2766.

AND


Page 2, line 16, delete "(5)" and substitute "(6)"

AND

Page 3, delete line 14 and substitute the following: "check information.

(c) If the volunteer organization desires to receive criminal background check information from the Federal Bureau of Investigation, the volunteer organization shall include a copy of the minutes from its most recent board meeting that lists offenses that the organization considers to disqualify an applicant from serving as a volunteer with the agency."

Page 5, line 1, delete "the application for a criminal background check" and substitute "its registration to obtain criminal background check information on volunteers"

Page 5, line 3, delete "agency" and substitute "organization"

AND

Page 5, line 27, delete "Federal" and substitute "System"

Page 5, delete line 31, and substitute the following:

"history system and the automated fingerprint identification system.

- 12-12-1610. Extent of disclosure.
- (a) The Department of Arkansas State Police and the Arkansas Crime
 Information Center shall disseminate criminal history information to the
 extent entries have been made at the time of the request for the information.
- (b) Any event, activity, or any portion of the criminal history information which has not been processed by the department or the center shall not be required to be included in the dissemination.
- (c) Requests for information, supporting documents, and any responses to a request for criminal background check information under this subchapter shall not be subject to disclosure under the Freedom of Information Act of 1967, § 25-19-101 et seq."
