Amendment No. 1 to Senate Bill No. 152.

Amend Senate Bill No. 152 as originally introduced:


Add the following two new sections immediately after SECTION 10 of the bill to read as follows:

SECTION 11. REGULAR SALARIES - NORTHWEST ARKANSAS CONFLICT OFFICE. There is hereby established for the Arkansas Public Defender Commission -Northwest Arkansas Conflict Office for the 2005-2007 biennium, the following maximum number of regular employees whose salaries shall be governed by the provisions of the Uniform Classification and Compensation Act (Arkansas Code 21-5-201) or its successor, and all laws amendatory thereto. Provided, however, that any position to which a specific maximum annual salary is set out herein in dollars, shall be exempt from the provisions of said Uniform Classification and Compensation Act. All persons occupying positions authorized herein are hereby governed by the provisions of the Regular Salaries Procedures and Restrictions Act (Arkansas Code 21-5-101), or its successor.
