Page 2, line 13, delete "SECTION 3." and substitute "SECTION 1."
AND
Page 2, delete lines 21 through 36 and substitute:
"(b) In school year 2004-2005 and 2005-2006, each school district in the state shall have in place a salary schedule with at least the following minimum levels of compensation for a basic contract:
