Subtitle of Senate Bill No. 593

"ARKANSAS PUBLIC SCHOOL ACADEMIC FACILITIES PROGRAM ACT."

Amendment No. 1 to Senate Bill No. 593.

Amend Senate Bill No. 593 as originally introduced:

Page 2, line 36, delete "defined" and substitute "described"

AND

Page 6, delete line 11 and substitute the following:

"Transportation shall promulgate rules necessary to administer the Arkansas Public School Academic Facilities Program, all its component and related programs, and the provisions of this"

AND

Page 14, line 36 delete "defined" and substitute "described"

AND

Page 16, delete line 30 and substitute the following:

"(d) When a school district is identified by the division to be in facilities distress, the"

AND

Page 17, delete lines 6 through 10 and substitute the following:

"(3)(A) Appoint an individual in place of the superintendent to administratively operate the school district under the supervision and approval of the Director of the Division of Public School Academic Facilities and Transportation.

(B) The division may direct the school district to compensate from school district funds the individual appointed to operate the school district;"

AND

Page 17, line 24, delete "defined" and substitute "described"



AND

Page 17, line 31, delete "defined" and substitute "described"

AND

Page 20, line 34, delete "Arkansas State Building Services" and substitute "Arkansas ~~State~~ Building ~~Services~~ Authority"

AND

Page 21, delete lines 14 and 15 and substitute the following:
"plan finally approved by the ~~State Board of Education~~ Commission for Public School Academic Facilities and Transportation for all projects where the ~~board~~ commission requires its approval thereof."

AND

Page 21, line 20, delete "Arkansas State Building Services" and substitute "Arkansas ~~State~~ Building ~~Services~~ Authority"

AND

Page 21, line 26, delete "Arkansas State Building Services" and substitute "Arkansas ~~State~~ Building ~~Services~~ Authority"

AND

Page 21, line 32, insert a new section to read as follows:

"SECTION 5. Arkansas Code 6-41-212 is amended to read as follows:
6-41-212. Facilities.

(a) Physical aspects and specifications for buildings, classrooms, and other facilities for, or likely to be used by, children with disabilities shall be approved by a ~~designee of the State Board of Education~~ the Division of Public School Academic Facilities and Transportation or a designee.

(b) A The division or a designee of the ~~board~~ division is required to review plans for public school construction or remodeling which are designed for children with disabilities to ensure accessibility and usefulness for that purpose."

AND

Renumber all subsequent sections of the bill
