
Page 1, line 32, delete "college or university" and substitute "institution of higher education"

AND

Page 2, line 14, delete "bookstore's"

AND

Page 2, delete lines 18 and 19 and substitute the following:



"(c)(1) As used in this section, "bundled package" means any combination of one (1) or more reusable textbooks and one (1) or more nonreusable textbooks, workbooks, CD-ROMs, floppy disks, passwords,"

AND

Page 2, delete lines 20 through 26, and substitute "<u>interactive hand-held</u> remote devices, flash drives, or any other memory-storing device as a package for sale."

AND

Page 2, line 27, delete "<u>college or university</u>" and substitute "<u>institution</u> <u>of higher education</u>"

AND

Page 2, delete line 28, and substitute the following: "<u>select or use for instruction a bundled package if:</u> (A) Any component of the package is not offered for sale individually; and (B) The cost of purchasing the items packaged together as one (1) purchase equals or exceeds the cost of purchasing the items individually."

Page 3, delete lines 1 through 7 and substitute the following: "state-supported institution of higher education to the:
