Amendment No. 1 to Senate Bill No. 223.

Amend Senate Bill No. 223 as originally introduced:

Page 2, line 16, delete "6" and substitute "8"

AND

Page 3, line 22, delete "299" and substitute "303"

AND

Page 4, line 6, delete "\$ 12,543,421 \$ 12,794,289" and substitute

AND

Page 4, line 8, delete "3,833,298 3,884,658" and substitute
"3,990,060 4,044,462"

AND

Page 4, line 17, delete "\$ 20,567,246 \$ 20,869,474" and substitute
"\$ 21,258,211 \$ 21,576,581"

AND

Delete SECTION 4 of the bill in its entirety and substitute the following:
" SECTION 4. APPROPRIATION - GRANTS. There is hereby appropriated, to the Department of Health and Human Services - Division of Medical Services, to be payable from the paying account as determined by the Chief Fiscal Officer of the State, for grant payments of the Department of Health and Human Services - Division of Medical Services - Grants for the biennial period ending June
