
Amendment No. 4 to Senate Bill No. 283.

Insert new sections immediately following SECTION 57 to read as follows:

"SECTION 58. The Act introduced as HB1281 of 2007 is amended as follows: SECTION 4. REGULAR SALARIES - LAND SURVEY DIVISION. There is hereby established for the Land Department for the 2007-2009 biennium, the following maximum number of regular employees whose salaries shall be governed by the provisions of the Uniform Classification and Compensation Act (Arkansas Code \$\$21-5-201 et seq.), or its successor, and all laws amendatory thereto. Provided, however, that any position to which a specific maximum annual salary is set out herein in dollars, shall be exempt from the provisions of said Uniform Classification and Compensation Act. All persons occupying positions authorized herein are hereby governed by the provisions of the Regular Salaries Procedures and Restrictions Act (Arkansas Code §21-5-101), or its successor.
