Subtitle of Senate Bill No. 195

AN ACT FOR THE AUDITOR OF STATE - OPERATIONS AND UNCLAIMED PROPERTY
PROGRAM APPROPRIATION FOR THE 2011-2012 FISCAL YEAR.

Amendment No. 1 to Senate Bill No. 195

Amend Senate Bill No. 195 as originally introduced:

Page 2, line 32, delete "534,187" and insert "605,607"

And

Page 2, line 35, delete "25,000" and insert "178,100"

And

Page 3, line 1, delete "\$2,663,140" and insert "\$2,887,660"

And

Page 3, line 31, delete "431,146" and insert "475,146"

And

Page 3, line 34, delete "25,000" and insert "198,000"

And

Page 3, line 36, delete "\$1,156,122" and insert "\$1,373,122"

And

Page 5, insert new sections immediately following Section 8 to read as follows:

" SECTION 9. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL OR TEMPORARY LAW. FUND TRANSFER. Immediately upon the effective date of this Act, and notwithstanding the provisions of A.C.A. 18-28-213 (c)(2) regarding the transfer of funds from the Unclaimed Property Proceeds Trust Fund to the general revenues of the state, the Auditor of State shall transfer on his or



her books and those of the State Treasurer and the Chief Fiscal Officer of State the sum of \$441,520 from the Unclaimed Property Proceeds Trust Fund to the State Central Services Fund for appropriations authorized in this Act for maintenance and general operations expenses regarding purchase and maintenance of software.

SECTION 10. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL OR TEMPORARY LAW. TRANSFER PROVISION. After receiving approval from the Chief Fiscal Officer of the State, and prior review by the Arkansas Legislative Council, the Auditor of State is authorized to transfer appropriation from any line item authorized in Section 3 Operations to any other line item authorized in Section 3 and the Agency is authorized to transfer appropriation from any line item authorized in Section 5 Unclaimed Property to any other line item authorized in Section 5.

The provisions of this section shall be in effect only from July 1, 2011 through June 30, 2012.”

And

Appropriately renumber subsequent Sections of the bill.
